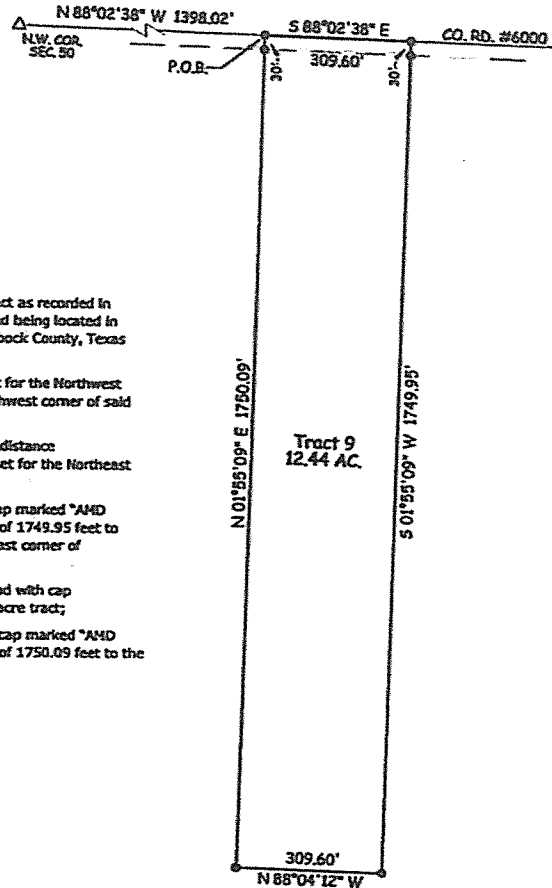

**LEGAL DESCRIPTION**

**FIELD NOTES** of a 12.44 acre tract of land being out of a 149.93 acre tract as recorded in C.C.F.N. 2012-27729, Official Public Records of Lubbock County, Texas and being located in Section 50, Block A, Abstract No. 1502, H.E. & W.T. R.R. Co. Survey, Lubbock County, Texas and being more particularly described by metes and bounds as follows:

**BEGINNING** at a 1/2" iron rod with cap marked "AMD ENGINEERING", set for the Northwest corner of this 12.44 acre tract, whence a railroad spike found for the Northwest corner of said Section 50 bears North 88°02'38" West, a distance of 1398.02 feet;

**THENCE** South 88°02'38" East, along the North line of said Section 50, a distance of 309.60 feet to a 1/2" iron rod with cap marked "AMD ENGINEERING", set for the Northeast corner of this 12.44 acre tract;

**THENCE** South 01°55'09" West, at 30.00 feet pass a 1/2" iron rod with cap marked "AMD ENGINEERING", set for a reference corner, continuing for a total distance of 1749.95 feet to a 1/2" iron rod with cap marked "AMD ENGINEERING", set for the Southeast corner of this 12.44 acre tract;

**THENCE** North 88°04'12" West, a distance of 309.60 feet to a 1/2" iron rod with cap marked "AMD ENGINEERING", set for the Southwest corner of this 12.44 acre tract;

**THENCE** North 01°55'09" East, at 1720.09 feet pass a 1/2" iron rod with cap marked "AMD ENGINEERING", set for a reference corner, continuing for a total distance of 1750.09 feet to the point of beginning.

## AMD Engineering and Surveying

### LEGAL DESCRIPTION

**FIELD NOTES** of a 149.93 acre tract of land being out of Section 50, Block A, Abstract No. 1502, H.E. & W.T. R.R. Co. Survey, Lubbock County, Texas and being more particularly described by metes and bounds as follows:

**BEGINNING** at a 1/2" iron rod with cap marked "AMD ENGINEERING", set for the Northeast corner of the Northwest Quarter of said Section 50 and being the Northeast corner of this 149.93 acre tract, said corner having a NAD83, State Plane Coordinate, Texas North Central Zone of N: 7,309,474.87 E: 977,415.31, whence a 1-1/4" iron pipe found for the Northeast corner of said Section 50 bears South 88°02'38" East, a distance of 2636.50 feet;

**THENCE** South 01°54'47" West, at 30.00 feet pass a 1/2" iron rod with cap marked "AMD ENGINEERING", set for a reference corner, continuing for a total distance of 2641.55 feet to a 1" iron pipe, found for the center of this section and the Southeast corner of this 149.93 acre tract;

**THENCE** North 88°04'12" West, at 1410.09 feet pass a 1/2" iron rod found for the Northeast corner of a tract of land as described in General Warranty Deed, C.C.F.N. 2006-10017, at 2606.78 feet pass a 1/2" iron rod with cap marked "AMD ENGINEERING", set for a reference corner, continuing for a total distance of 2636.78 feet to a railroad spike found for the Northwest corner of said tract described in C.C.F.N. 2006-10017 and being the Southwest corner of this 149.93 acre tract;

**THENCE** North 01°55'09" East, along the West line of said Section 50, a distance of 1828.60 feet to a railroad spike found for the Southwest corner of a 10 acre tract as described by Warranty Deed in Volume 2000, Page 142, Real Property Records of Lubbock County, Texas and being a corner of this 149.93 acre tract;

**THENCE** South 88°02'38" East, along the South line of said 10 acre tract, at 30.00 feet pass a 1/2" iron rod with cap marked "AMD ENGINEERING", set for a reference corner, continuing for a total distance of 535.06 feet to a 1/2" iron rod with cap marked "AMD ENGINEERING", set for the Southeast corner of said 10 acre tract and being a corner of this 149.93 acre tract;

**THENCE** North 01°55'09" East, along the East line of said 10 acre tract, at 784.14 feet pass a 1/2" iron rod, found for a reference corner, continuing for a total distance of 814.14 feet to a 1/2" iron rod, found for the Northeast corner of said 10 acre tract and being the Northwest corner of this 149.93 acre tract;


**THENCE** South 88°02'38" East, along the North line of said Section 50, a distance of 2101.43 feet to the point of beginning.

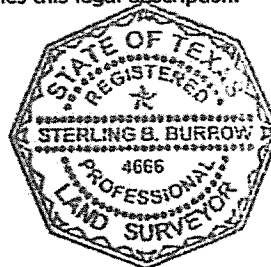
Bearings were determined by GPS observations, NAD83 (2011), Texas North Central Zone, U.S. Survey Feet.
