The farm is located on the southeast edge of town, at the intersection of paved roads Highway 5 and 165th Place. The farm offers multiple unique opportunities that would make it a solid addition to a local farm operation or a great candidate for an investor looking to diversify their portfolio.

The farm consists of 131.55 acres m/l, with an estimated 96.46 FSA tillable acres. An estimated 81.54 acres are currently in row crop production, carrying a CSR2 value of 78.3. Primary soil types on this tract include highly productive Bremer and Nevin silty clay loams, with slopes ranging from 0-2 percent. There are an additional 9.41 acres in CRP (Conservation Reserve Program) paying \$2,949.00 annually (\$313.35/acre) through 2027. The farm is located within proximity to Heartland Co-Op, just a few miles north of the farm in Avon.

Under the current farm bill, this farm qualifies for the implementation of the Wetland Reserve Program (WRP). This perk offers a great opportunity for a new owner who would want to pursue putting the farm into a conservation program that would provide habitat for wildlife, decrease flood damages, improve water quality, and help the recovery of endangered and threatened species of wildlife. In addition to the farming opportunities offered by this tract, the farm is an excellent recreational and hunting farm, being located in an area that holds a large population of whitetail, turkey, geese, ducks, and pheasants.
