The Banner County parcel a rolling hill farm that sits adjacent to County Road 6 on the north side of the property with the south side of the property directly adjacent northern Banner County line. The Kimball County portion consists of 631.23± acres, which consists of 560.14± acres of Certified Organic Farm ground and 71.09± of grass. The farm ground on this portion has been summer fallowed and is ready to be planted in the spring of 2024. There is no tenant farm lease on this portion. Kimball County parcel sits on a well-traveled county road, CR 54N, on the south side of the property with the Kimball/Banner County line on the north. These two portions of farm ground are within a mile of each other. Both of these portions of the property do have a lease contract with Invenergy Wind Turbine.
