PROPERTY OVERVIEW

This 17-acre site, comprising roughly 15.5 acres of uplands, boasts hard road frontage on three sides and is situated in an area with upscale lakefront homes. Located just outside Downtown Frostproof, this parcel is strategically located on a main thoroughfare connecting US 27 to Hwy 60, leading to Vero Beach.

Additionally, the site is close to Lake Reedy, with a distance of approximately 160 feet at a few points. This adjacency to Lake Reedy enhances its appeal, presenting significant development and recreational potential. The combination of scenic surroundings, accessibility, and proximity to the lake makes this property a promising prospect for various land use opportunities, from residential development to recreational ventures.

Lake Reedy in Frostproof, Florida, has an approximate surface area of around 3,488 acres. The lake is known for its irregular shape, offering various coves and inlets that add to its scenic beauty. In terms of depth, Lake Reedy reaches an average depth of approximately 12 feet, with some areas reaching down to 19 feet. The lake is popular among anglers for its diverse fish population, including species like largemouth bass, bluegill, and crappie. Lake Reedy has one main public boat ramp which is less than 1300 feet from the subject property.


Wetlands Map


