CERTIFICATE OF WATER RIGHT

This Is to Certify, ThatROBERT & ROSE RILEY AND
ROBERT & KATHLEEN MOFFITT

of 1863 Whistlers Lane, Roseburg, State of Oregon, 97470, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of North Umpqua River and reservoir constructed under Permit No. R-6182

a tributary of Umpqua River for the purpose of
irrigation of 15.5 acres and fish culture

under Permit No. 38282 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 15, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.20 cubic foot per second, being 0.19 c.f.s. for irrigation from River and 0.01 c.f.s. for fish culture from River and reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 5 (NW $\frac{1}{4}$ NW $\frac{1}{4}$), & SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 15, T. 26 S., R. 4 W., W. M., River-870 feet North and 350 feet West; Reservoir-260 feet South and 200 feet West, both from the NE Corner, SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 15

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Fish Culture & 15.5 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$
Section 15
T. 26 S., R. 4 W., W. M.

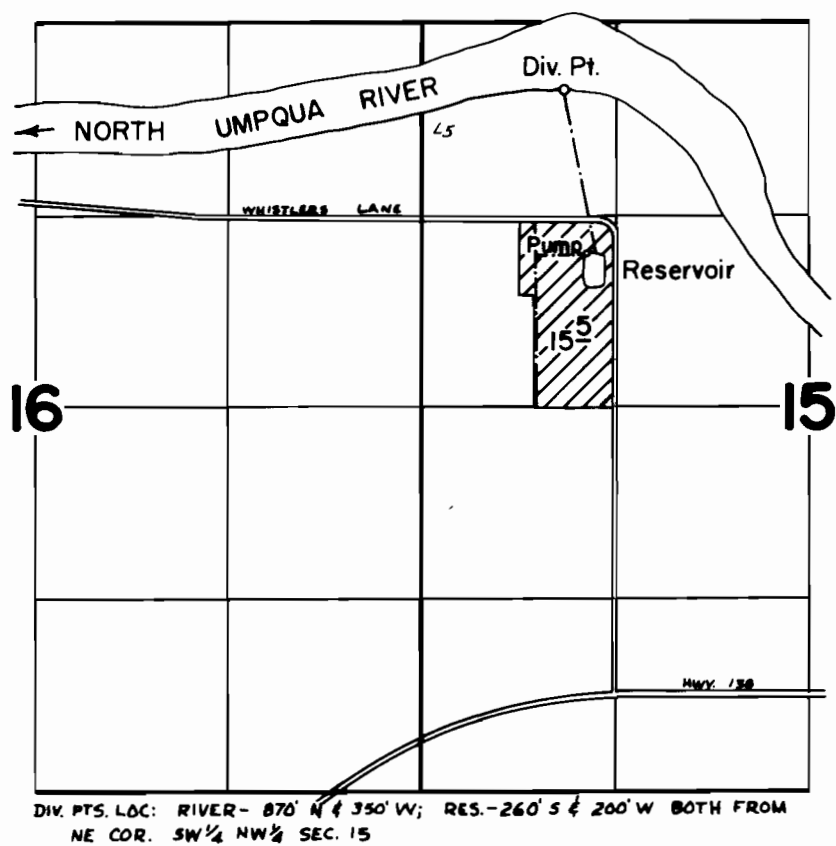
