


### **AUCTION NOTE**

Notable class II soils on the property include Svea-Wyard loams and Barnes-Svea loams. These soils are suitable for growing a variety of crops such as corn, soybeans, and a variety of other small grains. The land has excellent access from ND Hwy. #13 and 91st Ave. SE. The majority of the non-crop land on the property is currently enrolled in the Conservation Reserve Program (CRP). 

### TERMS & CONDITIONS

#### I. Terms and Conditions of Auction

All bidding is open to the public without regard to a prospective bidder's sex, race, color, religion, or national origin.

#### **II. Bidding Procedures**

All bidding is open to the public. You need only to raise your hand and shout out your bid, or instruct any of the ring men to do so on your behalf. Anyone who wishes to bid must first register to obtain a bidder's card at the registration desk.

Retain your bidder number for the duration of the auction. You are responsible for your assigned number. The property is sold when the Auctioneer announces, "sold," identifies the winning bid number and the amount of the bid and the information is recorded by the Auctioneer or his designee. In case of a tie bid, bidding will be reopened between the two tied bidders. The high bid cannot be withdrawn once the Auctioneer determines it to be the winning sale bid.

#### III. Purchase Agreement, Marketability, Signing Area

At the time the auction is complete, the successful high bidder must sign a standard Real Estate Purchase Agreement to purchase this property for which it was the high bidder. An appointment date to close the transaction will be furnished to the Purchaser after the Purchase Agreement is signed.
