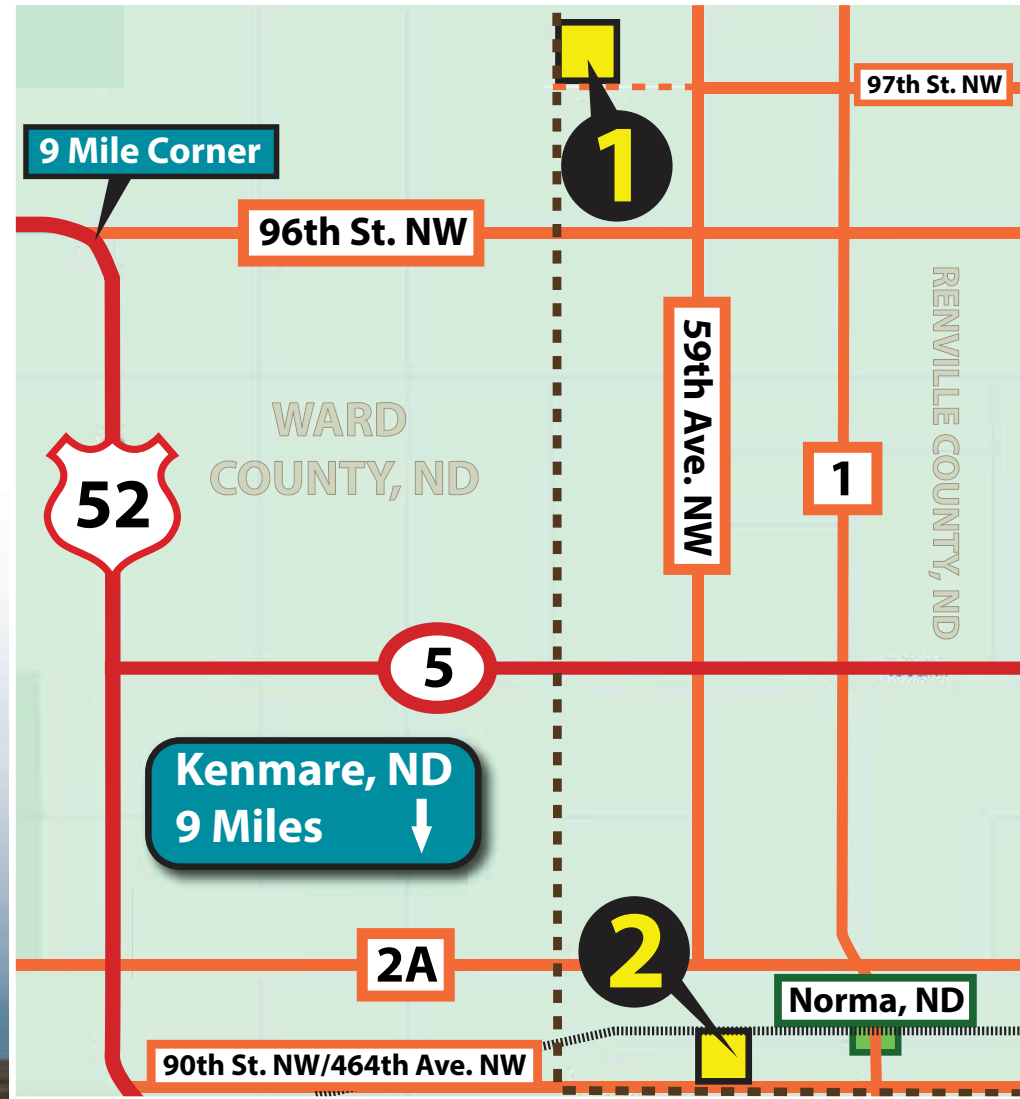
AUCTION NOTE

DRIVING DIRECTIONS

Parcel 1: From Kenmare, ND go north 9 miles on Hwy. #52 to 96th St. NW (Nine Mile Corner) and go east 4 miles to 59th Ave. NW. Go one mile north on 59th Ave. NW. Go west one mile on the section line and this will bring you to the southwest corner of parcel 1.

Parcel 2: From Norma, ND (NE of Kenmare, ND) go south 0.5 miles on County Rd. #1 and then go west 0.75 miles on 90th St. NW/464th Ave. NW. This will bring you to the southeast corner of parcel 2.



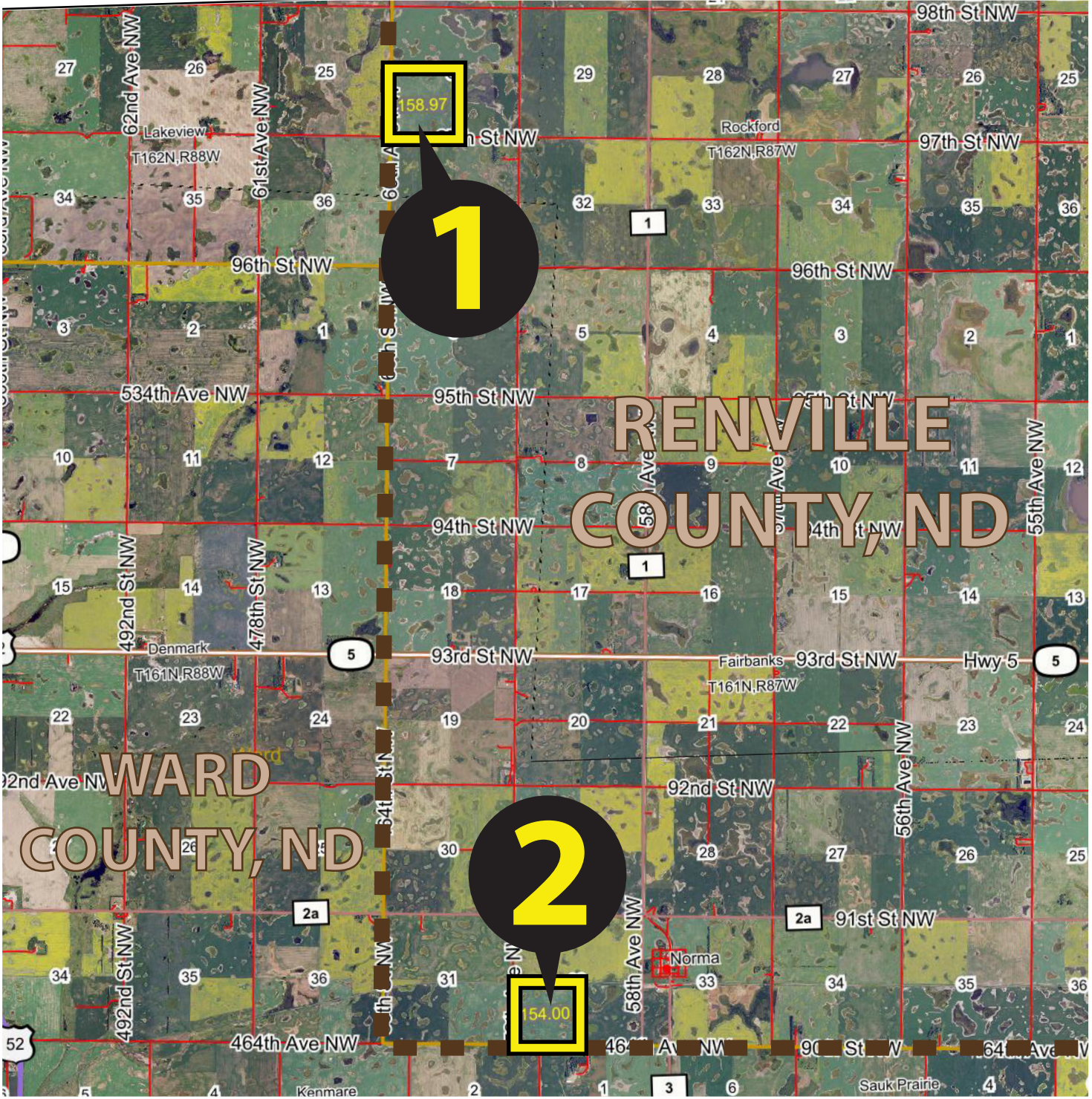

TERMS & CONDITIONS

I. Terms and Conditions of Auction

The property is sold when the Auctioneer announces, "sold," identifies the winning bid number and the amount of the bid and the information is recorded by the Auctioneer or his designee. In case of a tie bid, bidding will be reopened between the two tied bidders. The high bid cannot be withdrawn once the Auctioneer determines it to be the winning sale bid.
