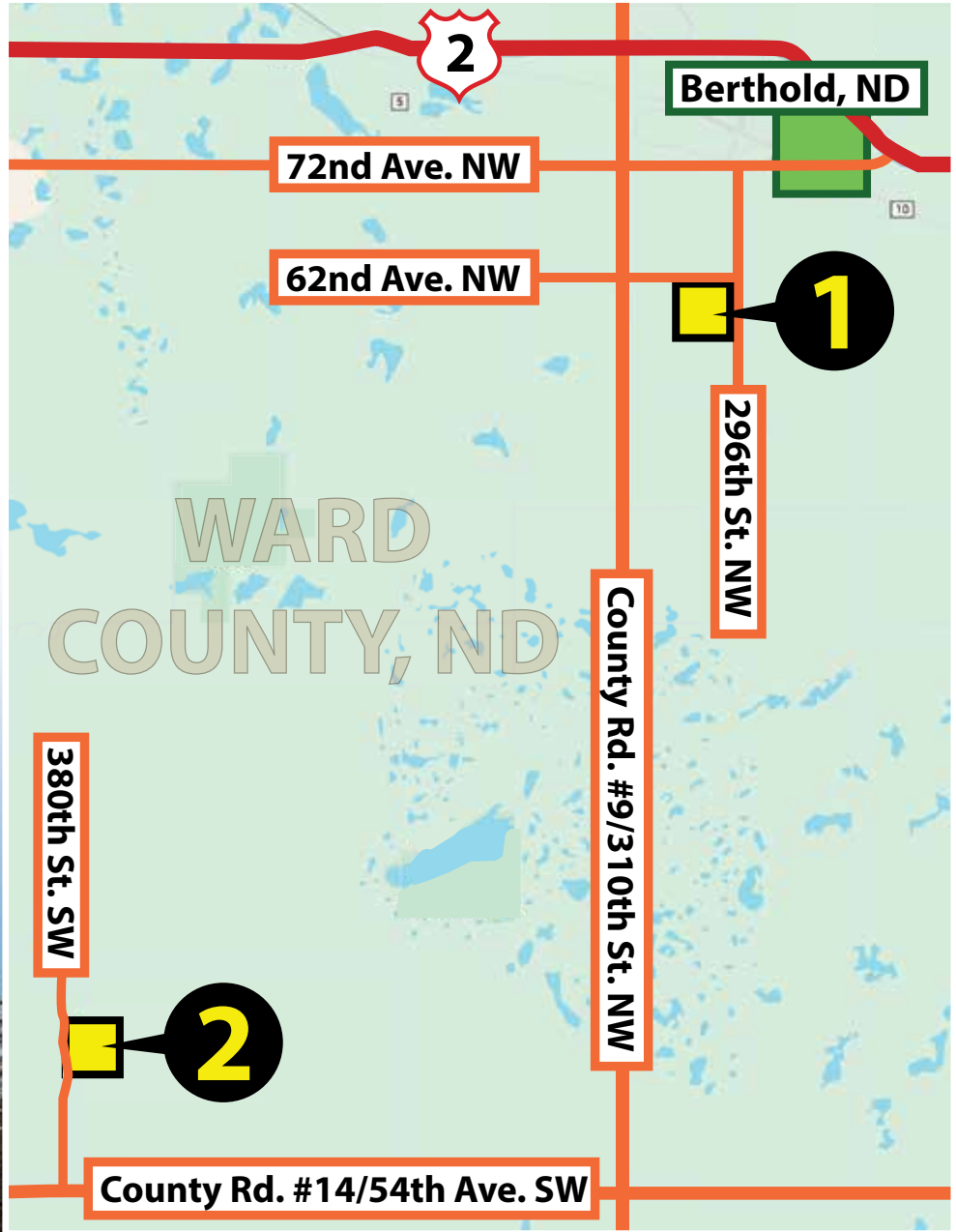
AUCTION NOTE

DRIVING DIRECTIONS

Parcel 1: At the intersection of 72nd Ave. NW & 296th St. NW west of Berthold, ND, go south 1 mile on 296th St. NW. This will bring you to the northeast corner of parcel 1.

Parcel 2: At the intersection of US Hwy. #2 and County Rd. #9/310th St. NW west of Berthold, ND, go 10 miles south on County Rd. #9/310th St. NW to County Rd. #14/54th Ave. SW. Go five miles west to 380th St. SW and then 1 mile north on 380th St. SW. This will bring you to the southwest corner of parcel 2.



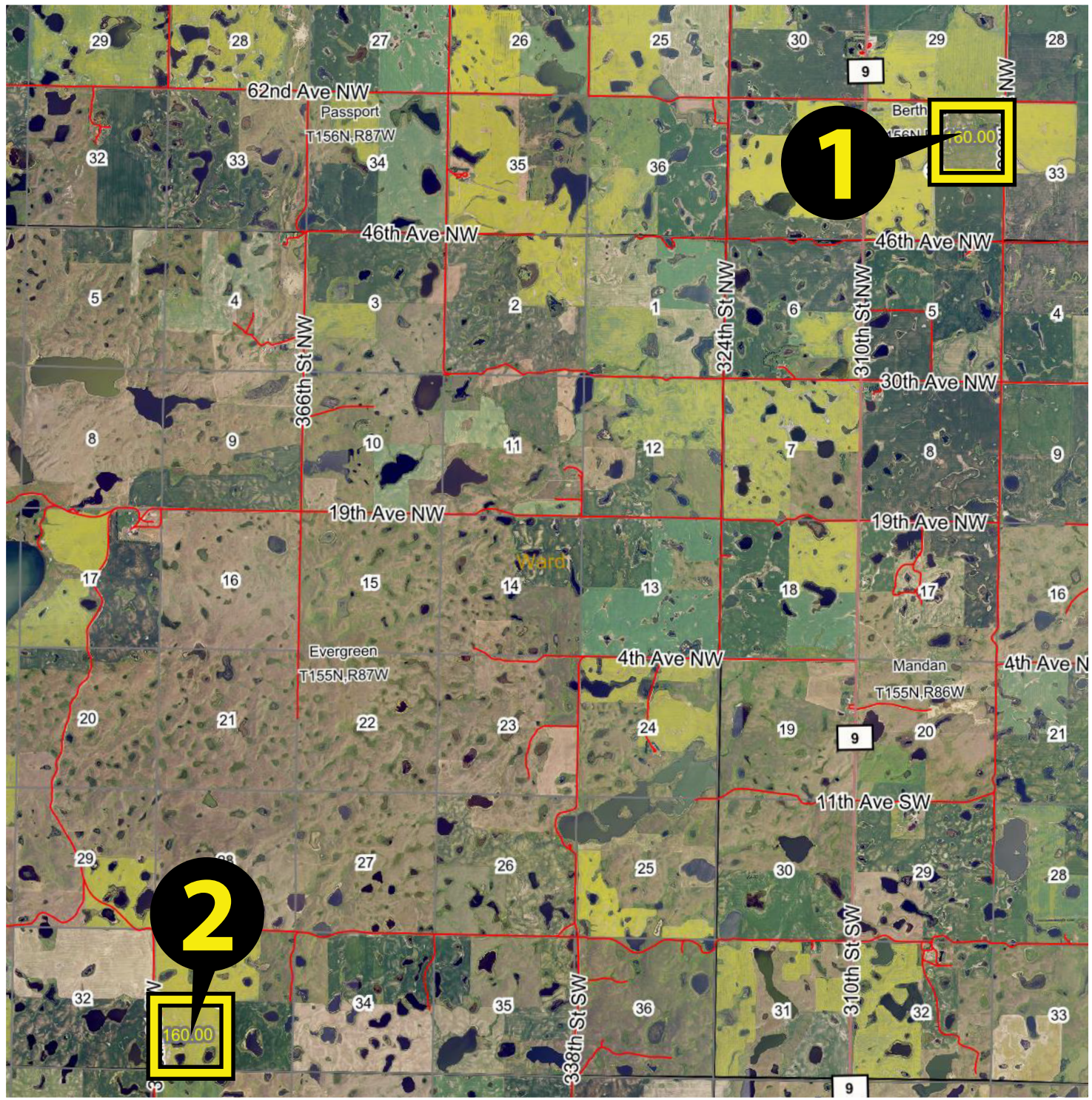

TERMS & CONDITIONS

I. Terms and Conditions of Auction

All bidding is open to the public without regard to a prospective bidder's sex, race, color, religion, or national origin.

A. Retain your bidder number for the duration of the auction. You are responsible for your assigned number. The property is sold when the Auctioneer announces, "sold," identifies the winning bid number and the amount of the bid and the information is recorded by the Auctioneer or his designee. In case of a tie bid, bidding will be reopened between the two tied bidders. The high bid cannot be withdrawn once the Auctioneer determines it to be the winning sale bid.

III. Purchase Agreement, Marketability, Signing Area

At the time the auction is complete, the successful high bidder must sign a standard Real Estate Purchase Agreement to purchase this property for which it was the high bidder.
