

- NARRATIVE -

THIS SURVEY WAS MADE IN APRIL THROUGH JULY, 2017 BY DANIEL W. BAKER OF BAKER AND ASSOCIATES SURVEYORS, INC. FOR HEIDI N. SAUSE TRUST U/T/A/ DATED 5/10/15 (50%) AND PHILLIP DAVIDSON (50%) IN THE NORTHEAST 1/4 AND SOUTHEAST 1/4 OF SECTION 22 AND THE NORTHWEST 1/4 AND SOUTHWEST 1/4 OF SECTION 23, TOWNSHIP 17 SOUTH, RANGE 6 WEST, WILLAMETTE MERIDIAN PER DOCUMENTS NUMBER 2005-095036 AND REEL 2298R, INSTRUMENT NUMBER 9735449, LANE COUNTY, OREGON OFFICIAL RECORDS. THE BASIS OF BEARING FOR THIS SURVEY WAS THE EAST LINE OF THE WILLIAM JOHNSON DONATION LAND CLAIM NO. 43 PER COUNTY SURVEY FILE 43074. CLOSED TRAVERSES WERE RUN BETWEEN FOUND CORNERS FOR CONTROL, WITH A MINIMUM ERROR OF CLOSURE OF GREATER THAN 1' IN 20,000', BEFORE ANGULAR ADJUSTMENT. ALL CONTROLLING CORNERS FOR THE SUBDIVISION OF SECTIONS 22 AND 23 WERE FOUND AND WERE PERPETUATED ORIGINAL CORNERS, WITH THE EXCEPTION THE 1/4 CORNER COMMON TO SECTIONS 22 AND 23 AND THE NORTHWEST CORNER OF DONATION LAND CLAIM NO. 43. THE 1/4 CORNER COMMON TO SECTIONS 22 AND 23 WAS RE-ESTABLISHED AT MIDPOINT BETWEEN THE SOUTHWEST AND NORTHWEST SECTION CORNERS OF SECTION 23
AND ON A LINE BETWEEN THE NORTHWEST SECTION CORNER AND THE FOUND SOUTHWEST CORNER OF DONATION LAND CLAIM NO. 43. PER THE
NOTES OF DONATION LAND CLAIM NO. 43, THE SURVEYOR PLACED THE SOUTHWEST AND NORTHWEST CORNERS OF DONATION LAND CLAIM NO. 43 ON
THE SECTION LINE COMMON TO SECTIONS 22 AND 23, THEREFORE, IT IS MY OPINION AND ALSO THE DONATION DO THE BUREAU OF LAND AND THE CADASTRAL SECTION. THE NORTHWEST CORNER OF DONATION LAND CLAIM NO. 43 WAS RE-ESTABLISHED BY BROKEN BOUNDARY METHOD PER THE 2009 BUREAU OF LAND MANAGEMENT "MANUAL OF SURVEYING INSTRUCTIONS" AND WAS SET ON THE SECTION LINE COMMON TO SECTIONS 22 AND 23 SECTIONS 22 AND 23 WERE THEN SUBDIVIDED PER THE 2009 BUREAU OF LAND MANAGEMENT "MANUAL OF SURVEYING INSTRUCTIONS". THE MOST WESTERLY LINE OF THE SUBJECT PROPERTY WAS MARKED 20 FEET EAST OF AN EXISTING ROADWAY PER BOOK 172, PAGE 470, LANE COUNTY, OREGON DEED RECORDS AND SURVEY IN COUNTY SURVEY FILE NO. 38614. THIS LINE WAS TO TERMINATE AT THE EAST—WEST CENTERLINE OF THE NORTHEAST 1/4 PER A WARRANTY DEED RECORDED ON 2247R, INSTRUMENT NO. 9684678, LANE COUNTY, OREGON OFFICIAL RECORDS AND THIS MATCHES THE DESCRIPTION IN DOCUMENT NO. 2013-019378 (TAX LOT 900). THE PROPERTY LINE THEN FOLLOWS THE NORTH LINE OF THE SOUTHEAST 1/4 OF THE NORTHEAST 1/4 OF SECTION 22 TO THE SECTION LINE COMMON TO SECTIONS 22 AND 23 TO THE NORTH 1/16 CORNER COMMON TO SECTIONS 22 AND 23. THEN NORTHERLY ALONG THE SECTION LINE TO NEWLY ESTABLISHED NORTHWEST CORNER OF DONATION LAND CLAIM NO. 43 AND TO THE SECTION CORNER COMMON TO SECTIONS 15, 16, 22 AND 23. THEN WE MARKED THE SECTION LINE COMMON TO SECTIONS 16 AND 23 TO THE WEST 1/4 CORNER, WHICH WAS ESTABLISHED AT MIDPOINT BETWEEN THE SECTION CORNER AND THE 1/4 CORNER COMMON YO SECTIONS 16 AND 23. WE THEN MARKED THE LINE ALONG THE EAST LINE OF GOVERNMENT LOT 1 TO THE SOUTHEAST CORNER OF SAID GOVERNMENT LOT 1. THEN WE MARKED THE LINE FROM THE SOUTHEAST CORNER OF GOVERNMENT LOT 1. TO THE NORTHEAST CORNER OF THE PROPERTY DESCRIBED IN A DEED RECORDED MAY 18, 1973, RECEPTION NO. 73—22484, LANE COUNTY, OREGON OFFICIAL RECORDS. WE FLAGGED THE SOUTH LINE OF THE SUBJECT PROPERTY BUT DID NOT SET ANY CORNERS ALONG THIS LINE OR AT THE SOUTHEAST OR SOUTHWEST CORNER BECAUSE THE LINE IS APPROXIMATELY 6 FEET ON THE SOUTH SIDE OF THE EXISTING FENCE AND THERE IS NO MERCHANTABLE TIMBER ON THE SOUTH SIDE OF THE FENCE. CORNERS SET IN THIS SURVEY WERE MONUMENTED WITH 5/8" X 36" REBAR WITH A 2 1/2" ALUMINUM CAP, MARKED AS SHOWN. THE TRUE PROPERTY LINE WAS MARKED BY BLAZING TREES ON EITHER SIDE OF THE TRUE PROPERTY LINE (BLAZES PAINTED ORANGE) AND BY SETTING 5 1/2' METAL FENCE POSTS AT RANDOM INTERVALS ALONG THE TRUE PROPERTY LINE, AS SHOWN ON THE SURVEY.






