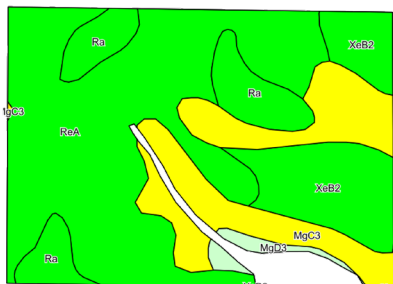

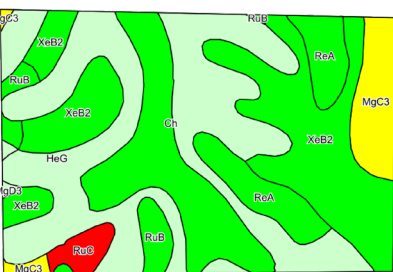

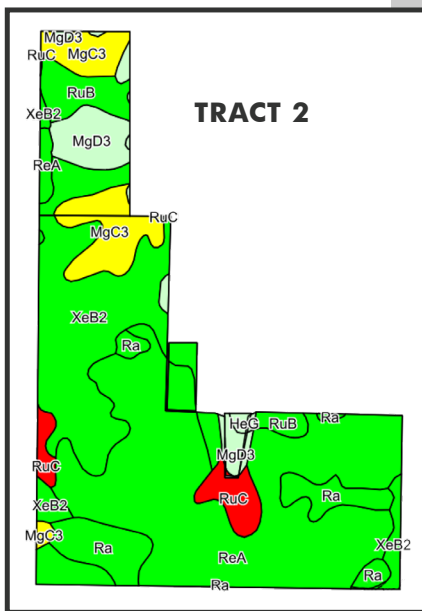

Terms and Conditions

PLEASE READ AND REVIEW THE REAL ESTATE TERMS THOROUGHLY PRIOR TO BIDDING ON ANY PROPERTY. IF YOU HAVE NOT READ AND UNDERSTAND THESE TERMS, DO NOT BID. BY BIDDING ON THE PROPERTY, BUYER AGREES TO ALL TERMS AND CONDITIONS SET FORTH AND ENTERS INTO A CONTRACTUAL AGREEMENT TO PURCHASE THE PROPERTY UNDER THE FOLLOWING TERMS AND CONDITIONS:

ONLINE BIDDING: AUCTION DATE / TIME: Bidding begins: April 30 2024 @ 2:00 PM EST; Bidding closes: April 30, 2024 @ 6:00 PM EST (**See AUCTION END TIMES).

UPON CONCLUSION OF THE AUCTION: The Winning Bidder(s) will be emailed a Real Estate Contract to print and is required to fully and correctly complete and properly sign without any modifications. Bidder is to return the completed, signed contract to Halderman Real Estate Services, Inc. by email, fax or delivered in person by 4:00 PM of the day following the auction. Along with the completed, signed contract, the Winning Bidder will be required to send the non-refundable earnest money deposit as stated in the real estate terms. This non-refundable earnest money deposit will be held in escrow until closing and that amount will then be credited to the Buyer as part of the purchase price of the property. Wire transfer instructions and escrow agreement forms will be provided to the Buyer along with the contract after the auction. Purchaser shall be responsible for all wire transfer fees.

Successful bidders not executing and returning the completed contract and earnest money deposit by 4:00 PM the day after the auction will be considered in default. - **COMBINATIONS:** The farm will be offered as individual tracts and in combinations.

- **POSSESSION:** Possession of the land will be at closing, subject to the tenant's rights. The cropland is rented for 2024 and possession will be after the crop is harvested, or December 31, 2024, whichever is sooner. The pasture land is rented and possession will be after the cattle are removed, which will occur no later than October 15, 2024.

- **REAL ESTATE TAXES:** Taxes will be prorated to the day of closing. The Seller will pay the 2023 real estate taxes, due and payable in 2024. Buyer will be given a credit at closing for the 2023 real estate taxes due and payable in 2024 and will be responsible to pay all taxes thereafter beginning with the fall 2024 installment.

- **RENTS:** Buyer(s) will receive half of the 2024 cash rent for the cropland and pasture.
