1. By deed dated July 2, 1968, Marvin E. Johnson and Lena G. Johnson, his wife, conveyed 0.715 acres to Samuel M. Donaldson, Jr. recorded in Deed Book 79 at Page 316. Also conveyed was a perpetual right of way and easement for the purpose of digging a ditch and laying a pipe line and a perpetual right of way for ingress and egress from the state road. This property is now owned by Kenneth Lee Claytor, et als. as shown on the Hiner plat as revised dated January 31, 2024.

2.. By deed dated December 12, 1985, recorded on January 13, 1986 in Deed Book 113 at Page 54, Marvin E. Johnson and Lena C. Johnson conveyed to Bath County Service Authority 0.022 acres, more or less, together with a perpetual easement of right of way for ingress and egress.

3. All easements as depicted on that revised plat dated January 31, 2024 and as conveyed by Deed of record as Instrument No. 21-190 of that right of way to the separate 4.284-acre parcel situated in the south portion of the parcel surveyed by Jeffrey Hiner.

There are acreage discrepancies between the revised Hiner plat of January 31, 2024 and the original deed into Marvin Johnson dated February 15, 1955 which states that the property that Marvin E. Johnson received from Belle W. Jordan and Ida M. Alphin contained 104 acres, more or less. By deed dated April 15, 1981, recorded on November 25, 1986, Marvin E. Johnson conveyed a tract alleged to contain 104 acres received from Jordan and Alphin to Jesse R. Johnson containing "100 acres or more". By deed dated March 19, 2021, recorded as Instrument No. 21-190, Jesse C. Johnson conveyed 2 parcels containing 32.047 acres and 4.284 acres from the real property he received from Jesse R. Johnson by deed dated February 18, 1993 recorded in Deed Book 136 at Page 188. The revised Hiner plat of January 31, 2024 depicts 155.020 acres and the tax records of Bath County reflect 66.69 acres belonging to Jesse Christopher Johnson.

All matters shown on the Hiner plat of January 31, 2024 including the rights of others to use the Winding Trail and Gabe Hollow Trail.
