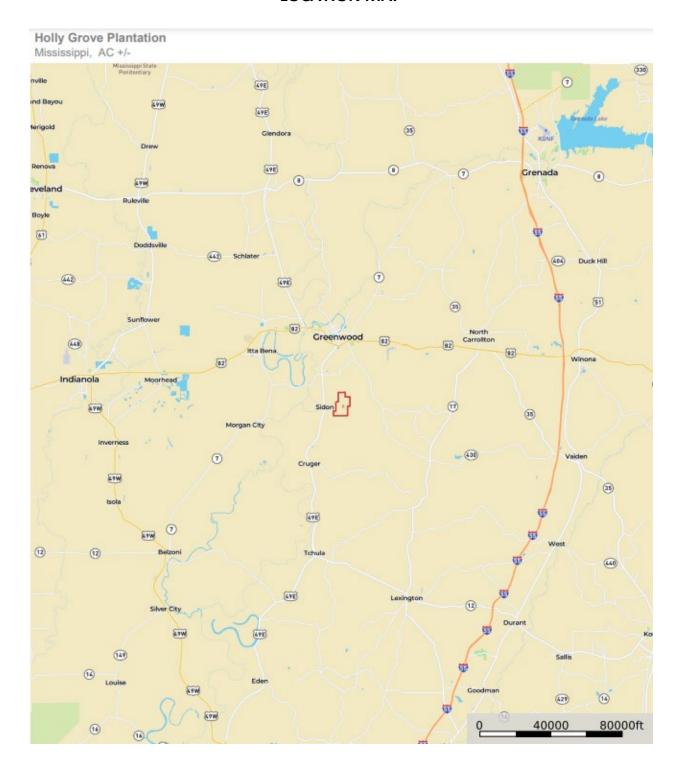

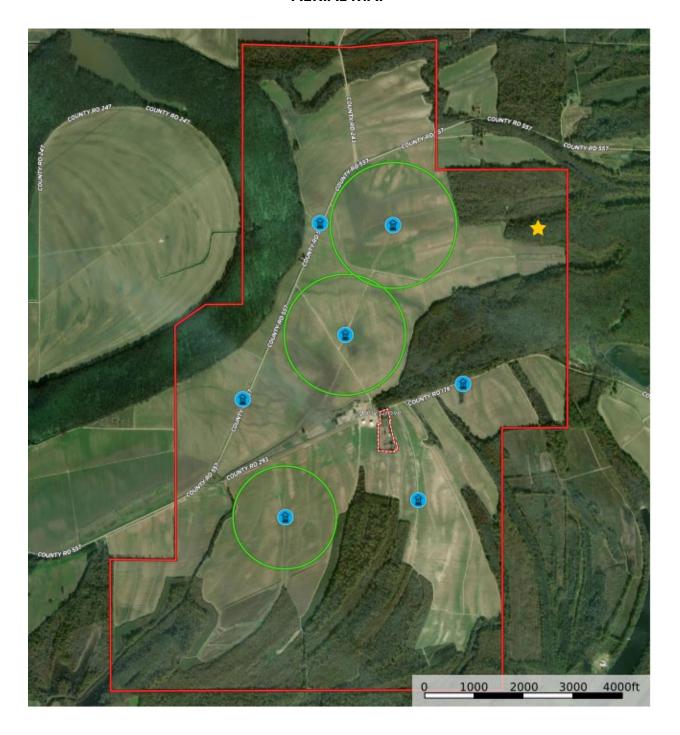

Subject Acres: The Holly Grove Plantation is one contiguous tract consisting of

1,953 +/- tax acres. The United States Department of

Agriculture (USDA) Farm Service Agency (FSA) states via the

FSA 156-EZ that there are 1,102.98 +/- acres of tillable

cropland and 300.71 +/- acres enrolled in the Conservation Reserve Program (CRP) generating additional income. The remaining acreage consists of 450 +/- acres of woods and the

balance of roads and ditches.

Cropland Info: Of the 1,102.98 FSA cropland acres, 690.7 (63%) are irrigated

from four (4) irrigation wells carrying water via underground pipe to risers and three (3) center pivots. Approximately 450.7

acres are furrow irrigation with the remaining 240 acres

irrigated by three center pivots.

Irrigation Info: The four (4) wells, pumps and gearheads providing furrow

irrigation are owned by the seller and will transfer to the

buyer. The three (3) center pivot well casings are owned by the seller, but the pivots, pumps, and gearheads are owned by the

CRP: The farm includes eleven (11) CRP contracts totaling 300.71

acres that generate annual payments of \$27,573.00.

Improvements: The headquarters site includes one $80' \times 60' (4,800 +/- sq. ft.)$

open equipment shed, one 140' x 40' (5,600 +/- sq. ft.) open equipment shed, one 35' x 50' (1,750 +/- sq. ft.) enclosed storage building, and one 50' x 60' (3,000 +/- sq. ft.) enclosed farm shop with an additional 30' x 60' (1,800 +/- sq. ft.) of open storage. The equipment sheds and enclosed farm shop and building are in excellent condition and provide an ideal

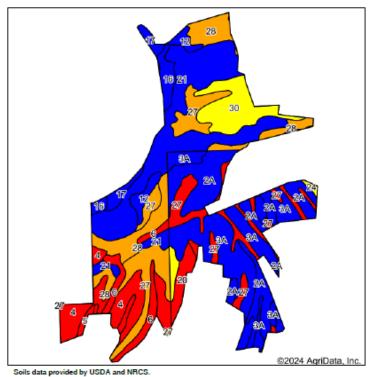

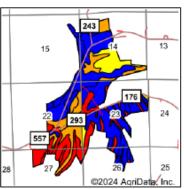
