2. Filing of all necessary paperwork with the county if applicable.
3. Clean up work site and dispose of refuse.
4. Ensure complete system performance by testing. The determination of performance is based on the system condition at the time of the repair.

5. Honor warranty on parts

JerNan Septic and Rainwater Solutions and its sub-contractors are not responsible for the costs associated with damaged sidewalks, driveways, fences, trees or other more permanent obstructions, incurred during the course of construction.
2. Water and spigot to wash down tanks and components.
3. Access to power supply for control of the system during repair.
4. Haul off of soil spoils.
5. Costs associated with the excavation of solid rock and backfill material necessary for the removal and replacement of soils.
6. Costs associated with the revegetation of landscaped areas, replacement of gravel in driveways and walkways, etc.
7. Costs associated with the damages to any unmarked underground utilities both public and private.
8. Costs associated with the discovery of any unknown variables that may be encountered during the course of construction or repair.
