AMENDMENT TO PROTECTIVE COVENANTS

THIS AMENDMENT TO PROTECTIVE COVENANTS made this 27th day of September 1993 by STEPHEN C. GOULD, JUDITH U. GOULD, JAMES M. ADAMS and GAYLE W. ADAMS, hereinafter called OWNERS:

OWNERS of the developers of Riverview Estates Subdivision as shown on map recorded in Plat Record File 3, Slide 91-24, Franklin County Registry. By Protective Covenants recorded in Book 939, Page 322, all of Lots 1 through 13 of Riverview Estates were subjected to those Protective Covenants.

The Protective Covenants recorded in Book 939, Page 324 state that on Lots 1, 5, 6, 7, 11, 12 and 13 a barn or other housing facility may be constructed for up to three horses.

The 2nd paragraph beginning on page 3 of the Protective Covenants recorded in Book 939, Page 322 is hereby amended to say that Owners of Lots 1, 5, 6, 7, 11, 12 and 13 can have up to three horses on their lot if such horses are properly fenced and housed.

In all other respects the Protective Covenants recorded in Book 939, Page 322 remain in full force and effect.
