LEGAL DESCRIPTION

A 1402.17 acre tract of land out of Sections 3, 4, & 5, Block 1, J. Poitevent Survey, Hall County, Texas, and being all of a 176 acre tract of land, a 485.40 acre tract of land, & a 585 acre tract of land described in Volume 297, Page 258, Official Public Records of Hall County, Texas, said 1402.17 acre tract of land being described by metes and bounds as follows:

BEGINNING at a 1/2" rebar with cap found in the west line of said Section 3, whence a 1/2" rebar with cap found in the West line of said Section 3 bears N 01°28'51" W -BASE BEARING- (bearings and distances contained herein are relative to Texas State Plane North zone NAD 83) 5881.58 feet;

THENCE N 44°10'56" E, 455.08 feet to a 1/2" rebar with cap found;

THENCE N 30°18'58" E, 3792.40 feet to a 1/2" rebar with cap found:

THENCE N 66°39'34" E, at 314.27 feet pass the East line of said Section 3, continue for a total distance of 1081.00 feet to a 1/2" rebar with cap found;

**THENCE** N 52°07'55" E, 2423.22 feet to a 1/2" rebar with cap found in the West line of said Section 5;

THENCE N 01°34'07" W, 1964.53 feet along the West line of said Section 5 to a point on the South low bank and vegetation line of the Prairie Dog Fork of the Red River;

THENCE along said South low bank and vegetation line to angle points as follows;

S 53°28'55" E, 241.48 feet to an angle point;

S 61°35'20" E, 405.38 feet to an angle point;

S 69°40'15" E, 1785.04 to an angle point;

N 82°42'48" E, 372.50 to a point in the East line of said Section 5;

THENCE S 01°34'07" E with the East line of Said Section 5, at 728.83 feet pass an 1 1/2" iron pipe found, at 9573.62 feet pass an 1 1/2" iron pipe found, continue for a total distance of 11098.90 feet to a point at the intersection of the East line of said Section 5 and a fence on the South bank of the Little Red River;

THENCE with the meanders of the South bank of said Little Red River to angle points as follows:

S 76°46'27" W, 2366.45 feet to an angle point;

S 72°11'27" W, 260.87 feet to a point in the West line of said Section 5;

THENCE N 01°34'07" W, 2526.75 feet along the West line of said Section 5 to a point in the center of said Little Red River;

THENCE with the meanders of the center of said Little Red River to angle points as follows;

S 57°00'34" W, 1617.08 feet to an angle point;

N 81°20'56" W, 661.24 feet to an angle point;

N 60°30'00" W, 747.22 feet to to an angle point in the West line of said Section 4;

N 54°40'34" W, 1149.75 feet to an angle point

N 51°01'52" W, 2233.29 feet to a point in the West line of said Section 3;

THENCE N 01°28'51" W, 964.03 feet with the West line of said Section 3 to the POINT OF BEGINNING of this tract of land;
