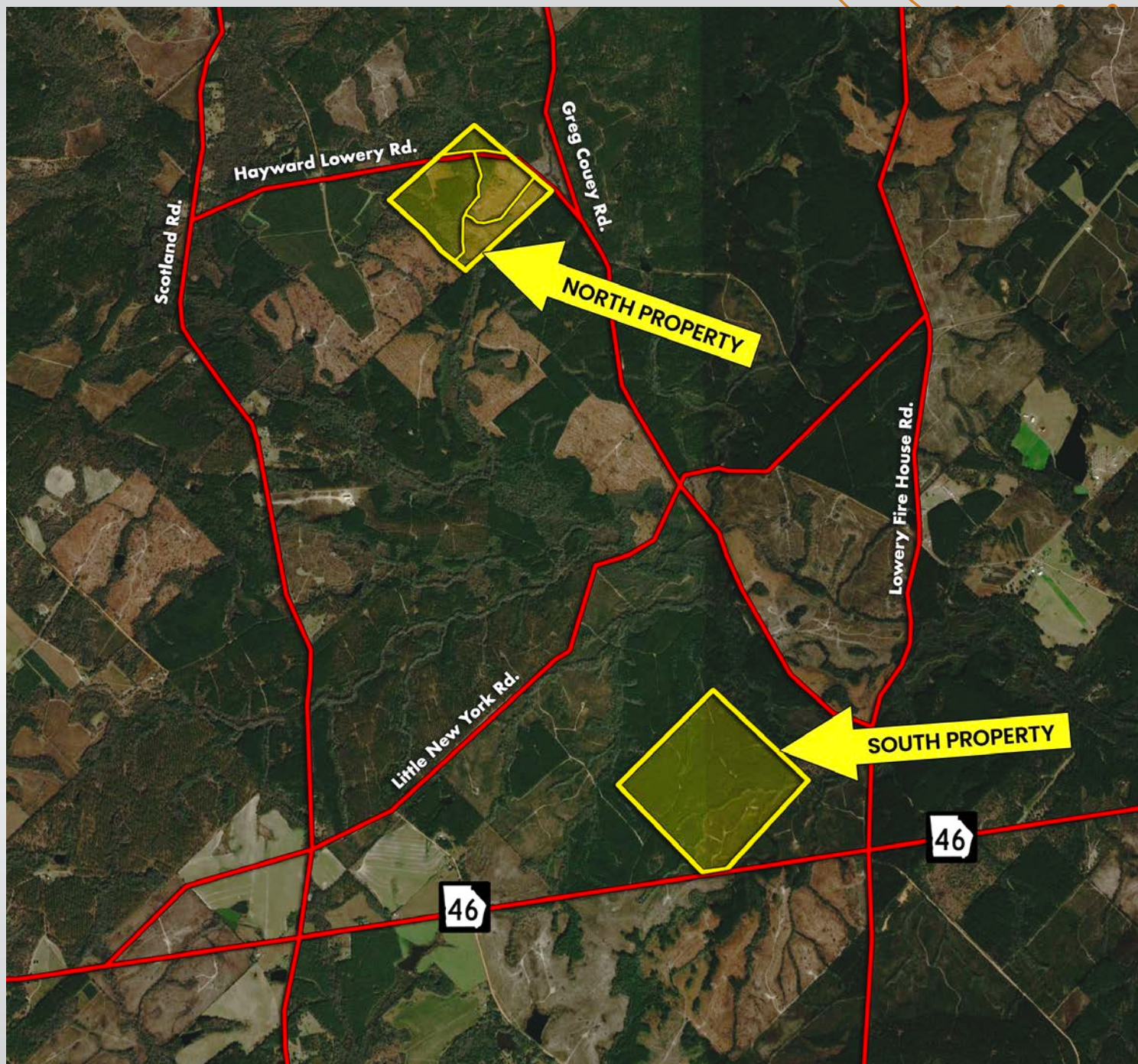

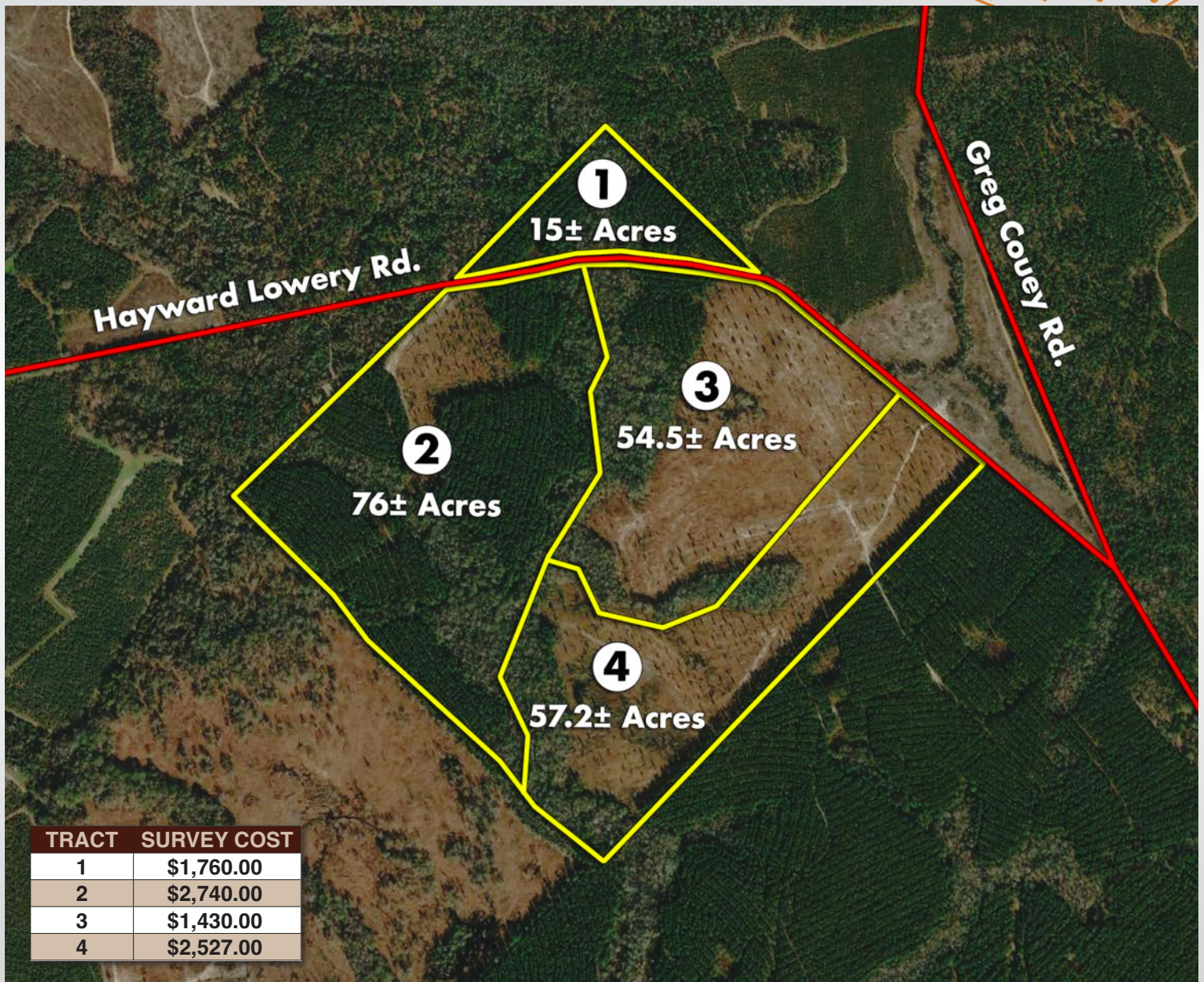




LOCATION MAP

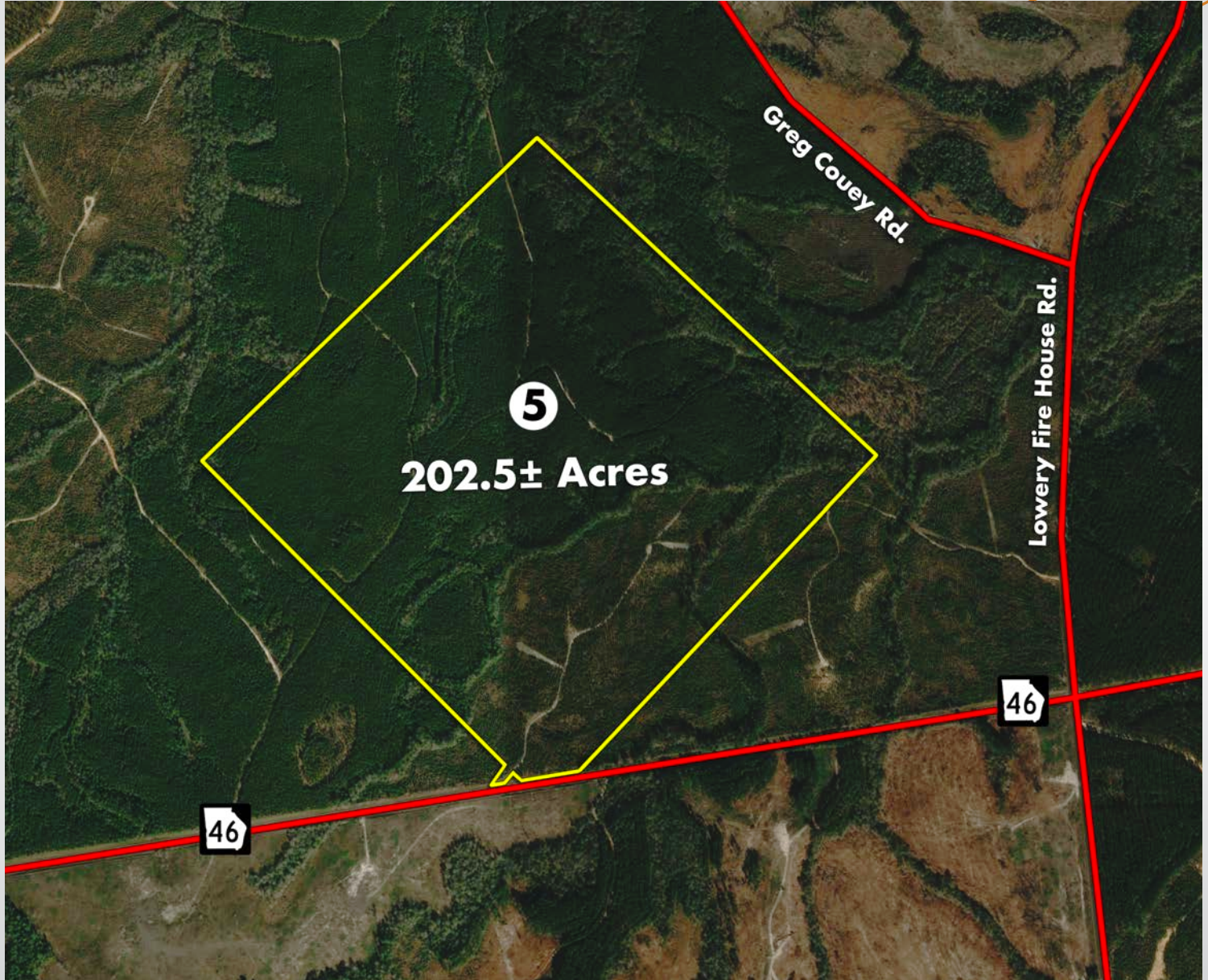


NORTH PROPERTY TRACT MAP





SOUTH PROPERTY TRACT MAP

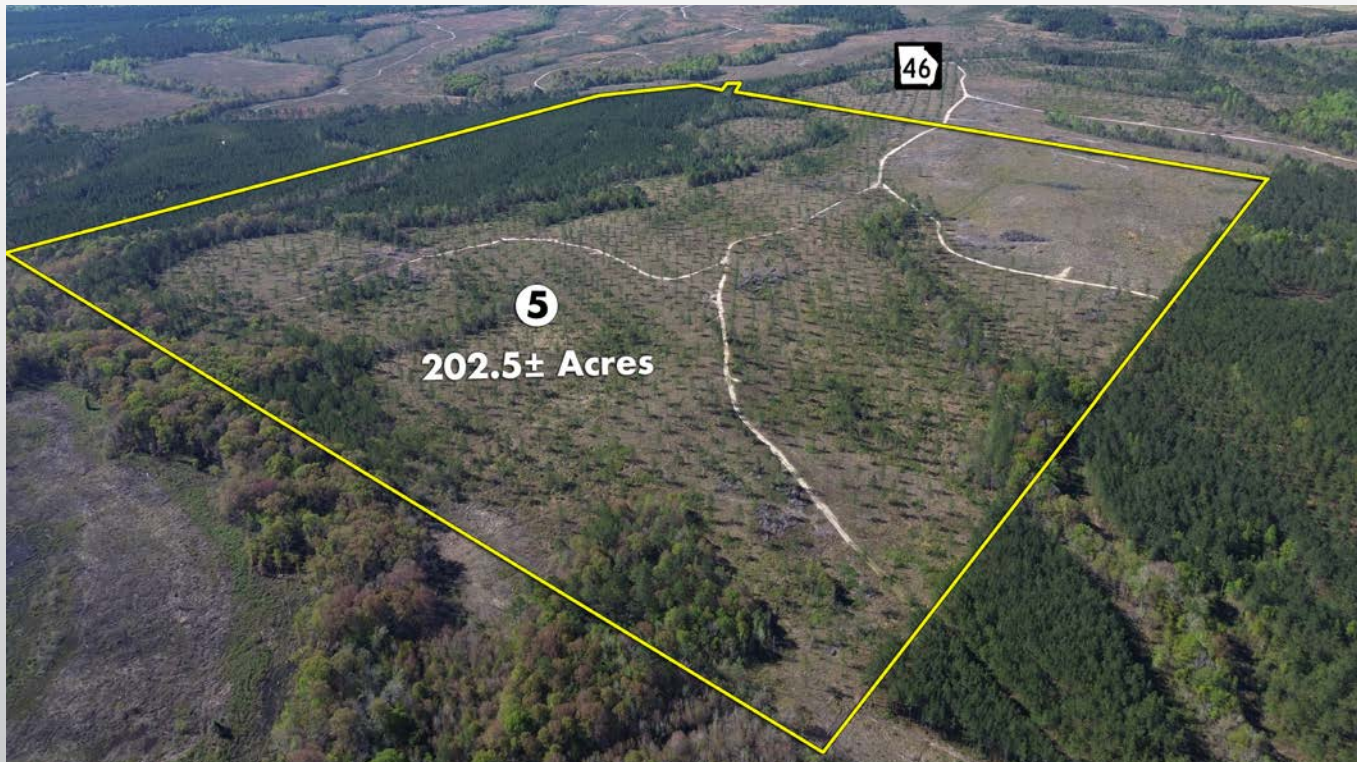




NORTH PROPERTY DRONE MAP



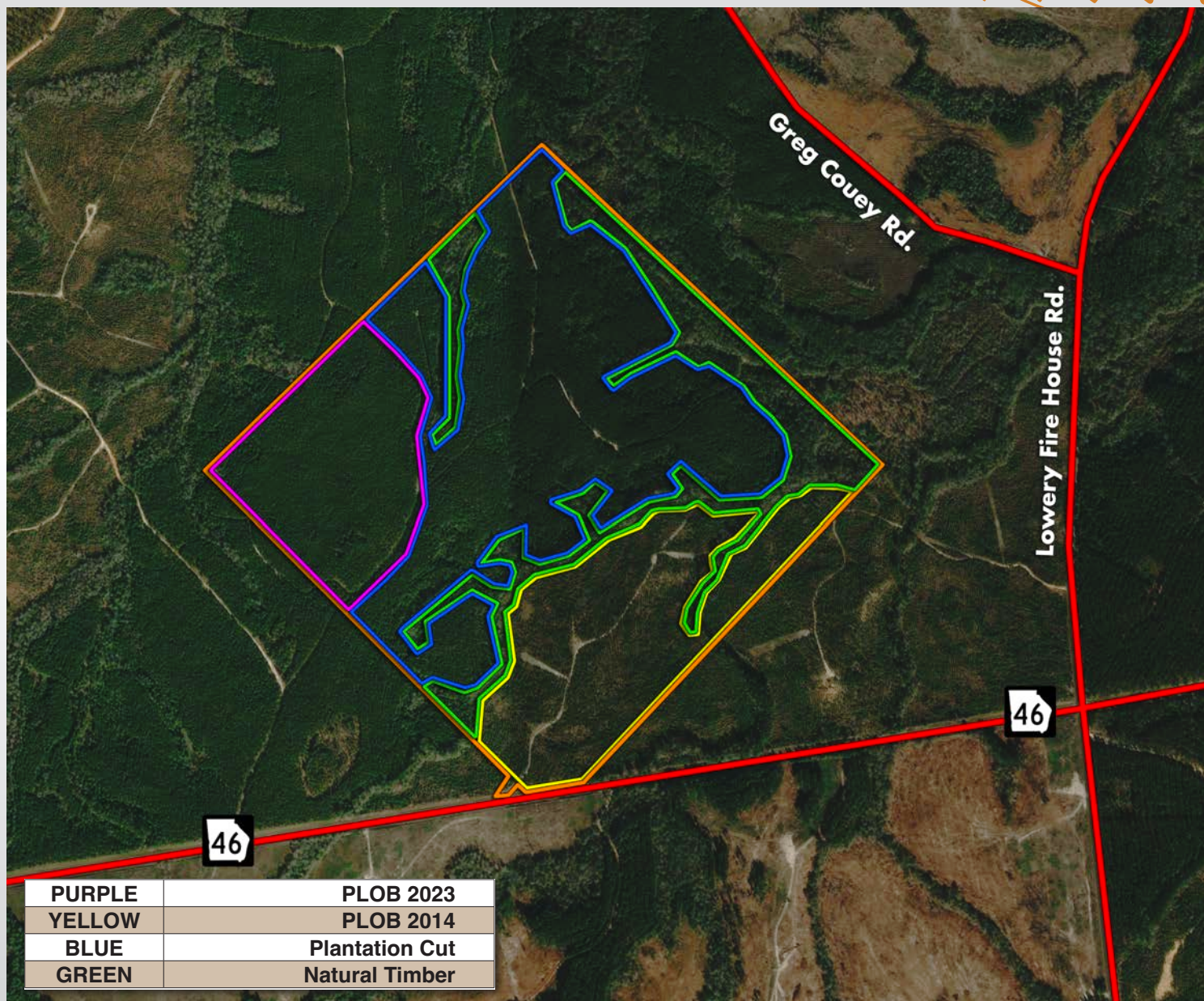

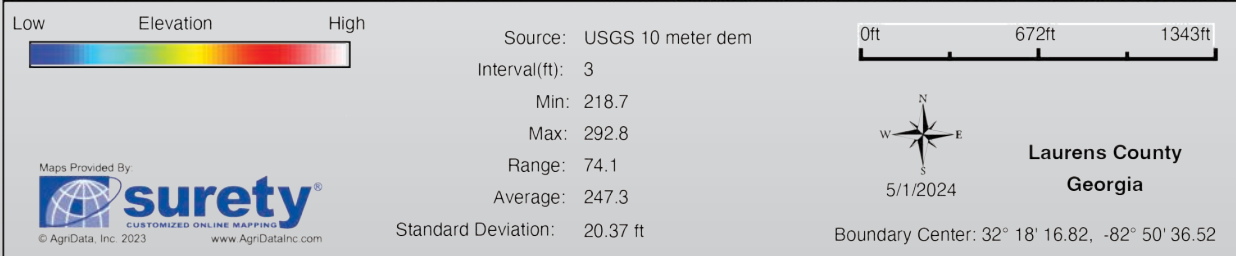
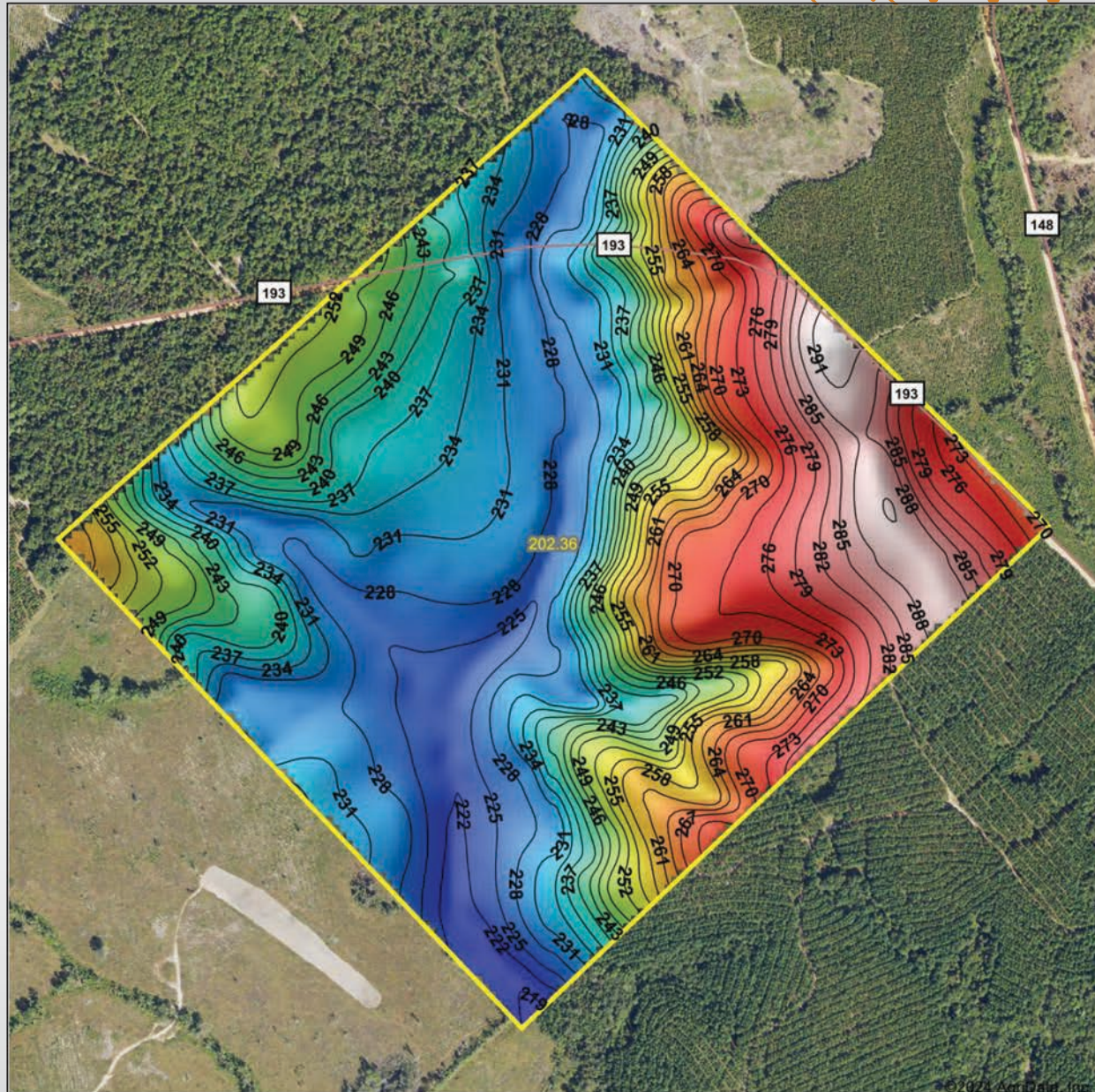


SOUTH PROPERTY TIMBER MAP





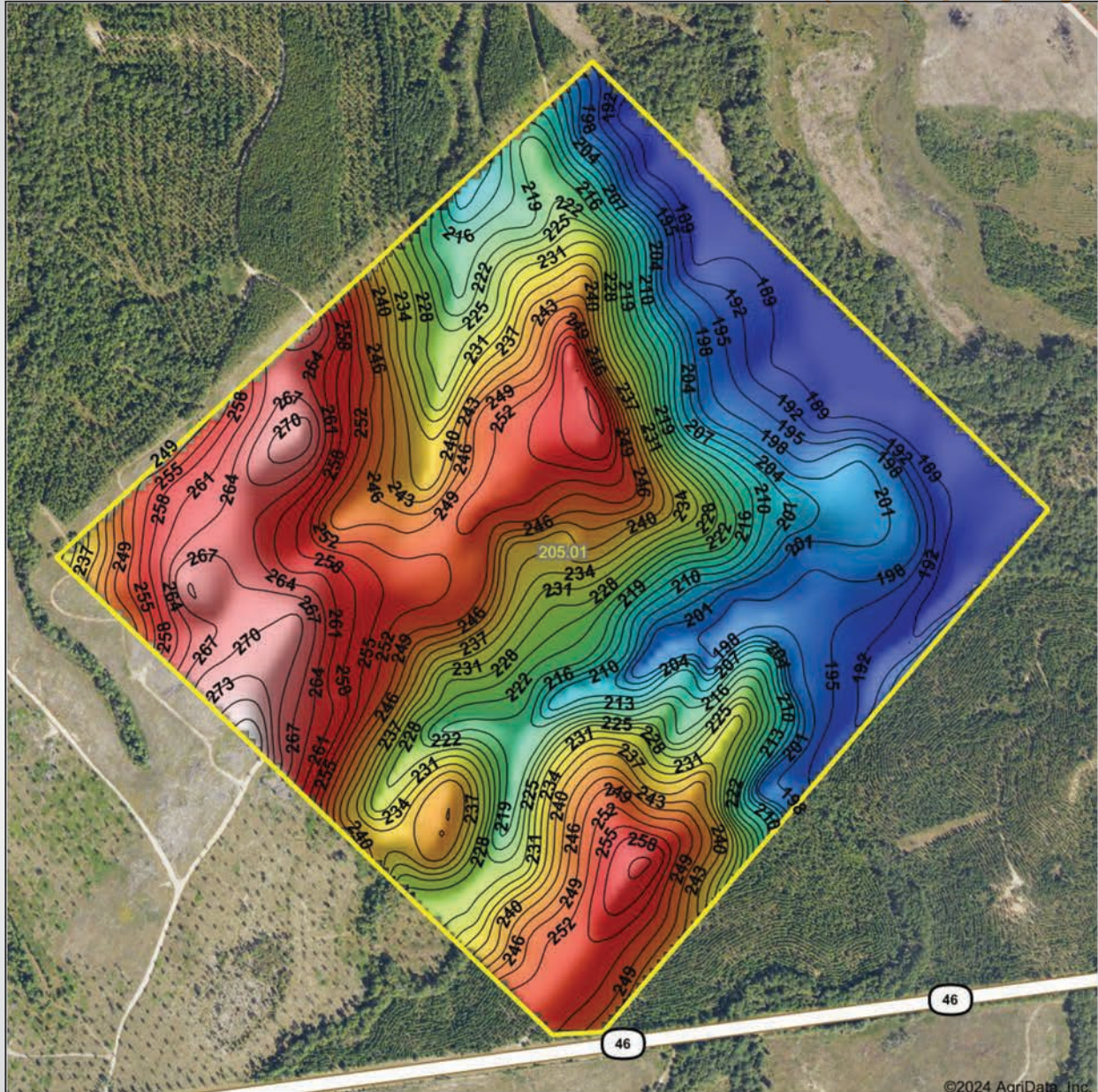
NORTH PROPERTY TOPOGRAPHY MAP

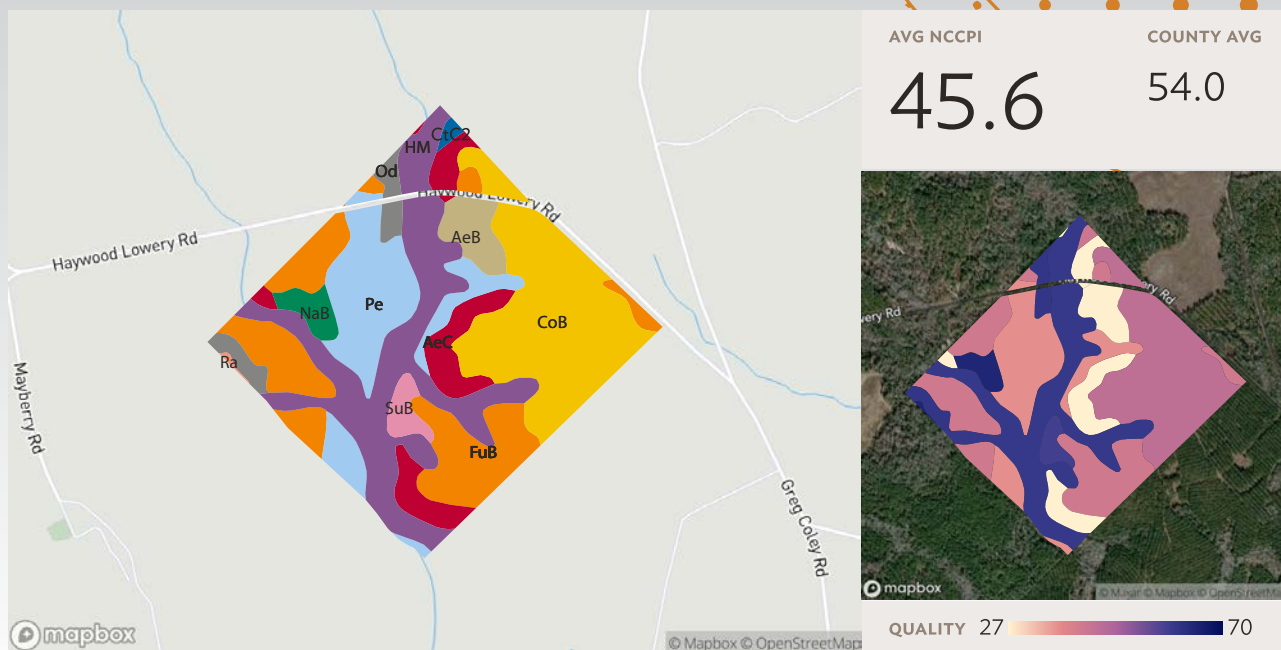

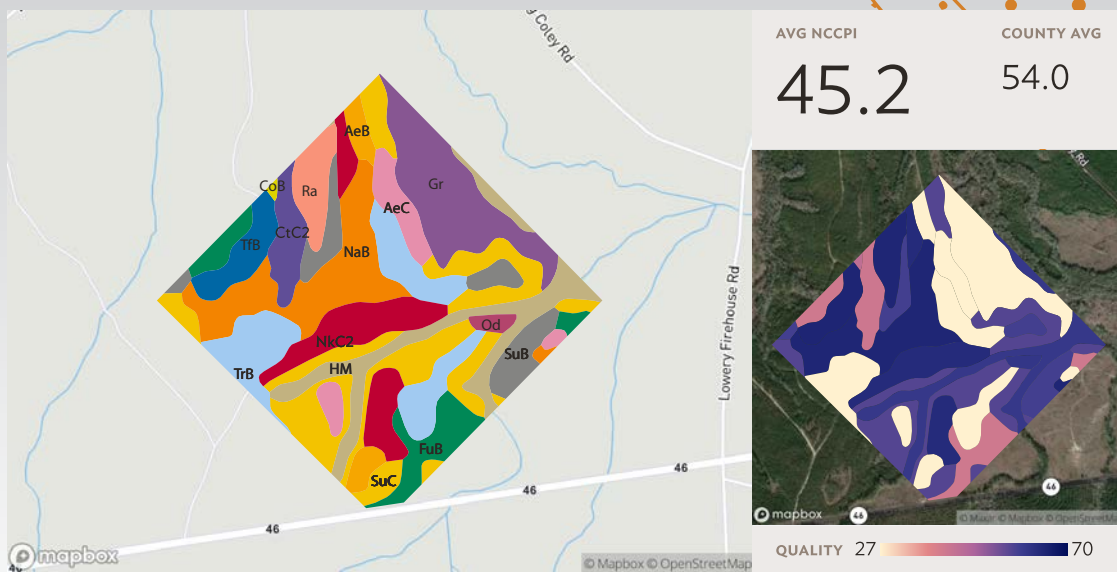
