PROPERTY OVERVIEW

Sunspot Timber & Hunting, in the same family for generations, sets itself apart from other available land properties due to the amount of quality mature pine & hardwood timber, quality land steward neighbors, paved road frontage, double frontage on well-known creeks (Lockhart & Cowikee Creek), existing food plots, & more.

Located just west of Hurtsboro in the eastern portion of the famed Black Belt Region of Alabama in Bullock & Macon Counties, Sunspot has been well managed for generations through prescribed burning and periodic pine stand improvement thinnings. The mature pine stands are currently heavily stocked with quality pine sawtimber. The hardwood stands are some of the finest in Alabama, fully stocked with grade hardwood sawtimber, including most major oak species as well as some well stocked pre-merchantable planted loblolly stands.

Complimenting the excellent timber and tranquil creeks are existing food plots and wildlife openings throughout the property. There is a thorough woods road and firebreak network providing excellent internal access. Thanks to the timber being mostly fully stocked and the use of prescribed fire in the pine stands, Sunspot offers a clean understory making the property a true pleasure to walk, whether for relaxation or hunting purposes.
