

OUITCLAIM DEED WITH COVENANT

WB RE HOLDINGS, LLC, a New York limited liability company with a place of business in New York, New York, for consideration paid, grants to John Paul Maginel and Paige Helm Maginel, both of Dongola, Illinois, not individually but only in their capacities as Trustees of the John Paul Maginel and Paige Helm Maginel Joint Revocable Trust, with a mailing address of 250 Hopper Lane, Dongola, IL 62926, with Quitclaim Covenant, a certain lot or parcel of land, in Franklin, Hancock County, Maine, described as follows:

Lot No. 1 - Bounded on the North by the waters of Hog Bay, so-called, and being a distance of seventy-six (76) rods, more or less; Easterly by land formerly owned or occupied by one Stanley-Gordon; Southerly by the Town Lots, so-called, formerly owned or occupied by John Adams and Theodore Bragdon; Westerly by the Leeman Orcutt lot, so-called; said lot or parcel is the western one half of a wood lot formerly owned in common by Enoch Blaisdell and another. The easterly bound of said lot being established by Agreement between Frederick Bender, Benjamin Bronfeld and Belle Bronfeld, dated October 14, 1982, and recorded in the Hancock County Registry of Deeds in Book 1448, Page 618.

Lot No. 2 - Bounded Northerly by land formerly owned or occupied by Stanley Gordon and by the lot described in preceding paragraph; Easterly by land now or formerly of Marcia Joy; Southerly by the Franklin-Sullivan Town Line; Westerly by land now or formerly of William B. Blaisdell.

Lot No. 3 - Bounded Northerly by the Town Road, so-called; Easterly by the first above described lot or parcel; Southerly by the second lot above described and land of Martha Bragdon Heirs; Westerly by land formerly owned or occupied by Madison Gordon. This lot or parcel is commonly known as the Leeman Orcutt Lot.

EXCEPTING that certain lot or parcel of land situated in Township 16, Middle Division, in said Hancock County, and being bounded and described as "Meadow Lot" on West Branch Narraguagus River in or near Section 11, as described in Resolve H.P. 243, L.D. 311, Chapter 11, Approved February 21, 1963 by the Maine, State Legislature.
