Tama County, Iowa Land Auction - Mark your calendar for Thursday, September 8th, 2022! Peoples Company is honored to offer 160.54 surveyed acres located in one of Iowa's highest producing counties. The auction will take place at 10:00 AM in the Traer Memorial Building located in Traer, Iowa.

The farm has 153.1 FSA cropland of which 152.04 acres are currently planted to corn carrying a CSR2 of 81. The primary soil types are Bremer Silty Clay Loam, Colo Silty Clay Loam, and Nevin Silty Clay Loam. The farm is open for the 2023 cropping season. The property is located southwest of Traer, Iowa along M Avenue, in Section 12 of Crystal Township.

The land auction can also be viewed through our Virtual Online Auction platform with online bidding, via the Peoples Company website or you can follow along live through our Facebook page on the day of the sale.

Auction Method: The farmland will be sold as one individual tract on a price per acre basis to the High Bidder.

Farm Program Information: Farm Program Information is provided by the Tama County Farm Service Agencies. The figures stated in the marketing material are the best estimates of the Seller and Peoples Company; however, Farm Program Information, base acres, total crop acres, conservation plan, etc. are subject to change when the farm is reconstituted by the Tama County FSA and NRCS offices.

Earnest Money Payment: A 10% earnest money payment is required on the day of the auction. The earnest money payment may be paid in the form of check or wire transfer. All funds will be held at SettleUp.

Closing: Closing will occur on or before Thursday, October 20th, 2022. The balance of the purchase price will be payable at closing in the form of guaranteed check or wire transfer.

Possession: Possession of the farm will be given At Closing, Subject to Tenant's Rights. Farm is open for the 2023 cropping season.

Contract & Title: Immediately upon the conclusion of the auction, the high bidder will enter into a real estate sales contract and deposit with Peoples Company the required earnest money payment. The Seller will provide a current abstract at their expense. Sale is not contingent upon Buyer financing.

Bidder Registration: All prospective bidders must register with Peoples Company and receive a bidder number in order to bid at the auction.
