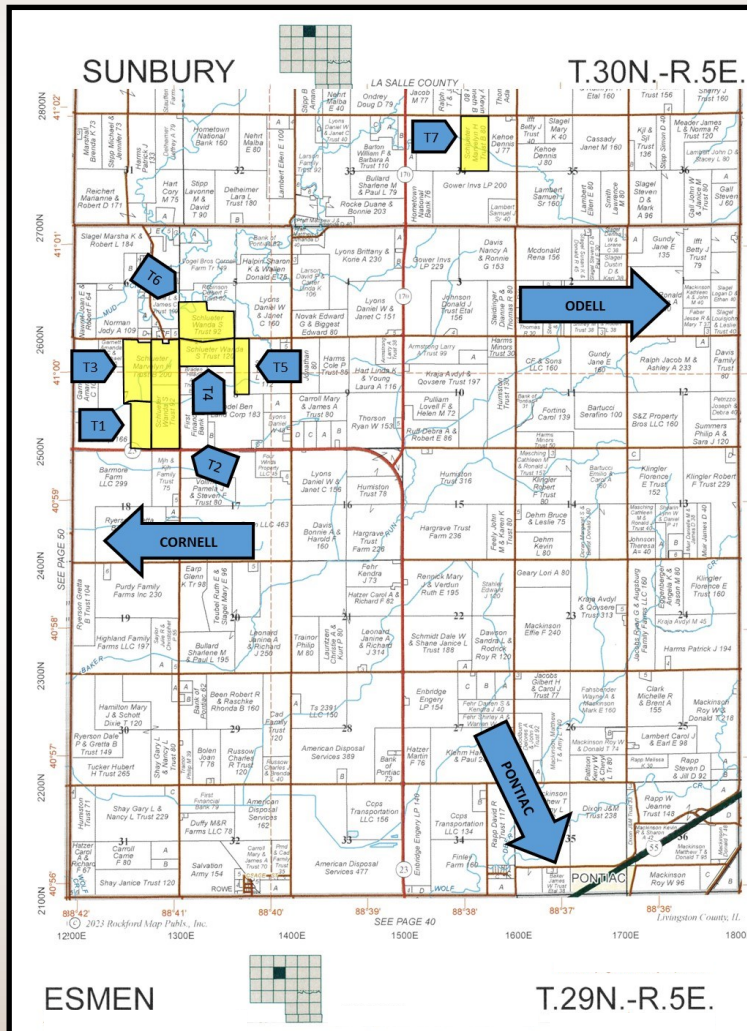

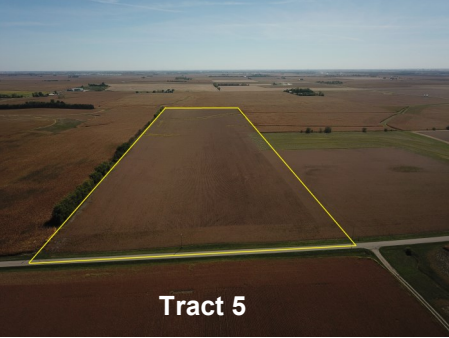
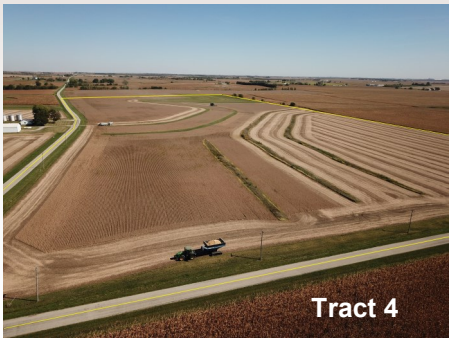

Buyer will enter into a contract following the auction, with 10% down payment required and balance due at closing on or before 30 days after the auction. A title policy in the amount of the sale price will be furnished to the Buyer, subject to standard and usual exceptions. Seller shall retain the 2024 crop income/cash rent or government payments and pay all related expenses for the 2024 crop year. Any Conservation Reserve Program Contract(s) shall be assigned to Buyer. Buyer shall agree to continue to honor any existing government agricultural program and conservation contracts affecting the real estate and indemnify and hold harmless Seller for any damage Seller may sustain by reason of any failure of Buyer to keep or perform any of the covenants and obligations provided to be kept or performed under the terms and conditions of any such contracts by Seller.
