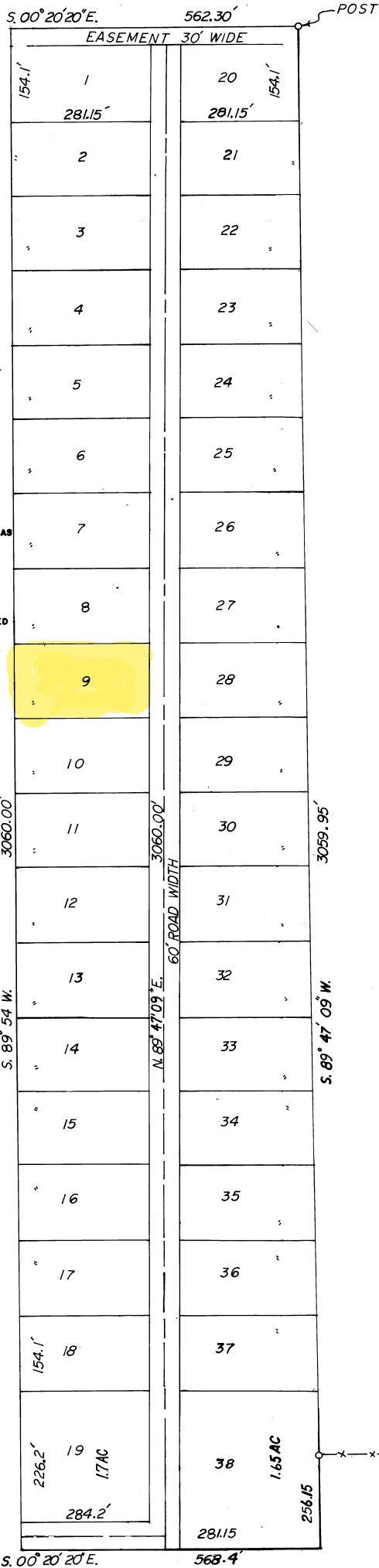
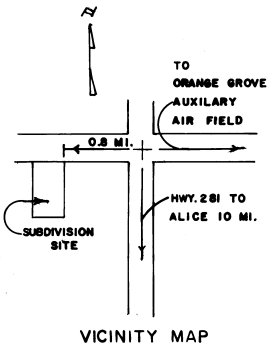
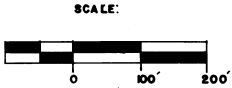


AMARGOSA SUBDIVISION UNIT NO. 2
