AGREEMENT FOR MODIFICATION OF DEED RESTRICTIONS

THAT WHEREAS, GRANITE PARTNERS, LLC, a Delaware limited liability company, herein called "Owner" and "Declarant", is the record owner of all that certain 2,397.14 acres, more or less, in Burnet County, Texas, more particularly described on Exhibit "A", attached hereto and made a part hereof, SAVE and EXCEPT, that certain 25.00 acre tract more particularly described on Exhibit "B", and further SAVE and EXCEPT that certain 20.20 acre tract more particularly described on Exhibit "C", attached hereto and incorporated for all purposes, and SAVE and EXCEPT that certain 200.00 acres of land more particularly described on Exhibit "D", attached hereto and incorporated herein for all purposes ("Granite Partners Property"); and

WHEREAS, LARRY McNIEL and SHIRLEY McNIEL are the owners of that certain 25.00 acre tract more particularly described on Exhibit "B" ("McNiel Property"); and

WHEREAS, 20 ACRES MCNIEL, LLC, a Texas limited liability company is the owner of that certain 20.20 acre tract more particularly described on Exhibit "C" ("20 Acres McNiel Property"); and

WHEREAS, certain deed restrictions were put in place in that Warranty Deed from Granite Partners, LLC to Larry McNiel and Shirley McNiel dated May 28, 2020 and recorded at Register Number 202006067 of the Official Public Records of Burnet County, Texas ("Original Deed Restrictions"); and

WHEREAS, Granite Partners, LLC, Larry McNiel and Shirley McNiel, and 20 Acres McNiel, LLC wish to hereby modify the Deed Restrictions, both as to content and the real property that is encumbered and restricted under the Deed Restrictions; and

WHEREAS, Granite Partners, LLC, Larry McNiel and Shirley McNiel, and 20 Acres McNiel, LLC hereby agree that the deed restrictions set forth in Article I herein shall fully replace the Original Deed Restrictions ("Revised Deed Restrictions); and

WHEREAS, Larry McNiel and Shirley McNiel, and 20 Acres McNiel, LLC will hold, sell and convey the McNiel Property and the 20 Acres McNiel Property subject to certain protective covenants, reservations, conditions, restrictions and charges as hereinafter set forth:

NOW, THEREFORE, it is hereby declared that all of the above referred Property shall be held, sold and conveyed subject to the following restrictions, covenants and conditions which are for the purpose of protecting the value and desirability of, and which shall run with the land and shall be binding on all parties having a right, title or interest in or to the above described McNiel Property and 20 Acres McNiel

Property, or any part thereof, and their heirs, successors and assigns, and which restrictions, covenants and conditions shall inure to the benefit of each owner thereof, and any Tract or deed which may hereafter be executed in connection with said McNiel Property and 20 Acres McNiel Property, or any part thereof, shall be conclusively held to have been executed, delivered and accepted subject to the terms and conditions contained in this instrument, regardless of whether or not such terms and conditions are specifically set out in said Tract or deed.

ARTICLE I. Revised Deed Restrictions

- 1. McNiel Property and 20 Acres McNiel Property shall be used solely for single-family residential and agricultural purposes.
- 2. Mobile, modular, pre-manufactured, and/or industrial built homes, recreational vehicles (RV's), campers or other trailer units shall not be used as a dwelling, nor stored on the McNiel Property and 20 Acres McNiel Property.
- 3. No structure shall be erected on the McNiel Property and 20 Acres McNiel Property nearer than two hundred feet (200') from the western boundary line of the McNiel Property and the 20 Acres McNiel Property and the northern boundary line of the 20 Acres McNiel Property.
- 4. The McNiel Property and 20 Acres McNiel Property shall not be used for any commercial purposes, except permanent agricultural crops including vineyards, fruit trees, pecan groves and permanent grass (hay meadows or grazing pastures) and livestock production. No industrial pursuit or enterprise shall be permitted to be conducted on the McNiel Property and 20 Acres McNiel Property.
- 5. Abandoned or inoperative equipment, vehicles or junk shall not be permitted, placed or stored on the McNiel Property and 20 Acres McNiel Property.
- 6. There shall not be any commercial feeding operations or commercial breeding of animals conducted on McNiel Property and 20 Acres McNiel Property. Agricultural animals used for grazing said McNiel Property and 20 Acres McNiel Property while simultaneously raising young (i.e. cow/calf operation) shall not be considered commercial breeding of animals.
- 7. No waste dumping or burying or disposal of any kind shall be allowed that would pollute any stream or body of water, or adversely affect the natural beauty and value of the McNiel Property and 20 Acres McNiel Property. Garbage or refuse shall not be disposed of or buried on the McNiel Property and 20 Acres McNiel Property.
- 8. Mineral exploration of any type which will damage the surface shall not be permitted on the McNiel Property and 20 Acres McNiel Property.
- 9. No cellular tower or other type of commercial tower shall be erected or placed upon the McNiel Property and 20 Acres McNiel Property.
- 10. McNiel Property and 20 Acres McNiel Property may only be subdivided once, and said subdivision may only be conveyed to an immediate family of Larry and Shirley McNiel.

This Agreement for Modification of Deed Restrictions shall be binding upon and inure to the benefit of parties below, and their respective heirs, successors and assigns.




