DESCRIPTION:

The facility has three robot rooms with four Lely robots each and six robot rooms with a single Lely robot for a total of 18 Lely robots. Of the 18 robots, six are included in the sale of the dairy. The other 12 Lely robots are to be sold via a separate allocation from the real estate.

The facility also features automatic cable scrapers, Lely cow brushes, automatic Lely feed pushers, two 8,000-gallon milk tanks, a 6,000-gallon Mueller tank and a 2,000-gallon tank. There is one residence on the facility, a 1,858 square foot Ranch style home with a nice shop.

The facility has six pens, each pen has: 186 stanchions, 199 free stall beds with water mattresses, built in foot bath, and air gates for sorting cows. There are two 400k BTU boilers, and a 20,000-gallon freshwater storage tank.

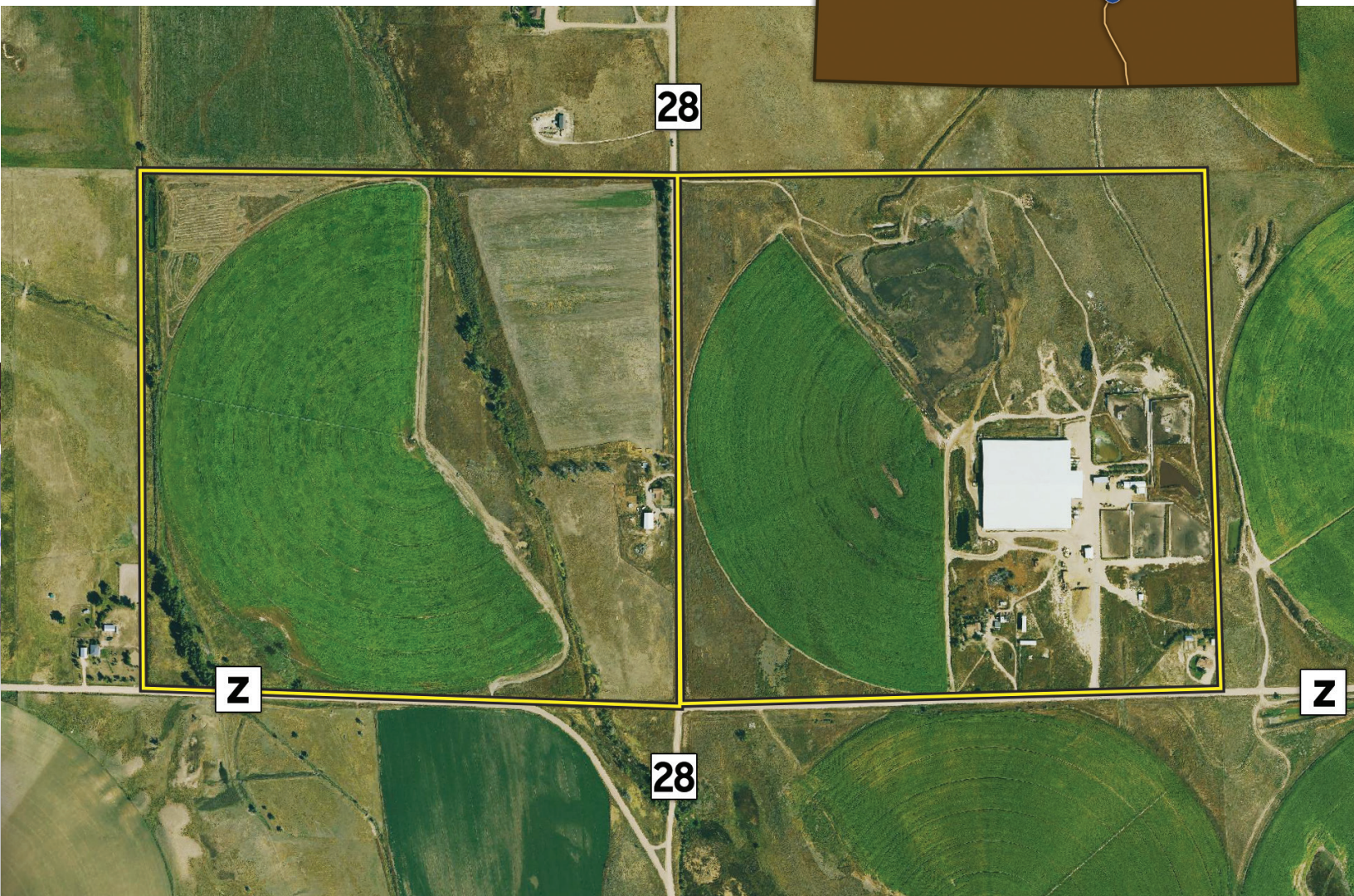
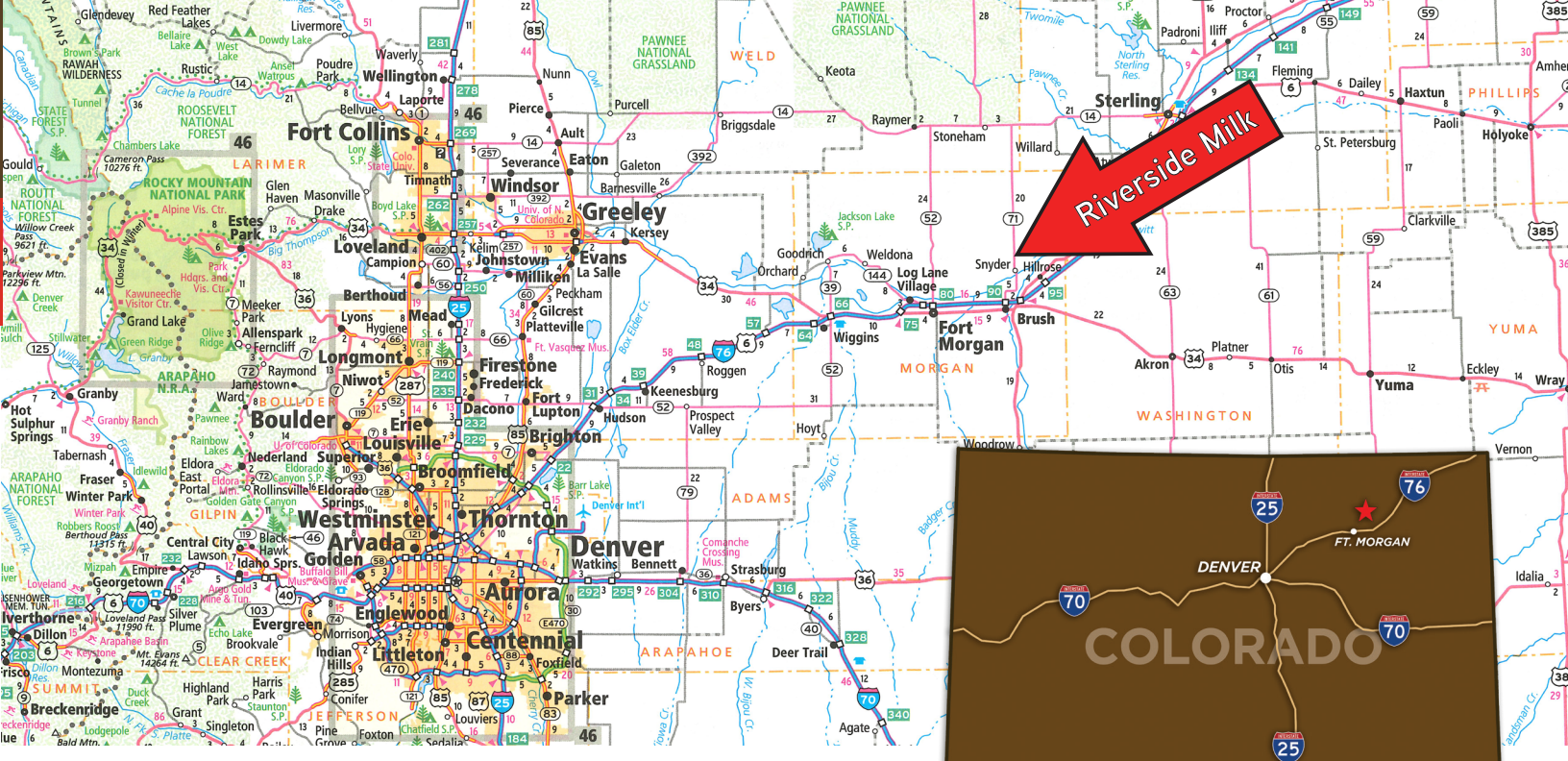
