

## DESCRIPTION OF PROPERTY - TRACT I:

All that certain tract or parcel of land being a part of the SE1/4 of the NW1/4 and the SW1/4 of the NE1/4 of Section 19, T. 15 S., R. 27 W., Miller County, Arkansas; and being more particularly described by metes and bounds as follows:

COMMENCING at an axle found in place at the Northwest corner of the SW1/4 of the NE1/4 of Section 19, T. 15 S., R. 27 W., Miller County, Arkansas; THENCE – S. 89° 47′ 00″ W., 714.98 ft. with the North boundary line of the above mentioned SW1/4 of the NE1/4 to a 1/2″ reinf. steel set for corner, the POINT OF BEGINNING of the herein described tract of land:

THENCE - S. 89°47'00" W., 528.53 ft. with the above mentioned North boundary line of the SW1/4 of the NE1/4 to an axle found in place at an existing fence corner;

THENCE - S. 00° 27' 59" W., 420.57 ft. with an existing fence line to a 3/8" square iron pin found in place;

THENCE - N. 89° 31′ 59″ E., passing at 1273.16 ft. a 1-1/4″ iron pipe found in place and continuing 30.00 ft. for a total distance of 1303.16 ft. to the center of County Road No. 278;

THENCE - Northeasterly with the centerline of the above mentioned County Road No. 278 along the following courses: N. 32 ° 20 ' 06" E., 30.10 ft. and N. 50 ° 50' 06" E., 39.50 ft.;

THENCE - S. 89° 31′ 59" W., passing at 30.00 ft. a 1/2" reinf. steel set for offset corner and continuing 790.91 ft. for a total distance of 820.91 ft. to a 1/2" reinf. steel set for corner;

BEGINNING at an axle found in place at the Northwest corner of the SW1/4 of the NE1/4 of Section 19, T. 15 S., R. 27 W., Miller County, Arkansas;

THENCE - N. 89° 47' 00" E., 97.16 ft. with the North boundary line of the above mentioned NW1/4 of the NE1/4 to a 1/2" reinf. steel set at the Northwest corner of a certain 0.60 acre tract;

THENCE - S. 00° 13' 00" E., 80.00 ft. with the West boundary line of the above mentioned 0.60 acre tract to a 1/2" reinf. steel set at the Southwest corner of said 0.60 acre tract:

THENCE - N. 89° 47′ 00″ E., with the South boundary line of the above mentioned 0.60 acre tract, passing at 275.56 ft. a 1/2″ reinf. steel set for offset corner and continuing 25.00 ft. for a total distance of 300.56 ft. to the center of County Road No. 278;
