## **PROPERTY SUMMARY**

he Chalk Woods is a turn-key, developed hunting property that provides authentic greentimber duck hunting, deer hunting, and an onsite hunting camp. The land consists of 73.0 +/- acres located in Prairie County, Arkansas, just north of Biscoe, with excellent access directly off state Highway 33, which is connected to I-40 roughly three miles south.

The land rests between the White and Cache Rivers and is in the epicenter of some of the best mallard duck wintering grounds in North America. The expansive Cache River NWR is only one mile east, and just over a mile away are the White River bottoms and the Plunkett Farm Unit of the Cache River NWR. The Plunkett Farm Unit is a waterfowl sanctuary known for consistently holding thousands of ducks in the fall and winter. An estimated 7,000 +/- acres of adjacent waterfowl habitat landscape is within a five-mile radius of the property.

The land offers 66.0 +/- acres of bottomland hardwood timber, which of 50.0 +/- acres are impounded to form a green-tree reservoir (GTR) for duck hunting. The GTR has three traditional shooting holes, all mulched with one planted in millet, and an opening on the southwest portion as an alternative shooting location. A

12-inch diesel-powered well for pumping the GTR to proper flood has recently been installed on the south boundary of the property. Access to the well is off Erwin Road via a gated entrance. The remaining 16.0 +/- acres of timber floods with minimal rainfall, which can sometimes offer a secondary area for duck hunting. The land also offers excellent deer hunting throughout, with numerous places for stands. There is a natural field providing an excellent location for developing a deer food plot or dove hunting area. In addition to the private duck and deer hunting opportunities, excellent public land duck hunting is within proximity and easily accessible. The Cache River NWR is located two miles to the east with public boat access to the Cache River.

The property has a 1,456.0 +/- square-foot hunting camp delivering an excellent base for hunting the onsite or the adjacent public lands. Situated on 2.0 +/- acres, the area around the camp has ample parking and additional room for improvements. The camp offers comfortable accommodations: three bedrooms, two bathrooms, a kitchen, a living area, essential utilities, and a new heating and air system.

**The Landscape** – The property is positioned between the White and Cache Rivers and consists of 90% bottomland hardwood timber. 50.0 + /- acres are impounded forming a GTR to hold water for duck hunting and the remaining woods floods with minimal rainfall at various times. A 5.0 + /- acre natural vegetative field and a 2.0 + /- acre improvement site are located on the east portion of the property.

**Structural Improvements** – The property offers a 1,456.0 +/- square-foot onsite hunting camp serving as an excellent base for hunting onsite or the surrounding public lands. The camp has 3 bedrooms, 2 bathrooms, a kitchen, a living area, essential utilities, and a new heating and air-conditioning system. The camp house sits on 2.0 +/- acres offering plenty of parking and room for additional improvements.

**Hunting and Wildlife Resources** – The land is located between the White and Cache Rivers, an area ranked as an outstanding one of North America's most important waterfowl flyways and wintering areas for mallard ducks. The Plunkett Farm Unit of the Cache River NWR is a waterfowl sanctuary located just 1.5 +/- miles northeast of the property. This sanctuary, and the expansive acreage of managed public lands adjacent to the property are known for holding thousands of ducks during the fall and winter seasons. The property offers a 50.0 +/- acre impounded GTR with a well and flashboard water control structure to provide proper water levels for duck hunting. The GTR has three established shooting holes, with one of the holes planted in millet. The remaining timber north of the GTR provides an additional hunting ground for ducks when flooded by seasonal rainfall. In addition to the private, green-timber duck hunting opportunities the land offers, plenty of public lands are within close proximity to the property. The Cache River NWR is located only 2.5 +/- miles to the east and has boat access to the Cache River. Dagmar WMA is 7.0 +/- miles from the land, with many public points for boat or walk-in access. The property also offers exceptional whitetail deer hunting. There are several locations to place deer stands and 5.0 +/- acres are well-suited for developing a deer food plot or establishing a dove hunting field.

**Water Resources** – There is a newly installed 12-inch diesel-powered well for pumping the GTR. Two drainage sloughs enter from the northwest and north and run through the property exiting on the south.






### **SUBJECT PROPERTY - AERIAL MAP**




### **TOPOGRAPHIC MAP**


















# Devlin "Duck" Hodges


