

Surveyors Certificate

I, Gregory S. Maines, Professional Land Surveyor No. S-2729, hereby certify that under the direction of Trevor and Amanda Ostrowski, owners of said land; I have surveyed and mapped Lots 13, 14, 15 and 16, which are represented by this Certified Survey Map; that the exterior boundary of the parcel surveyed and mapped is described as follows:

A parcel of land being part of the Southeast Quarter of the Southwest Quarter, Northwest Quarter of the Southeast Quarter and Southwest Quarter of the Southeast Quarter, Section 30, Township 36 North, Range 6 East, Town of Nokomis, Oneida County, Wisconsin, being more particularly described as follows:

Commencing at the south quarter corner of said Section 30 marked by a steel nail; thence N00°01'42"W for a distance of 40.35 feet to an iron pipe on the northerly right-of-way line of County Highway "Y", the PLACE OF BEGINNING. Thence along said northerly right-of-way line, S89°58'34"W for a distance of 14.76 feet to an iron pipe; thence leaving said northerly right-of-way line, N02°41'27"W for a distance of 804.54 feet to an iron pipe; thence N04°19'56"E for a distance of 481.33 feet to the center-south sixteenth corner marked by an alloy capped iron pipe; thence along the west line of said Northwest Quarter of the Southeast Quarter, N00°44'37"W for a distance of 100.00 feet to an iron pipe; thence S89°56'09"E for a distance of 465.00 feet to an iron pipe; thence S00°44'37"E for a distance of 100.00 feet to an iron pipe on the north line of said Southwest Quarter of the Southeast Quarter; thence along said north line, S89°56'09"E for a distance of 859.31 feet to the southeast sixteenth corner marked by an alloy capped iron pipe; thence along the east line of said Southwest Quarter of the Southeast Quarter, S00°57'32"E for a distance of 1288.49 feet to an iron rod on said northerly right-of-way line of County Highway "Y"; thence along said northerly right-of-way line, N89°44'00"W for a distance of 1329.72 feet to the PLACE OF BEGINNING. Said parcel being 1,786,043 sq. ft. or 41.00 acres.

Subject to the rights of the public over the creek shown hereon.

Together with and subject to any easements, restrictions, and reservations of record or of use.

That this Certified Survey Map is a correct representation of the exterior boundary surveyed; that I have fully complied with the provisions of Chapter 236.34 of the Wisconsin Statute in surveying and mapping the same.

Notes:

1. There was significant snow cover during the time of this survey, there may have been improvements that could not be seen and therefore are not shown.
2. Wetlands shown hereon were derived from county topographic data and aerial imagery, they have not been delineated and are for reference only.
3. The filling of wetlands is prohibited unless proper permits are obtained.
4. The ordinary high water mark of the creek shown hereon has not been determined by the Wisconsin Department of Natural Resources and is therefore considered approximate and is for reference only. Any land below the ordinary high water mark is subject to the rights of the public trust as established under Article IX, Section 1, of the state constitution.


