A. Woods and wife Corda Woods to W. B. Clifton dated November 30, 1966 as shown of record in Volume 572, Page 497, Deed Records, Wood County, Texas, said lot, tract, or parcel of land being more particularly described by metes bounds as follows:

BEGINNING at a 1/2 inch iron rod set at a fence intersection at the Northeast corner of said 21.59 acre tract and said 50 acre tract and in the West line of Wood County Road No. 3878, said POINT OF BEGINNING also being the most easterly Northeast corner of a called 15 acre tract described as "Tract No. 2" in a Deed from Francis Riggs Tedder and husband Joe Tedder to Debbie L. Tedder and husband Gene C. Tedder dated August 7, 1997 as shown of record in Volume 1568, Page 762, Real Property Records, Wood County, Texas;

THENCE S 00° 10′ 00″ E along the East line of 50 acre tract and the West line of said County Road and generally along a fence, leaving said County Road and continuing along the East line of said 50 acre tract and the West line of a called 5.000 acre tract described in a Deed from W. B. Clifton to Robert L.
