ALL DISTANCES SHOWN HEREON ARE SURFACE DISTANCES TO CONVERT TO STATE PLANE DISTANCES MULTIPLY BY SCALE FACTOR OF 0.9998982. REFERENCE IS MADE TO PLAT OF EVEN DATE ACCOMPANYING THIS METES AND BOUNDS DESCRIPTION. ALL ½ INCH IRON RODS SET HEREIN ARE IDENTIFIED WITH A PLASTIC CAP STAMPED "MCHANDLER 5292".

BEGINNING at a ½ inch iron rod set for the Southwest corner of this tract of land, in a West line of said 16.663 acres, the Northwest corner of 17.51 acres, surveyed this date, and in the East right of way line of F. M. 3180, 140 foot wide right of way. This corner has a State Plane Coordinate Value of N 13,865,000.90 and E 3,284,865.56. From this corner a 5/8 inch iron rod found for the Southwest corner of said 16.663 acres, the Southwest corner of said 17.51 acres, the Northwest corner of 9.048 acres conveyed to Eagle Point Homes LLC, by Richard Dale Carmody, Executor, in deed dated February 17, 2016, and recorded in Volume 1632 at Page 433 of the Official Public Records of Chambers County, Texas, and in the East right of way line of F. M. 3180 bears South 07°09'18" West a distance of 593.79 feet.

THENCE North 07°09'18" East with the West line of this tract of land, the West line of said 16.663 acres, and the East right of way line of F. M. 3180 a distance of 46.11 feet to a ½ inch iron rod found for the Northwest corner of this tract of land, the Northwest corner of said 16.663 acres, the Southwest corner of a 2.269 acre tract of land called Parcel "B", surveyed this date, and the Southwest corner of 16.947 acres conveyed to Kathy Ann Vosloh Freeman by Kathy Ann Vosloh Freeman, Executor, in deed dated November 30, 2021, and recorded in Document No. 2021-176282 of Chambers County, Texas.

THENCE North 86°47'19" East with the North line of this tract of land, the North line of said 16.663 acres, the South line of said 2.269 acres, and the South line of said 16.947 acres a distance of 583.76 feet to a ½ inch iron rod set for the Northeast corner of this tract of land, the Southeast corner of said 2.269 acres, and in a curve in the North line of said 17.51 acres. Form this corner a ½ inch iron rod found bears North 86°47'19" East a distance of 412.95 feet.

THENCE North 07°09'18" East with the West line of this tract of land, the West line of said 16.947 acres, and the East right of way line of F. M. 3180, at a distance of 73.89 feet to a ½ inch iron rod set for the Northwest corner of this tract of land, and the Southwest corner of 13.02 acres surveyed this date. From this corner a capped iron rod found for the Northwest corner of said 16.947 acres, the Southwest corner of Lot 65 of Cotton Creek Subdivision as recorded in Volume "A" at Page 251 of the Map Records of Chambers County, Texas, and in the East right of way line of F. Along a curve to the left, having a central angle of 61°46'35", a radius of 440.00 feet, an arc length of 474.41 feet, and a chord bearing and distance of North 66°16'00" East, 451.76 feet;

Along a curve to the right, having a central angle of 48°25'14", a radius of 560.00 feet, an arc length of 473.25 feet, and a chord bearing and distance of North 59°35'20" East, 459.30 feet to a ½ inch iron rod set for the Northeast corner of this tract of land, the Southeast corner of said 13.02 acres, in the East line of said 16.947 acres, and in the West line of 30.17 acres conveyed to Eagle Point Homes LLC., by Keith D. Along a curve to the left, having a central angle of 46°15'28", a radius of 440.00 feet, an arc length of 355.23 feet, and a chord bearing and distance of South 58°30'27" West, 345.66 feet;

Along a curve to the right, having a central angle of 18°40'10", a radius of 560.00 feet, an arc length of 182.47 feet, and a chord bearing an distance of South 44°42'48" West, 181.67 feet to a ½ inch iron rod set for the Southeast corner of this tract of land, the Northeast corner of said 0.8846 of an acre, in the South line of said 16.947 acres, in the North line of said 16.663 acres, and in the North line of said 17.51 acres.
