Dear Mr. Hensley,

On December 18th, 2014 County Ranger Oscar Creech, Assistant County Ranger Seth Bauguess, and I examined your forestlands located in Wilson County, NC. Tax parcels 2667-49-4549 & 2668-42-0394 are located off of Saint Marys Church Road northeast of Kenly, NC. It is our understanding that you have requested a forest management plan to integrate the property management objectives with the requirements of the Forestry Present Use Tax Valuation Program. The enclosed management outline and map summarize our findings and recommendations that we made from our walk over the tract. The prescriptions are general in nature and are meant to point you in the right direction.

Summary of Recommendations

Area 1 (68 ÷/- acres), 20 year-old natural lobiolly pine & mixed hardwood: Commercially thin within the next 5 years (2015-2020).

Landowner Hazard-Reduction Prescribed Burning Program (optional practice): 1 year after thinning is completed.

2030-2035: Have a Consulting Forester or the NC Forest Service examine for possible harvest at age 35 to 40

Area 2 (2 +/- acres), 42 year-old natural lobiolly pine & mixed hardwood. Harvest cut when Area 1 is harvested in 2035.


