WITNESSETH in consideration of SIXTY-NINE THOUSAND NINETY (\$69,090.00)

DOLLARS in hand paid, the receipt whereof is hereby acknowledged, the said Grantors do hereby grant and convey to the said Grantee, her heirs, successors and assigns,

<u>ALL</u> those certain lots, pieces and parcels of land, lying and being situate in the Township of Laporte, County of Sullivan and Commonwealth of Pennsylvania, bounded and described as follows:

Parcel Number One:

BEGINNING at a point in the center line of a fifty (50') foot wide private right-of-way known as Pole Bridge Road, being the northwest corner of Lot 17 of this subdivision and the northeast corner of the lot herein described; thence leaving Pole Bridge Road and continuing along the common boundary line between the lot herein described and Lot 17 of this subdivision the following three (3) courses and distances: [1] South thirteen (13°) degrees, thirty-seven (37') minutes, thirty-one (31") seconds West, one hundred fifty-two and ninety-eight hundredths (152.98') feet to a point; [2] South eighteen (18°) degrees, four (04') minutes, forty-three (43") seconds West, one hundred forty-three and twenty-eight hundredths (143.28') feet to a point; [3] South forty-two (42°) degrees, four (04') minutes West, two hundred eight and twenty-nine hundredths (208.29') feet to a point; thence along line of land of Dennis McCarty, et al. the following three (3) courses and distances: [1] North eighty-seven (87°) degrees, twenty-five (25') minutes, nineteen (19") seconds West, ninety-three and fifty hundredths (93.50') feet to a point; [2] North eighty-seven (87°) degrees, twenty-five (25') minutes, nineteen (19")

two (82°) degrees forty-four (44') minutes, thirty-seven (37") seconds West, one hundred eighteen and forty-five hundredths (118.45') feet to a point; [3] North twelve (12°) degrees, twenty (20') minutes, twelve (12") seconds East, three hundred thirty-eight and twenty hundredths (338.20') feet to a point in the center line of the aforesaid Pole Bridge Road; thence continuing along the center line of Pole Bridge Road, the following three (3) courses and distances: [1] North fifty-one (51°) degrees, forty-three (43') minutes, thirty-two (32") seconds East, one hundred two and ninety-nine hundredths (102.99') feet to a point; [2] North eighty-two (82°) degrees, two (02') minutes, twenty (20") seconds East, two hundred twenty and twelve hundredths (220.12') feet to a point; [3] South eighty-five (85°) degrees, fifty-one (51') minutes, forty-one (41") seconds East, sixty (60.0') feet to a point, the point and place of beginning.

BEGINNING at a point in the center line of the fifty (50') foot right-of-way that extends westerly from the cul-de-sac at the end of Pole Bridge Road, said point being the northwest corner of Lot 18 and the southwest corner of Lot 12; thence South twelve (12°) degrees, twenty (20') minutes, twelve (12") seconds west, three hundred thirty-eight and twenty hundredths (338.20') feet along the west line of Lot 18 to a point in the center line of a fifty (50') foot right-of-way, said point being the southwest corner of Lot 18; thence along the center line of the fifty (50') foot right-of-way the following courses and distances:

1. South seventy-seven (77°) degrees, thirty-four (34') minutes, forty-five (45") seconds West, one hundred ninety-six and ten hundredths (196.10') feet to a point;

8. South thirty-three (33°) degrees, thirty-eight (38') minutes, fifty-three (53") seconds West, sixty-six and seventy-nine hundredths (66.79') feet to a point;

9. South twenty-two (22°) degrees, twenty-seven (27') minutes, twenty-eight (28") seconds West, two hundred eighty-seven and eleven hundredths (287.11') feet to a point;

10. South twenty-eight (28°) degrees, seven (07') minutes, forty-eight (48") seconds West, two hundred thirty and thirty-nine hundredths (230.39') feet to a point;

thence North fifty (50°) degrees, forty-five (45') minutes, eighteen (18") seconds West, two thousand four hundred six and ninety-four hundredths (2406.94') feet along the remaining lands of O. Kenneth Shaffer, et al., passing through an iron pin a the side of the right-of-way to an iron pin in the line of the State Forest Lands; thence North thirtyeight (38°) degrees, thirty-one (31') minutes, thirty-three (33") seconds East, one thousand one hundred forty-three and thirty-six hundredths (1143.36') feet along the line of the State Forest Lands to a found iron pin at the southwest corner of Lot 29 of this subdivision; thence South fifty-one (51°) degrees, twenty-eight (28') minutes, forty-two (42") seconds East, two thousand two hundred twenty-eight and fifty hundredths (2228.50') feet along the line of Lot 29 of this subdivision, passing through an iron pin near the side of a previously proposed right-of-way to a point; thence North seventy-one (71°) degrees, twenty-five (25') minutes, thirty-two (32") seconds East, three hundred thirty-four and thirty hundredths (334.30') feet to a point; thence North fifty-seven (57°) degrees, thirty-six (36') minutes, thirty-three (33") seconds East, one hundred twenty-six and sixty hundredths (126.60') feet to a point; thence North seventy (70°) degrees, eight (08') minutes, three (03") seconds East, one hundred thirty-one and twenty hundredths (131.20') feet to a point; thence South eighty-seven (87°) degrees, forty-eight (48') minutes, twenty-seven (27") seconds East, seventy-two and forty hundredths (72.40') feet to a point; thence North sixty-nine (69°) degrees, thirty-five (35') minutes, three (03") seconds East, sixty-four (64.00') feet to a point; thence North forty-eight (48°) degrees, thirty-seven (37') minutes, forty-eight (48") seconds East, one hundred fifty-nine and eighty hundredths (159.80') feet to an iron pin; thence North thirty-five (35°) degrees, forty-six (46') minutes, fifty-four (54") seconds East, seventy-two and ninety-one hundredths (72.91') feet to the place of beginning.

Pursuant to Sullivan County Ordinance Number 9302719 it is understood that the parcels hereinabove described are to be considered as one for tax and subdivision purposes and that no further subdivision shall occur unless prior subdivision approval is granted by the Sullivan County Planning Commission and the Municipality in which said parcel is located.

EXCEPTING AND RESERVING unto the grantors herein, their heirs and assigns, a fifty (50') foot wide right-of-way, changing to a twenty-five (25') foot wide right-of-way, along the southeastern boundary lines of the above-described lot, the center line of said right-of-way described as follows:

ALSO EXCEPTING AND RESERVING unto the grantors herein, their heirs and assigns, the right to dedicate the private road known as Pole Bridge Road adjoining the above described parcel of land on the north to the limits of the right-of-way of said private road as it is delineated on the above recited subdivision map, as a public highway, without any compensation to the grantees herein, their heirs or assigns, at the time of said dedication; also reserving the need for joinder or permission of the grantees herein, their heirs or assigns, to such act of dedication and any related actions appurtenant thereto.

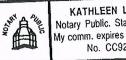
