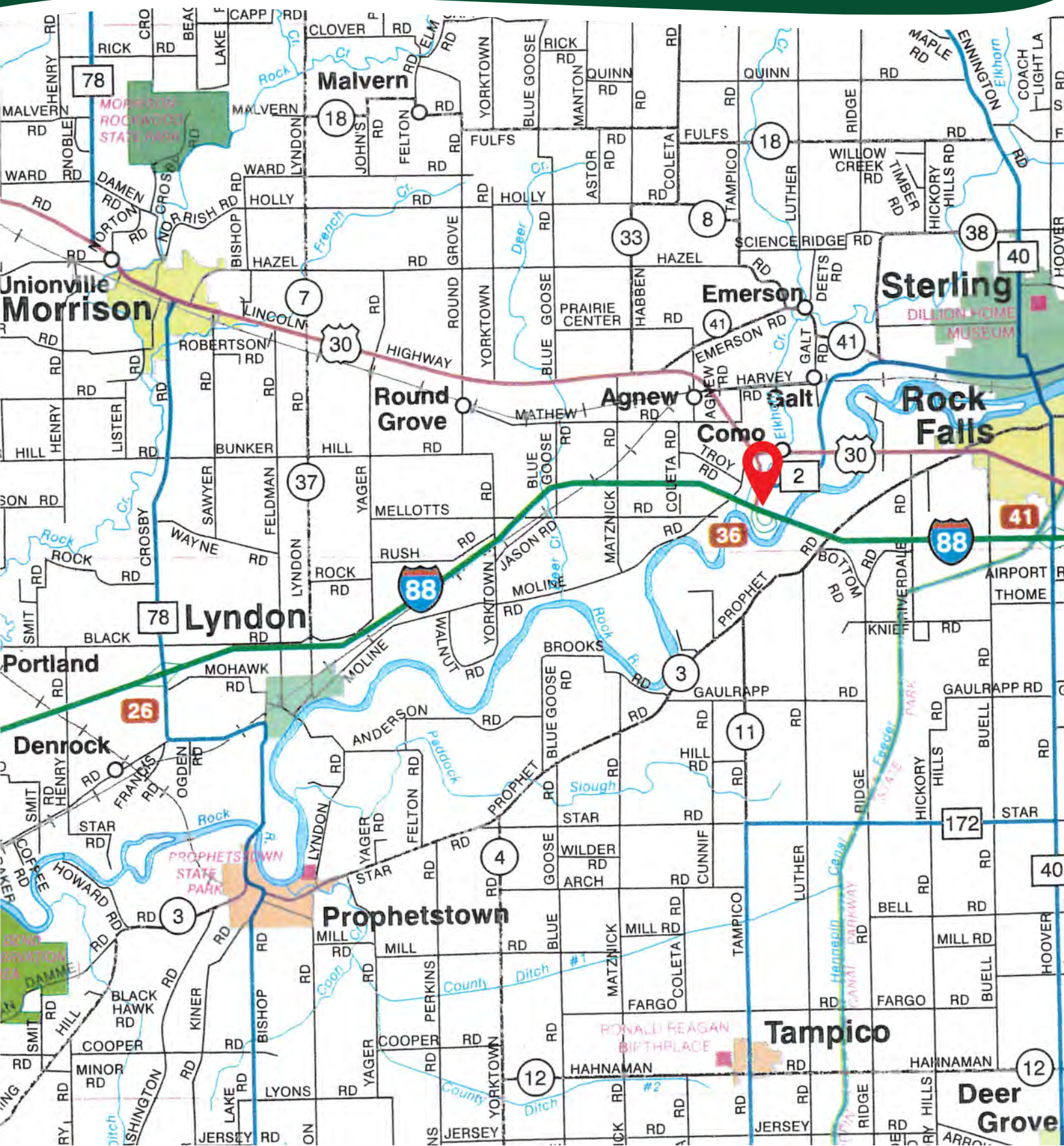
## AERIAL MAP

LOCATION	The subject farm is located approximately 97 miles west of Chicago O'Hare International Airport. Nearby cities include: Sterling (2 miles northeast), Rock Falls (3 3/8 miles east), and Morrison (8 5/8 miles northwest).
FRONTAGE	There is approximately 1/4 mile of road frontage on Interstate 88/Illinois Route 110, 1/8 mile on U.S. Route 30, and 1/16 mile on Como Road.
MAJOR HIGHWAYS	Interstate 88/Illinois Route 110 and U.S. Route 30 border the property and Illinois Route 40 is 4 1/2 miles east.
LEGAL DESCRIPTION	A brief legal description indicates The Como Interstate Farm is located in Part of the Southwest Quarter of Section 35, Township 21 North - Range 6 East (Hopkins Township), Whiteside County, Illinois.
TOTAL ACRES	There are a total of 19.41 acres, more or less, according to the Whiteside County Assessor.
TILLABLE ACRES	There are approximately 13 tillable acres according to the Whiteside County FSA.
SOIL TYPES	Major soil types found on this farm include Du Page silt loam and Ross silt loam.
TOPOGRAPHY	The topography of the subject farm is level.

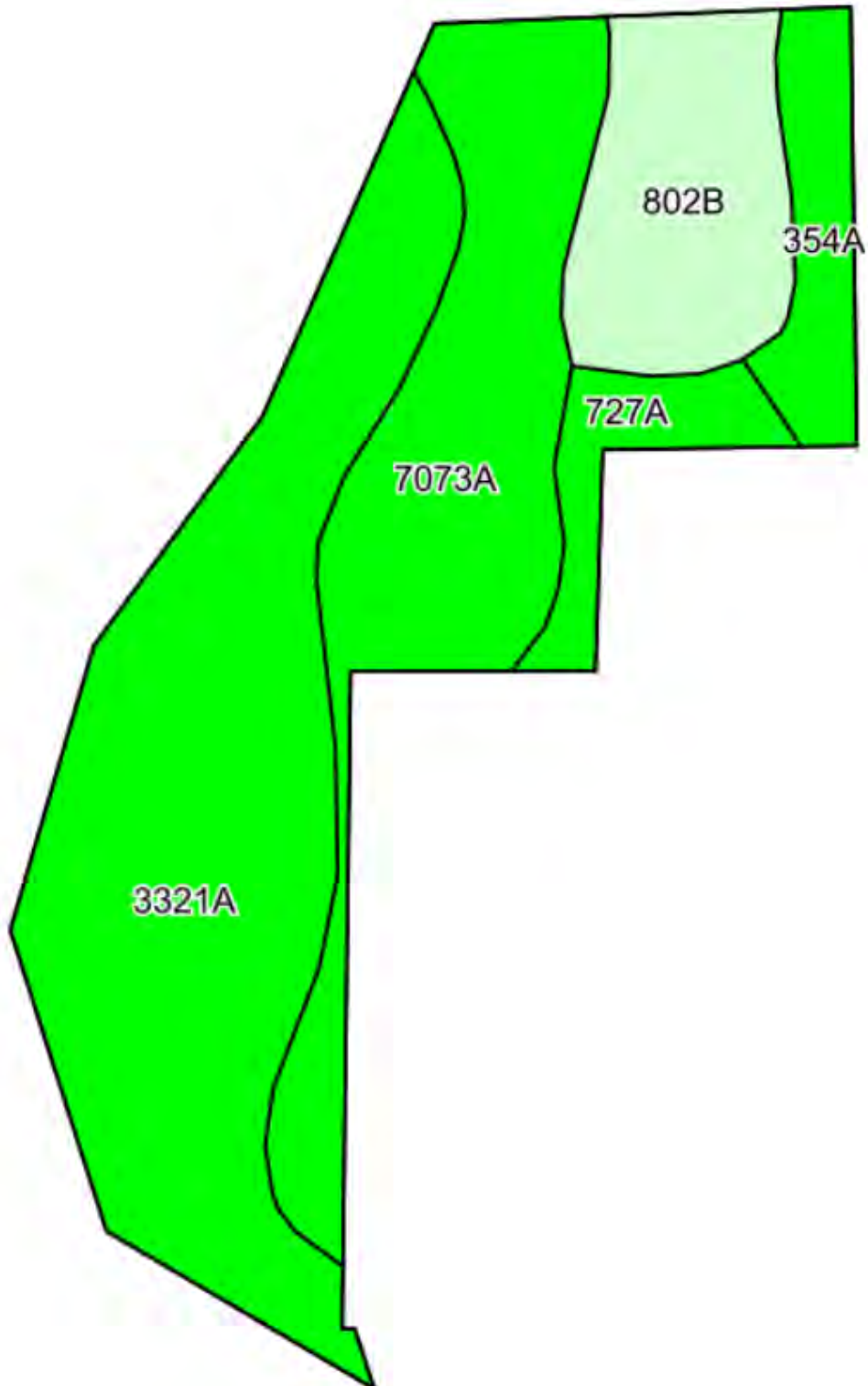
