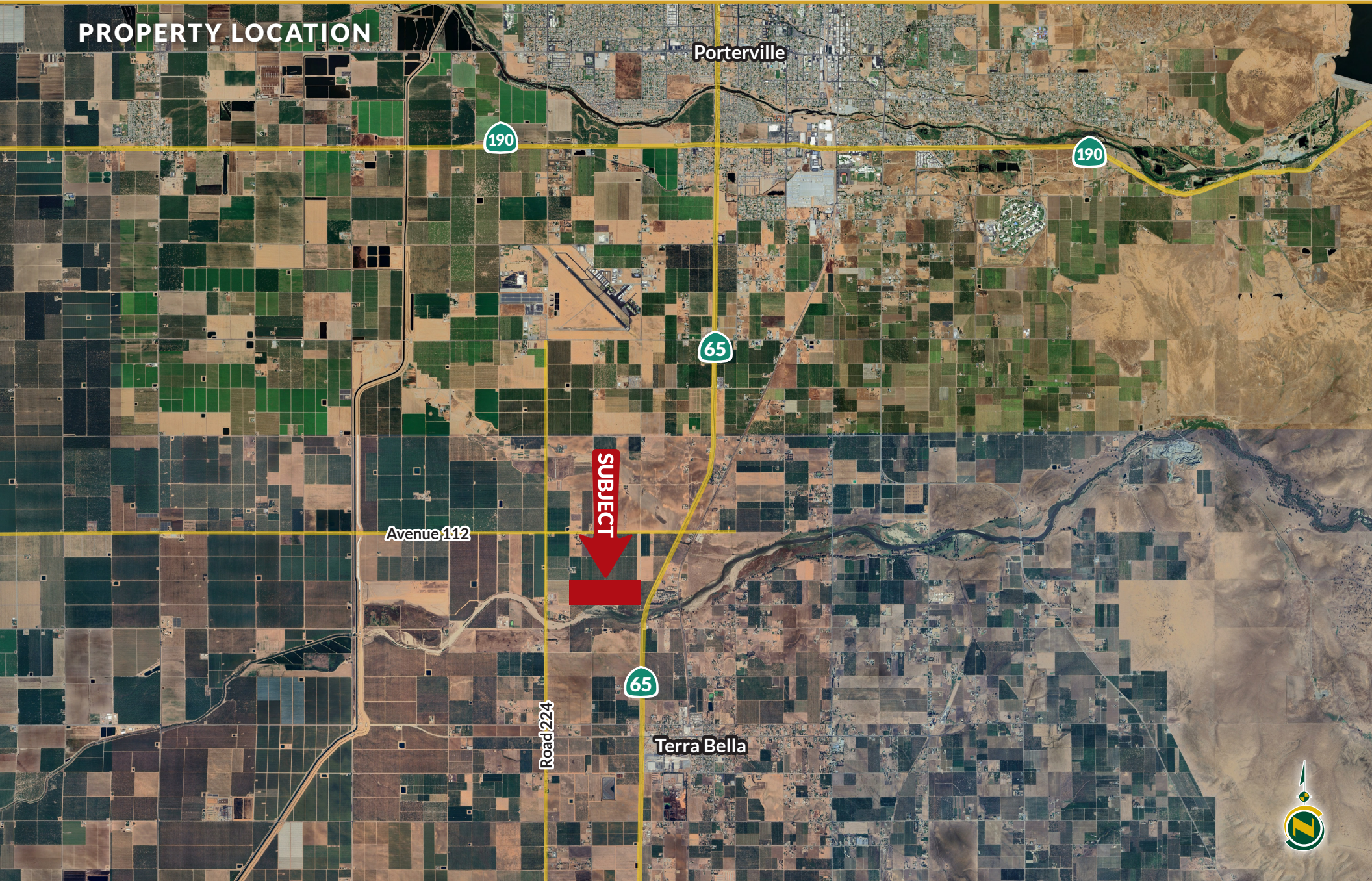

WATER

Irrigation water is provided by three Ag wells. The main well was drilled to a depth of approximately 1,200± feet deep and the two remaining wells at 700± feet deep. The wells supply water to the reservoir, which is then pumped to the irrigation system. The property is in the Eastern Tule GSA.

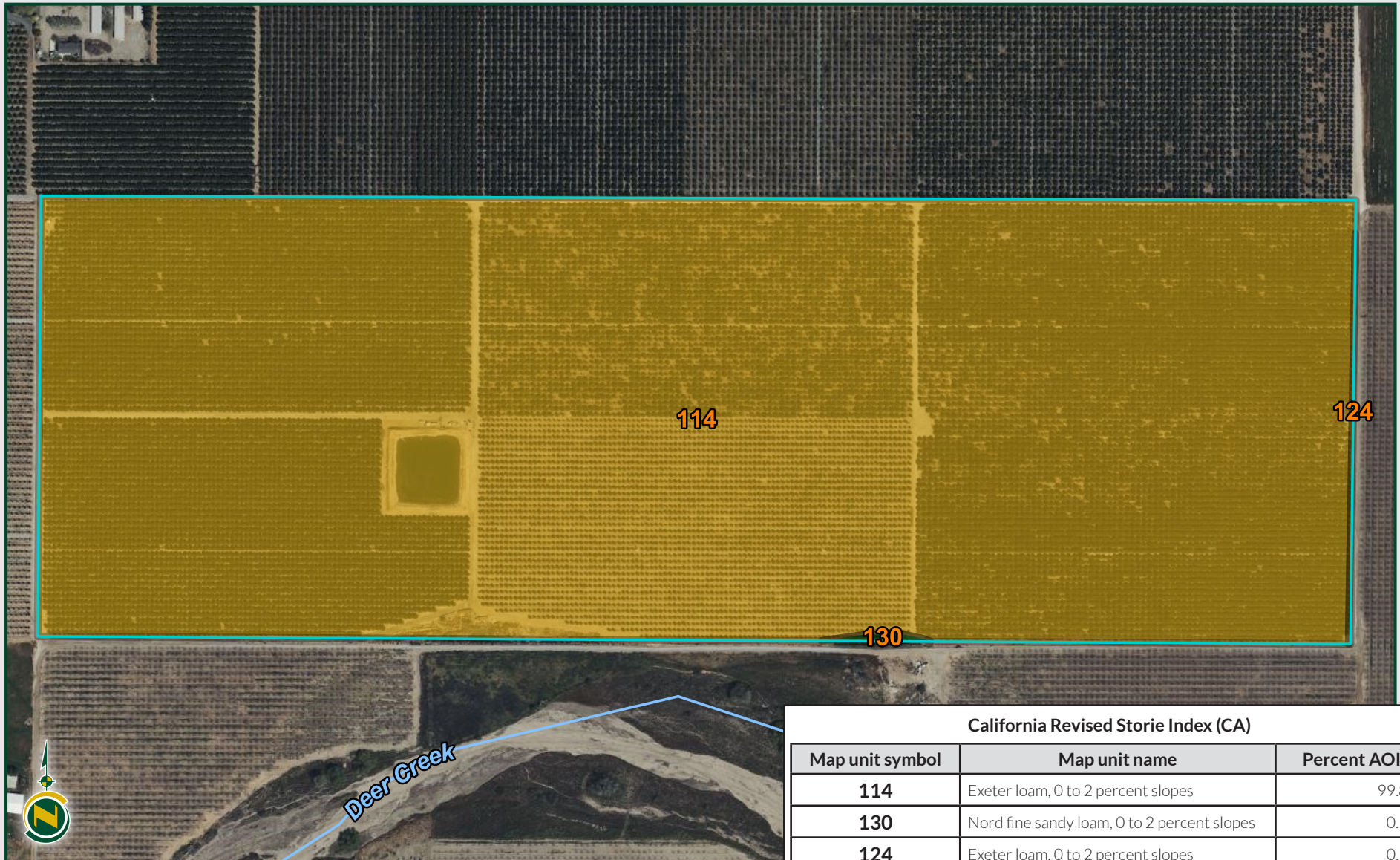

SOILS MAP



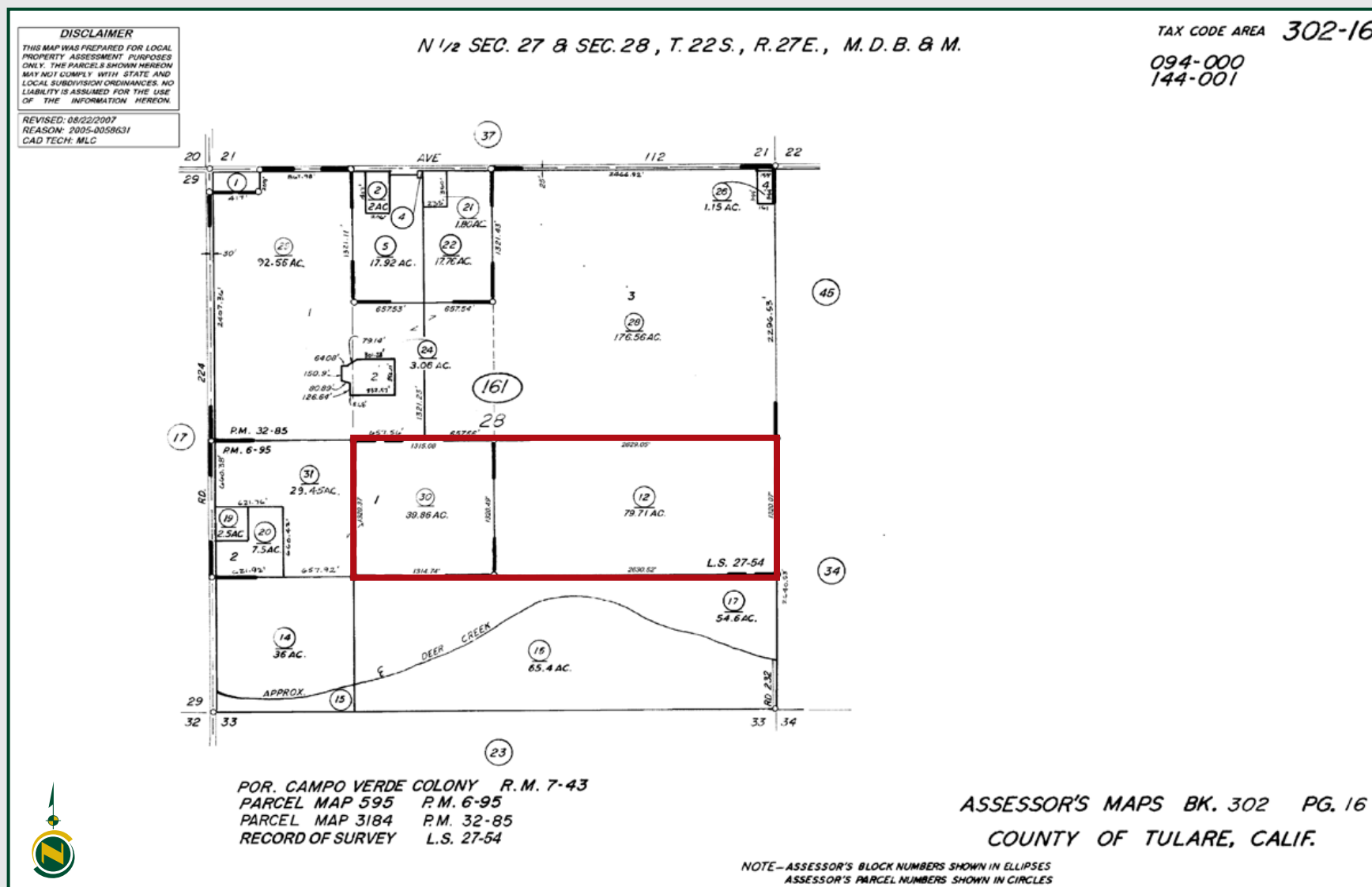
