DEED

WITNESSETH: That for and in consideration of the sum of One Dollar and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the said Grantors do hereby grant, bargain, sell, and convey, and by these presents has granted, bargained, sold, and conveyed, unto the said Grantees, as joint tenants with the right of survivorship, and not as tenants in common, in fee simple, with covenants of general warranty, all of the following described realty, together with its improvements and appurtenances, situate, lying and being in Moorefield District, Hardy County, West Virginia, and more particularly described as follows:

Lot 3-A:

All that certain lot or parcel of real estate together with all rights, rights-of-ways, improvements and appurtenances thereunto belonging, being located and situate in Moorefield District, Hardy County, West Virginia, known and being designated as Lot No. 3-A in what is known as the Subdivision of "Oakmont", containing 5.000 acres, more or less, as referenced on that certain master plat or map of said Oakmont Subdivision which is duly recorded in the Hardy County Clerk's Office in Plat Book No. 2, at pages 68 and 138.

LESS HOWEVER, the out conveyance of those two small tracts therefrom containing 13,720.68 square feet and 1.014 acres, more or less, respectively, made by the Grantors herein recorded in Deed Book 244, at page 277.

Lot 4-A:

All that certain tract or parcel of real estate situate and lying on the south side of West Virginia State Route 55, about four miles east of the Town of Moorefield, in Moorefield District, Hardy County, West Virginia containing 22.222 acres, and being designated as Lot No. 4-A of the Subdivision of "Oakmont" on a plat or map of said subdivision made by David O. Heishman, Licensed Land Surveyor No. 536, which is of record in the Office of the Clerk of the County Commission

of Hardy County, West Virginia, in Plat Book No. 2, at page 69. (includes Lot 5A)

AND BEING the same real estate conveyed to Grantors by Deeds recorded in the aforesaid Clerk's office in Deed Book 238 at page 582; and in Deed Book 280 at page 468.

This conveyance is made subject to and together with agreements, covenants, conditions, easements, rights, rights-of-way and restrictions of record.

It is the intention of this conveyance to vest title in Jeffrey W. Spickler and Margaret Denise Spickler, as joint tenants with the right of survivorship, so that upon the death of either, the interest of such decedent shall pass to the survivor by operation of law.
