

METES AND BOUNDS DESCRIPTION:

BEING a tract of land in the J.M. Espinoza Survey, Abstract No. 227, Erath County, Texas, and being all of that tract of land described in the deed to Maegan Gayle Barnes, as recorded in Document No. 2024-03497, Official Public Records, Erath County, Texas (OPRECT), and being more particularly described by metes and bounds as follows: (Basis of bearing being U.S. State Plane Grid - Texas North Central Zone (4202) NAD83 as established using the AllTerra RTKNet Cooperative Network. Reference frame is NAD83(2011) Epoch 2010.0000. Distances shown are U.S. Survey feet displayed in surface values).

BEGINNING at a 3 inch pipe fence corner post in the north line of the J.M. Espinoza Survey, Abstract No. 227 and the south line of the T. Stubblefield Survey, Abstract No. 684, for the northwest corner of said Barnes tract and the northeast corner of a called 230.86 acre tract of land described in the deed to Lance Kirlin Griswold, et al, as recorded in Document No. 2018-00606, OPRECT, also being in the south line of a tract of land described in the deed to BBR Ranch, LLC, as recorded in Volume 1341, Page 607, OPRECT;

THENCE South 89°59'06" East, with the north line of said Barnes tract and generally along a wire fence, a distance of 1,206.14 feet to a 2 inch pipe fence corner post for the southwest corner of a called 5.51 acre tract of land described in the deed to Stacy Kelleher, as recorded in Volume 1295, Page 985, OPRECT;

THENCE South 89°34°25' East, continuing with the north line of said Barnes tract and generally along a wire fence, a distance of 82.02 feet to a 1/2 inch capped iron rod found marked "RPLS 1983" in the northern line of F.M. 1188 for the northeast corner of said Barnes tract;

THENCE with the northern line of F.M. 1188 and a curve to the left, with a radius of 1,482.39 feet and a chord which bears South 41°15'47" West, a distance of 1,962.32 feet; through a central angle of 82°53'11", an arc distance of 2,144.48 feet to a 5/8 inch iron rod found for the south corner of said Barnes tract and a corner of said Griswold tract:

THENCE departing the northwest line of F.M. 1188 and with the common line of said Barnes tract and said Griswold tract and generally along a wire fence, the following courses and distances:

North 01°11'39" West, a distance of 223.93 feet to a 3 inch cedar fence corner post found;

North 00°29'22" East, a distance of 1,252 15 feet to the POINT OF BEGINNING and containing 10.467 Acres of Land.
