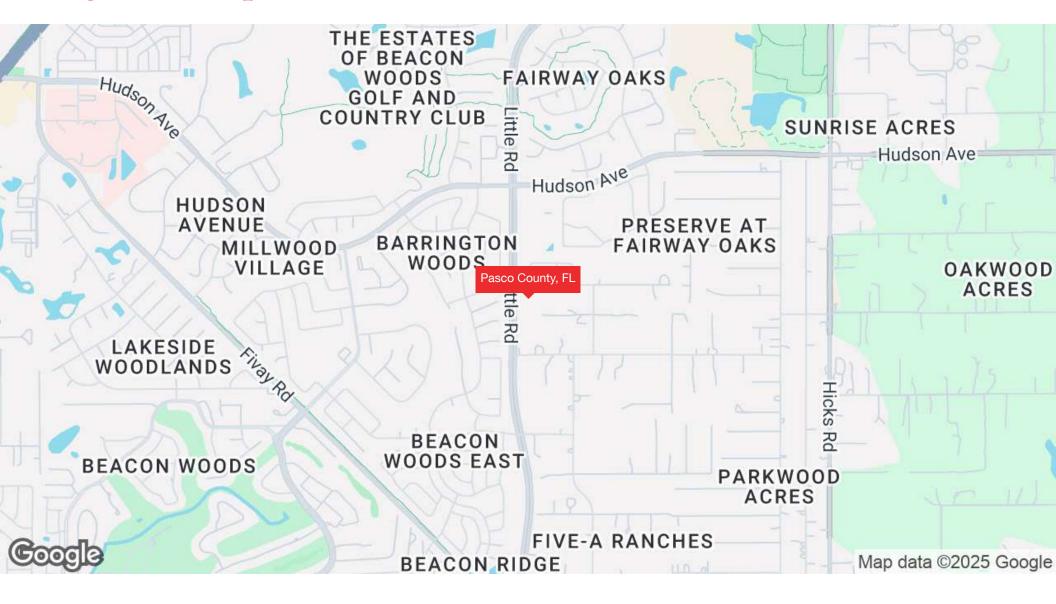


Location Map





Regional Map

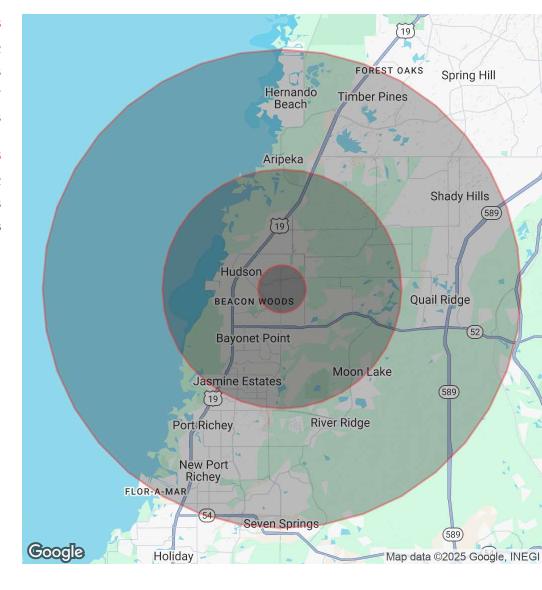
