



PROPERTY DETAILS

LOCATION	The subject farm is located approximately 60 miles west of Chicago O'Hare International Airport and is within the <u>City of Rochelle</u> . Nearby cities include: DeKalb (13 3/4 miles west), Rockford (17 miles north), and Byron (17 miles northwest).
FRONTAGE	There is approximately 1/4 mile of road frontage on Veterans Parkway.
MAJOR HIGHHWAYS	Illinois Route 251 is 1/4 mile west, Interstate 88 is 5/16 mile south, Interstate 39 is 1 7/8 miles east, Illinois Route 38 is 1 miles northwest. Rochelle is at the intersection of Interstates I-39 Logistics and Distribution Corridor and the I-88 Research and Development Corridor.
RAIL	The City of Rochelle Industrial Railroad (CIR) has been the catalyst for economic development for the City of Rochelle for more than 30 years. The continuous expansion of the rail system has allowed rail-served industries to cut cost and increase efficiency in shipping and receiving operations due to the dual interchanges with Union Pacific and Burlington Northern Santa Fe Railroads. The CIR was strategically established and located on the growth edge of Chicago's westward commercial frontier to meet the demand of industries looking to locate outside the capacity-constrained Chicago area.










ZONING MAP
