## FIELD NOTE DESCRIPTION 18.281 ACRES IN THE GEORGE G. OLIVER SURVEY, ABSTRACT NUMBER 800, HOUSTON COUNTY, TEXAS

BEING a 18.281 acre tract of land situated in the George G. Oliver Survey, Abstract Number 800, Houston County, Texas, being a portion of the remainder of that certain called 200.92 acre tract described in instrument to East Texas Hunting Lands, LLC, recorded in Volume 2020, Page 1743 of the Official Public Records of Houston County, Texas (O.P.R.H.C.T.), said 18.281 acre tract being more particularly described by metes and bounds as follows:

BEGINNING at a ½ inch iron rod found in the approximate centerline of Brent Cemetery Road, the easterly south line of said 200.92 acre tract for the common northerly corner of the certain called 4.799 acre tract described in instrument to Nancy Lee Hoch, recorded in Volume 2000, Page 1220, O.P.R.H.C.T., and that certain called 4.799 acre tract described in instrument to Jimmy L. Pate and Billie J. Pate, recorded in Volume 2019, Page 336, O.P.R.H.C.T., being the easterly southeast corner of the herein described 18.281 acre tract, from which a 2 inch iron pipe found for the easterly southeast corner of said 200.92 acre tract bears North 86°59'39" East, 862.21 feet;

THENCE South 86°59'39" West, 47.09 feet, with the common line between said 200.92 acre tract and said Hoch tract, to a ½ inch iron pipe found for a common corner of same, being an interior corner of the herein described 18.281 acre tract;

THENCE South 05°00'57" East, 926.61 feet, continuing with said common line, to a 1 inch iron pipe found in the apparent common line of said Oliver Survey and the McKinney and Williams Survey, Abstract No. 767, the common line between said 200.92 acre tract and that certain tract shown to be owned by the U.S. Government Forest, per Houston County Appraisal District (H.C.A.D.) ID No. 15657, being the common southerly corner of said 200.92 acre tract and said Hoch 4.799 acre tract, being the southeasterly corner of the herein described 18.281 acre tract;

THENCE South 88°22'30" West, 757.09 feet, along the apparent northerly line of said McKinney and Williams Survey, and the E.L. Beard Survey, Abstract No. 228, with the northerly line of said U.S. Government Forest tract per H.C.A.D. 15657 and that certain tract shown to owned by the U.S. Government Forest, per H.C.A.D. ID No. 15662, common to apparent southerly line of said Oliver Survey, the southerly line of said 200.92 acre tract, to a ½ inch iron rod with cap stamped "TPS 100834-00" set for the southwesterly corner of the herein described 18.281 acre tract, from which a 5/8 inch iron rod with 3 inch disk found for reference bears South 88°22'30" West, 1,167.31 feet;

THENCE North 01°48'29" West, 1,169.06 feet, severing over and across said 200.92 acre tract, at a distance of 1,144.06 feet, pass a ½ inch iron rod with cap stamped "TPS 100834-00" set for reference, in all, a total distance of 1,169.06 feet to a ½ inch iron rod with cap stamped "TPS 100834-00" set in the approximate centerline of said Brent Cemetery Road, for the northwesterly corner of the herein described 18.281 acre tract;

THENCE continuing across said 200.92 acre tract, along the approximate centerline of said Brent Cemetery Road, the following thirteen (13) courses and distances:

- 2) North 72°24'22" East, 107.53 feet, to a point for corner;
- 3) North 79°56'43" East, 111.12 feet, to a point for corner;
