THIS INDENTURE made this 1st day of December, 2023, between Wildcat Timber II, LLC, a Delaware Limited Liability Company as party or parties of the first part, hereinafter called Grantor, and Chatchai Natakustong, Kotchakorn Natakustong and Chalita Natakustong as joint tenants with survivorship and not as tenants in common as parties of the second part, hereinafter called Grantees (the words "Grantor" and "Grantees" to include their respective heirs, successors and assigns where the context requires or permits).

WITNESSETH that: Grantor, for and in consideration of the sum of TEN AND NO/100 DOLLARS (\$10.00) and other good and valuable considerations in hand paid, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, aliened, conveyed and confirmed, and by these presents does grant, bargain, sell, alien, convey and confirm unto the said Grantee.

All that tract or parcel of land lying and being in Land Lots 61, 62, 82, 83, 84, 98, and 99 of the 24th District, 2nd Section of Gilmer County, Georgia, and being designated as Lot 290 of Creekside Crossings, Phase 8, containing 3.56 acres, more or less, and being more particularly described on plat of survey prepared by Jeffrey T. Vick, G.R.L.S. #3278, dated October 13, 2023, revised November 14, 2023, and recorded in Plat Book 72, Page 185, Gilmer County, Georgia Records. Said plat is incorporated herein by reference for a more complete legal description.

This conveyance is subject to the Declaration of Covenants, Conditions, Restrictions and Easements for Creekside Crossing, dated August 26, 2021, and recorded on August 31, 2021, in Deed Book 2420, Pages 1-52, Gilmer County, Georgia Records; as modified and/or amended per those instruments recorded in Deed Book 2542, Pages 222-233; Deed Book 2547, Pages 189-196; and Deed Book 2567, Pages 138-145, said records; as further supplemented and/or amended of record.

This Deed is given subject to all easements and restrictions of record.

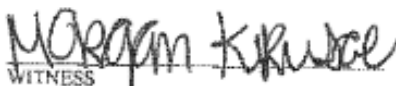
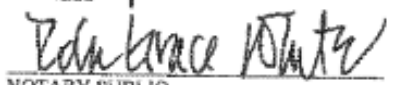
TO HAVE AND TO HOLD the said tract or parcel of land, together with all and singular the rights, members and appurtenances thereof, to the same being, belonging or in anywise appertaining, to the only proper use, benefit and behoove of the said Grantees, as joint tenants and not as tenants in common, for and during their joint lives, and upon the death of either of them, then to the survivor of them in FEE SIMPLE, together with every contingent remainder and right of reversion, and to the heirs and assigns of said survivor.

THIS CONVEYANCE is made pursuant to Official Code of Georgia Section 44-6-190, and it is the intention of the parties hereto to hereby create in Grantees a joint tenancy estate with the right of survivorship and not as tenants in common.

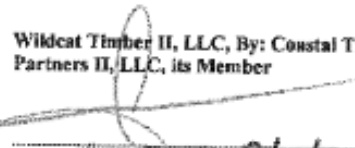
AND THE SAID Grantor will warrant and forever defend the right and title to the above described property unto the said Grantee against the claims of all persons by, through and under the above named Grantor.
