All that certain 211.91 acre tract of land in the Mary F. Breedlove Survey, A – 52, in Coryell County, Texas, being all of that certain 101 1/3 acre tract one, 86 acre tract two, 24 acre tract three described in deed from Oad Painter, et ux to O.D. Nichols, et ux, dated December 6. 1945, and recorded in volume 153, page 595 of the official public records of Coryell County, Texas, and including a 300x600 yard tract included within the said 86 and 101 acre tract described in deed from O.D. Nichols to Jimme Nichols, dated July 12, 1979, and recorded in volume 358, page 743 of the official public records of Coryell County, Texas, and a 3.35 acre tract called to be a part of the said 101 1/3 acre tract described in deed from Odean Nichols to Jim Allen Nichols, dated June 26, 1990, and recorded in volume 491, page 412 of the official public records of Coryell County, Texas, and a tract located north of Bertong Branch, south of the 86 acre tract and west of the 101 1/3 acre tract that is not included within the said Nichols tracts nor within the tract lying south of Bertong Branch, but occupied with the Nichols tracts, and described as follows:

Beginning at a 3/8" iron rod found at the northeast corner of the said 101 1/3 acre tract, the southeast corner of a 38.764 acre tract described in deed from Barbara Oldham to Ronald C. Elza, et ux, dated March 21, 2005, and recorded in document number 180494 of the official public records of Coryell County, Texas, at the northeast corner of a 25' road easement, and in the west line of Coryell County Road No. 213, for the northeast corner of this tract;

Thence S 18°27'12" W, along the west line of the said county road, 1356.60' to a capped 3/8" iron rod set at an ell corner of the said 101 1/3 acre tract, a southwest corner of the said county road, for a corner of this tract;

Thence S 74°12'37" E, along the south line of the said county road, 959.49' to a capped 3/8" iron rod set at the northeast corner of the said 24 acre tract three, the northwest corner of a 193.91 acre tract described in deed from Arthur W. Walsh, et ux to Larry Davis, et ux, dated June 20, 1996, and recorded in document number 97967 of the official public records of Coryell County, Texas, for the most easterly northeast corner of this tract;

Thence along the west line of the said 193.91 acre tract as follows;

S 14°48'22" W, 1310.71' to a spike set in a 14" cedar tree;

S 05°50'30" E, 45.45' to a spike set in a 24" cedar tree;

And S 14°43'33" W, along a fence, at 794.53' pass a spike set at a fence post, continuing a total distance of 888.98' to the southeast corner of the said 24 acre tract three, the southwest corner of the said 193.91 acre tract, and in the north line of a former 618.60 acre tract described in deed to

Don Jake Saunders, recorded in volume 184, page 100 of the official public records of Coryell County, Texas, and on the north bank of Bertong Branch, for the southeast corner of this tract;

Thence along the north bank of Bertong Branch and the north line of the said 618.60 acre tract, as follows:

And N 68°22'29" W, 67.52' to the intersection of the south line of the said 86 acre tract with the north bank of Bertong Branch, for a corner of this tract;

Thence N 72°32'57" W, along the south line of the said 86 acre tract, at 103.52' pass a 2" pipe post at the beginning of a fence, continuing a total distance of 520.75' to a capped 3/8" iron rod set for the southwest corner of the said 86 acre tract, for the southwest corner of this tract;

Thence N 16°42'53" E, along the west line of the said 86 acre tract, at 666.80' pass a spike found at a fence corner post at a corner of a 313.57 acre tract described in deed from Mono Pruitt, Jr. to Larry Pruitt, et ux, dated March 14, 2001, and recorded in document number 139482 of the official public records of Coryell County, Texas, continuing along a fence and the west line of the said 86 and 101 1/3 acre tract, a total distance of 3006.36' to a capped 3/8" iron rod set at a fence corner post at the northeast corner of the said 313.57 acre tract, the southeast corner of a 67.01

acre tract described in deed to the Danny K. Pruitt Trust, recorded in document number 276568 of the official public records of Coryell County, Texas, for a corner of this tract;

Thence N 17°00'19" E, along a fence, 301.26' to a capped 3/8" iron rod set at the southwest corner of a 1.00 acre tract described in deed from Coy Carter, Jr. to Charles C. Davis, dated February 15, 2008, and recorded in document number 214987 of the official public records of Coryell County, Texas, for a northwest corner of this tract;

Thence S 73°22'32" E, along the south line of the said 1.00 acre tract, 208.70' to a capped 3/8" iron rod set for the southeast corner of the said 1.00 acre tract;

Thence N 16°38'18" E, along the east line of the said 1.00 acre tract, 208.70' to a capped 3/8" iron rod set in the north line of the said 101 1/3 acre tract, at the northeast corner of the said 1.00 acre tract and in the south line of the said 38.764 acre tract, for the northwest corner of this tract;

Thence S 73°23'52" E, along a fence and the north line of the said 101 1/3 acre tract, 1589.05' to the point of beginning and containing 211.91 acres of land.
