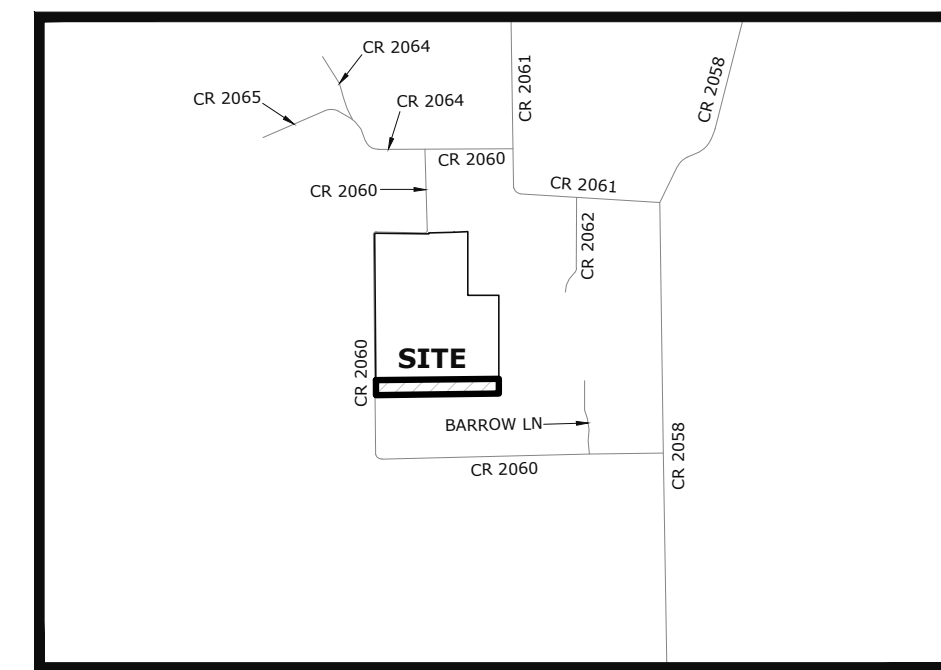
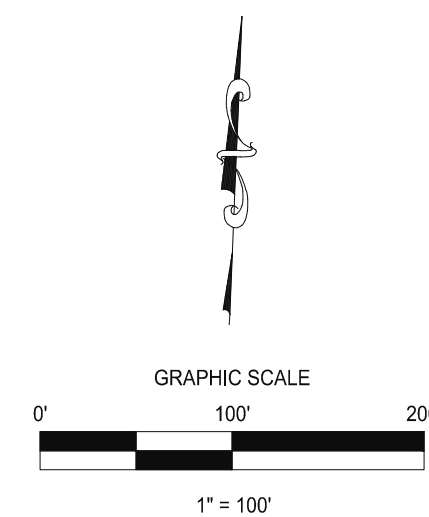




VICINITY MAP

LEGAL DESCRIPTION
10.001 ACRES

BEING all that certain tract of land situated in the J. Young Survey, Abstract No. 126, Liberty County, Texas, and being a portion of a called 58.099 acre tract of land, described in deed to Sebron B. Williams and wife, Mary Jo Williams, recorded in Volume 652, Page 716, Deed Records of Liberty County, Texas, and a portion of a called 40.1959 acre tract of land described in deed to Sebron B. Williams, recorded in Volume 1954, Page 585, Deed Records of Liberty County, Texas as described in Volume 721, Page 338, said Deed Records and being more particularly described by metes and bounds as follows:

BEGINNING at 1/2-iron rod with a cap stamped "RPLS 6677" found at the southwest corner of said 58.099 acre tract and in the east right-of-way line of County Road 2060 (a public right-of-way);

THENCE North 02° 51' 32" West, with the west line of said 58.099 acre tract and the east right-of-way line of County Road 2060, a distance of 232.99 feet to a 1/2-iron rod with a cap stamped "RPLS 6677" set (hereinafter referred to as capped iron rod set) for the northwest corner of the herein described tract;

THENCE North 87° 08' 28" East, over and across said 58.099 acre tract and said 40.1959 acre tract, a distance of 1900.30 feet to a capped iron rod set in the east line of said 40.1959 acre tract and in the west line of a called 6.145 acre tract of land described in deed to John H. Santana and Mollie Ann Santana, recorded in Volume 1958, Page 417, Official Public Records of Liberty County, Texas;

THENCE South 02° 27' 34" East, with the east line of said 40.1959 acre tract and the west line of said 6.145 acre tract, a distance of 226.03 feet to a Sucker Rod found at the southeast corner of said 40.1959 acre tract and at the southwest corner of said 6.145 acre tract;

THENCE South 86° 56' 49" West, with the south line of said 40.1959 acre tract, a distance of 1151.56 feet to a 1/2-iron rod with a cap stamped "RPLS 6677" found at the southwest corner of said 40.1959 acre tract and the southeast corner of said 58.099 acre tract;

THENCE South 86° 54' 21" West, with the south line of said 58.099 acre tract, a distance of 747.17 feet to the POINT OF BEGINNING and enclosing 10.001 acres (435,637 square feet) of land, more or less.

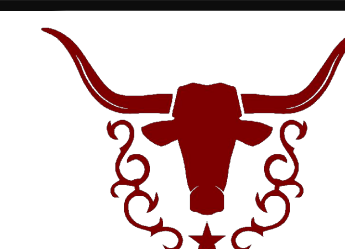
