Narrative Description of Waters/72.7 Acres

Location:


The 72.7-acre project site is located adjacent to and west of U.S. Highway 278/S.C. Highway 462 about ½ mile north of SSR 54 in Jasper County, South Carolina. An approximate location for aerial interpretation is: Latitude 32N23'50", Longitude – 80W54'45".

Conditions:

The site was investigated during the week of May 21, 2001. Conditions were clear, hot, and humid. The site was investigated during a prolonged dry period. The soils in most wetland areas were dry in the first 12". Soil samplings were moistened prior to assessment. Soil color, texture and secondary indicators were assessed as a primary factor, with available vegetation observed as a secondary indicator.

Overview of Site:

The project site is trapezoidal in configuration, with about 800 feet of frontage along U.S. Highway 278. The site extends westward some 4,000 feet to the right-of-way of an abandoned railroad bed. The highest topography on site appears to be along the highway, which slopes into a wetland area (A-B-C-D-E) that transects the tract in a north/south direction. Areas within the hill, as well as along the historic wetland have been shallowly excavated for fill materials. Disturbed areas on the hill did not exhibit wetland characteristics and were not delineated. Disturbed areas adjacent to the historic wetland exhibit wetland characteristics and were included in the delineation as jurisdictional. The topography of the site westward of the A-B-C-D-E wetland is generally flat, with soils that exhibit heavier texture than those near Highway 278. A narrow, cypress bottom, wetland extends across the tract, about 3,000 feet west of Highway 278. This wetland is bounded to the east by a major functional ditch that has apparently been in place for many years. The western boundary has been delineated as G1-G18. Wetland H lies along the western-most boundary and appears to continue off-site to the north. A portion of a larger system lies along Highway 278 and was delineated as wetland J. Two areas were delineated as completely isolated wetlands within the project boundaries. Nonjurisdictional wetland I is located just east of wetland H. Non-jurisdictional wetland F is located just west of wetland A-B-C-D-E. Jurisdictional wetlands extend beyond the site boundaries and appear to be connected systems.








USDA SCS SOILS MAP Jasper County, South Carolina


