THENCE SOUTH $01^{\circ}07'27''$ EAST, 1211.22 FEET TO A 3/8" STEEL ROD W/CAP IN THE SOUTH LINE OF SAID 101.40 ACRES, SET FOR THE SOUTHEAST CORNER OF THIS TRACT AND THE SOUTHWEST CORNER OF SAID TRACT 8;

THENCE SOUTH 85°41'40" WEST, 361.20 FEET TO A 3/8" STEEL ROD IN THE SOUTH LINE OF SAID 101.40 ACRES, SET FOR THE SOUTHWEST CORNER OF THIS TRACT AND THE SOUTHEAST CORNER OF SAID TRACT 6;
