Properties, Blanco County, Texas. 10.100 acre Tract 55, Blanco North

Being 10.100 acres of land out of the G.C. & S.F. Railroad Co. FROM an iron pin and corner post set for the Easternmost Southeast corner of the above described Glenn H. Kothmann tract, THENCE with the fence, the East line of the said Glenn H. Kothmann tract, N. 04° 12' 45" W. 2,767.12 feet, N. 04° 28' W. 106.74 feet, N. 04° 31' E. 2,666.11 feet and N. 16° 49' 15" W. 286.08 feet to an iron post set for the Northeast corner of 10.100 acre Tract 54, for the Southeast corner and POINT OF BEGINNING of the herein described 10.100 acre Tract 55;

THENCE with the North line of 10.100 acre Tract 54, N. 68° 26' W. 664.91 feet to an iron post in the East line of a 60.0 foot road, set for the Northwest corner of 10.100 acre Tract 54; for the Southwest corner of this tract;

THENCE with the East line of the said 60.0 foot road, N. 21° 34' W. 636.40 feet to an iron post set for the Southwest corner of 10.100 acre Tract 56, for the Northwest corner of this tract;

THENCE with the South line of 10.100 acre Tract 56, S. 68° 26' W. 717.74 feet to an iron post in the fence, the East line of the Glenn H. Kothmann tract, set for the Southeast corner of 10.100 acre Tract 56, for the Northeast corner of this tract;

THENCE with the fence, the East line of the said Glenn H. Kothmann tract, S. 16° 49' 15" E. 638.59 feet to the place of beginning.
