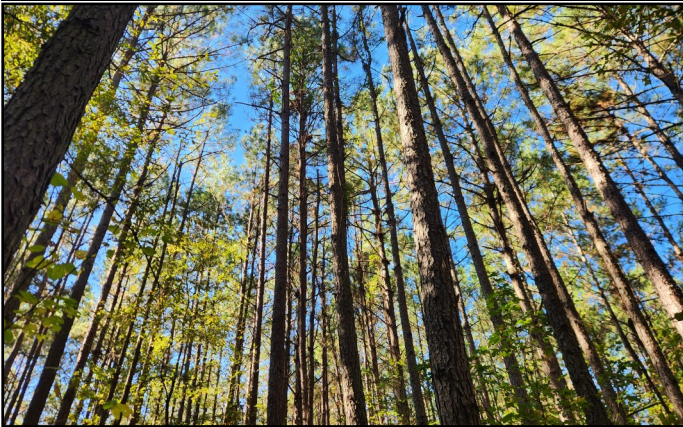

Site index for loblolly pine averages eighty (80) feet (base age 50) on Saffell-Sacul, Sawyer and fine sandy loam soils. Timber consists of $\pm$ 2001 pine stand and is ready to harvest with a mix of pine products. Tract offers opportunity for immediate timber income, hunting / recreation, and is an excellent timber investment property.

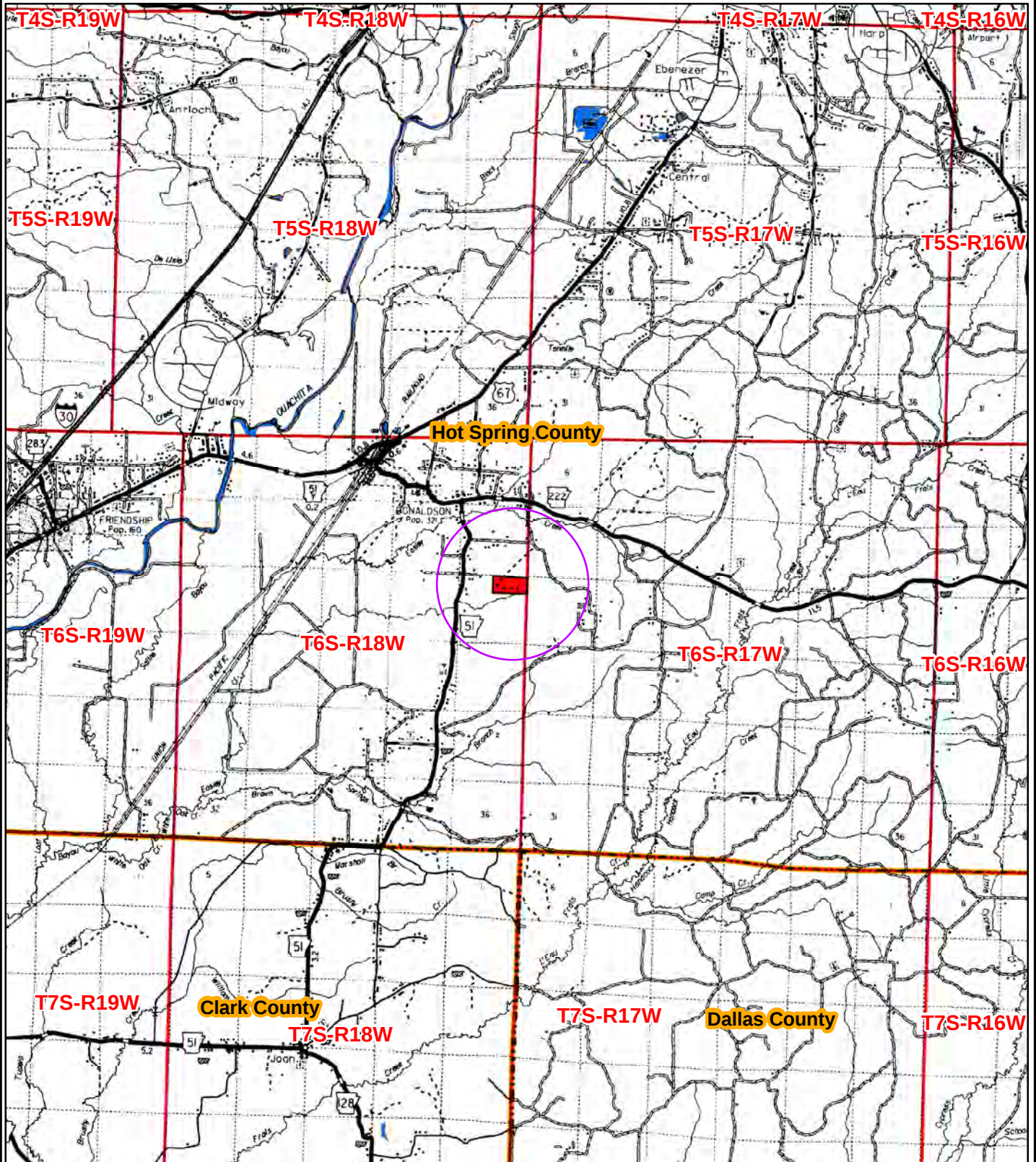

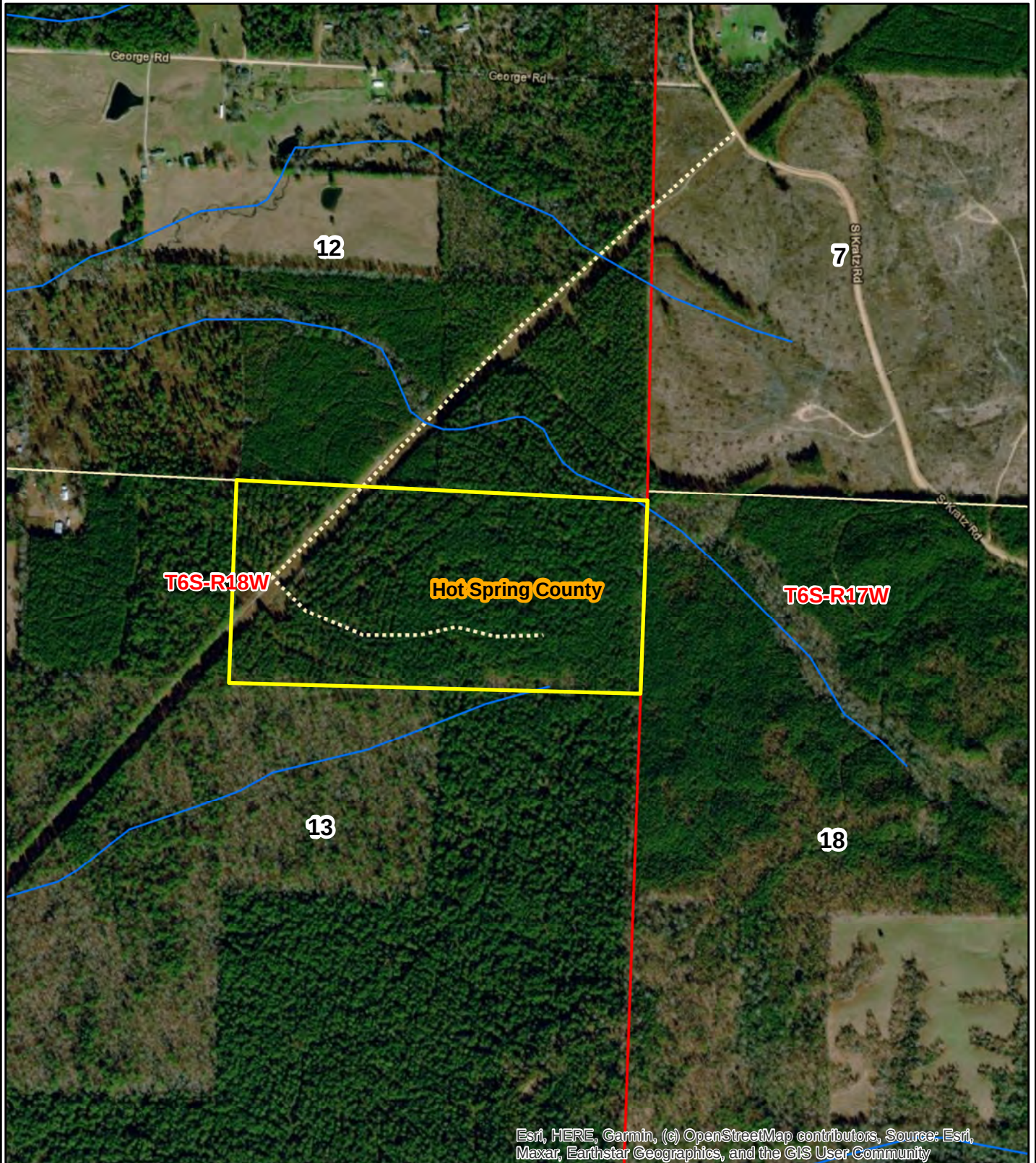

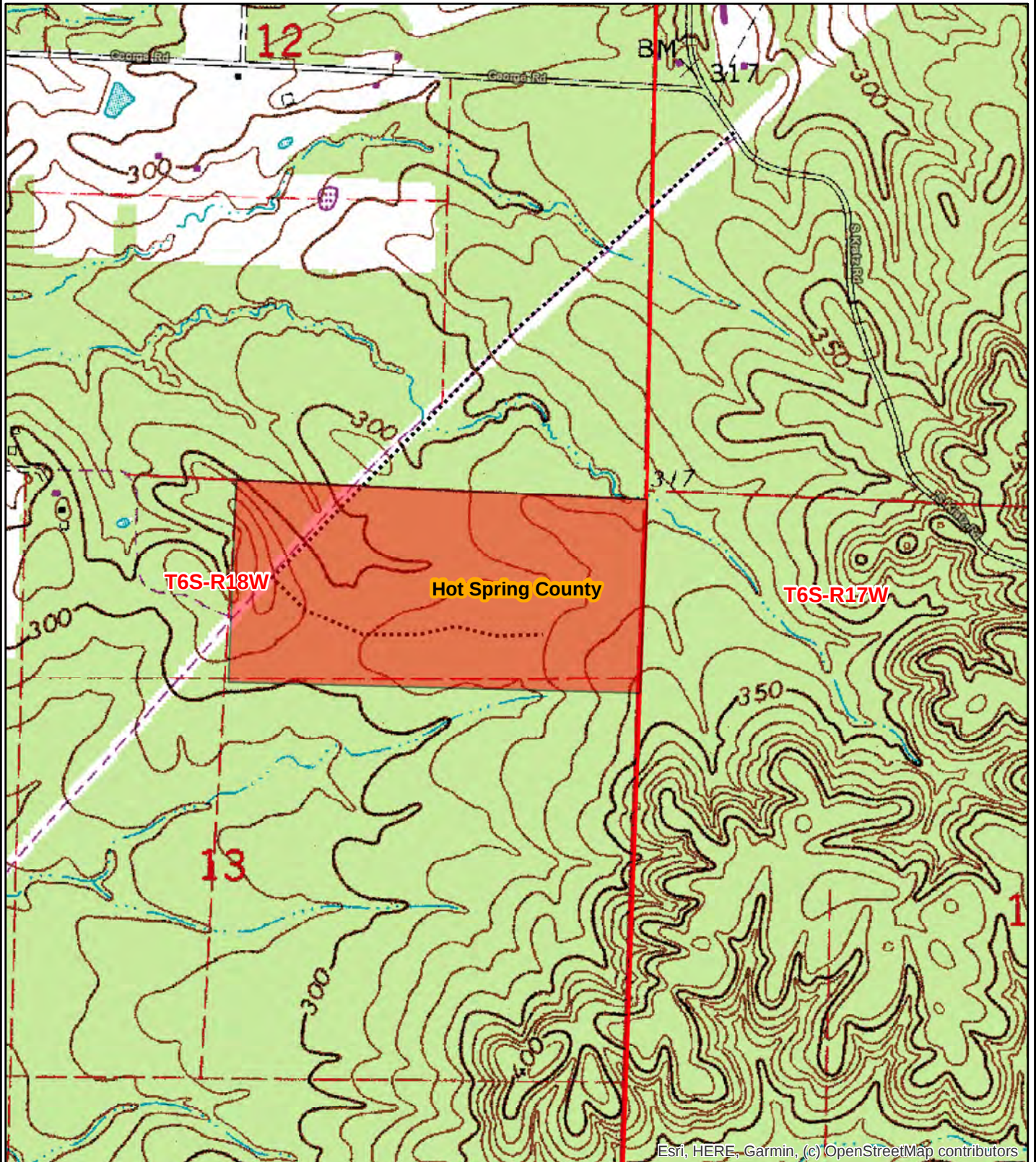
