THIS INDENTURE made this 15th day of Sept., 2023, between Wildcat Timber II, LLC, a Delaware Limited Liability Company, as party or parties of the first part, hereinafter called Grantor, and Lane Nicole McLetchie as party or parties of the second part, hereinafter called Grantee (the words "Grantor" and "Grantee" to include their respective heirs, successors and assigns where the context requires or permits).

WITNESSETH that Grantor, for and in consideration of the sum of TEN AND NO/100 DOLLARS (\$10.00) and other good and valuable considerations in hand paid, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, aliened, conveyed and confirmed, and by these presents does grant, bargain, sell, alien, convey and confirm unto the said Grantee.

All that tract or parcel of land lying and being in Land Lots 49, 60 & 85 of the 24th District, 2nd Section of Gilmer County, Georgia, and being designated as Lot 177 of Creekside Crossings, Phase 4, containing 3.96 acres, more or less, and being more particularly described on plat of survey prepared for Creekside Crossings, by Jeffrey T. Vick, GRLS #3278, dated August 26, 2022 and recorded in Plat Book 70, Page 16, Gilmer County, Georgia Records. Said plat is incorporated herein by reference for a more complete legal description.

This conveyance is subject to the Declaration of Covenants, Conditions Restrictions and Easement for Creekside Crossing, dated August 26, 2021, filed August 31, 2021 in Deed Book 2420, Page 1, Gilmer County, Georgia Records, as supplemented per that Supplemental Declaration of Covenants, Conditions and Restrictions dated August 24, 2022, and recorded in Deed Book 2542 Page 232, said records; as amended per Amendment to the Declaration of Covenants, conditions & Restrictions for Creekside Carver Hill, dated March 24, 2023 and recorded in Deed Book 1358 Page 730-741, said records; as further supplemented and/or amended of record.

This Deed is given subject to all easements and restrictions of record.

TO HAVE AND TO HOLD the said tract or parcel of land, together with all and singular the rights, members and appurtenances thereof, to the same being, belonging or in anywise appertaining, to the only proper use, benefit and behoof of the said Grantee, forever in **FREE SIMPLE**.

AND THE SAID Grantor will warrant and forever defend the right and title to the above described property unto the said Grantee against the claims of all persons by, through and under the above named Grantor.
