

EXHIBIT "A" LEGAL DESCRIPTION **43.62 ACRES**

(COUNTY OF JACK) (STATE OF TEXAS)

All that certain 43.62 acres tract or parcel of land being situated in the M. Watkins Survey, Abstract 1731 and the W. W. Wood Survey, Abstract 1445, in Jack County, Texas and being a part of a called 86.8 acres tract described in a Warranty Deed to John H. Keyser, as recorded in Vol. 200, Pg. 423 of the Deed Records of said county and said 43.62 acres tract being described by metes and bounds, as follows:

BEGINNING at a 4 inch pipe fence corner found on the east line of 4, First Tract, a called 229.87 acres tract recorded in Doc. No. 20220003122 of the Official Public Records of said county, the northwest corner of 4, Second Tract, a called 229.87 acres tract recorded in said Doc. No. 20220003122, for the southwest corner described herein (NOTE: BEARINGS AND DISTANCES ARE BASED ON U. S. STATE PLANE NAD 1983 COORDINATES, TEXAS NORTH CENTRAL ZONE - 4202);

THENCE North 00°47'54" East, along said east line, a distance of 624.07 feet to a 1/2 inch iron rebar with an aluminum cap stamped "RPLS 5210", set for the northwest corner described herein;

THENCE South 89°37'53" East, leaving said east line, a distance of 3,041.47 feet to a 1/2 inch iron rebar with an aluminum cap stamped "RPLS 5210", set in Berry Dairy Road, on the west line of 12, Tract 3, a called 480.00 acres tract record in Bk. 0910, Pg. 0445 of said Official Public Records and the line dividing said Abstract 1731 and the S. P. RR. Co. Survey No. 7, Abstract 551, a called 640 acres tract recorded in Vol. A-1, Pg. 106 of said Deed Records, for the northeast corner described herein;

THENCE South 00°11'53" West, along said road and said dividing line, a distance of 624.06 feet to a 1/2 inch iron rebar with an aluminum cap stamped "RPLS 5210", set for the northeast corner of said Second Tract and the southeast corner described herein;

THENCE North 89°37'53" West, leaving said road, said dividing line and along the north line of said Second Tract, a distance of 3,048.01 feet to the POINT OF BEGINNING and containing 43.62 acres of land, of which approximately 0.31 acre lies within said Berry Dairy Road.
