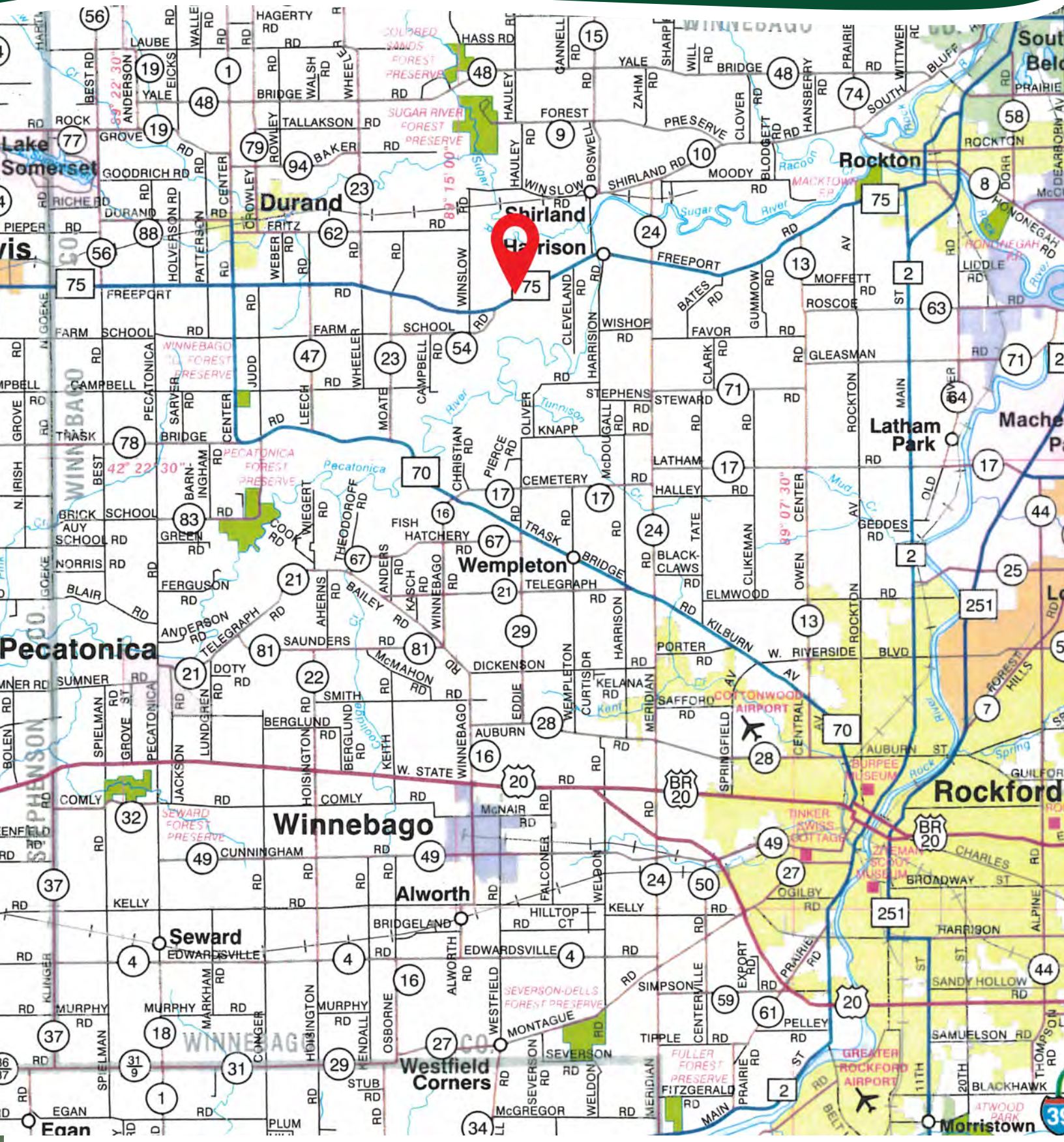
AERIAL MAP

LOCATION	The subject farm is located approximately 74 miles northwest of Chicago O'Hare International Airport. Nearby cities include: Durand (4 1/2 miles west), Rockton (6 1/4 miles northeast), and Rockford (7 3/4 miles southeast).
FRONTAGE	There is approximately 7/16 mile of road frontage on Illinois Route 75.
MAJOR HIGHWAYS	Illinois Route 75 is the south border of the property, Illinois Route 70 is 3 1/2 miles southwest, and Illinois Route 2 is 7 1/8 miles east of the property.
LEGAL DESCRIPTION	A brief legal description indicates The Route 75 Farm is located in Part of Sections 15, 16, 21, & 22, Township 28 North – Range 11 East (Harrison Township), Winnebago County, Illinois.
TOTAL ACRES	There are a total of 289.99 acres according to a recent survey.
CROPLAND ACRES	There are approximately 278.87 cropland acres according to the Winnebago County FSA, of which 20.43 acres are enrolled in CRP with an annual contract payment of \$5,064.00 through September 30, 2031.

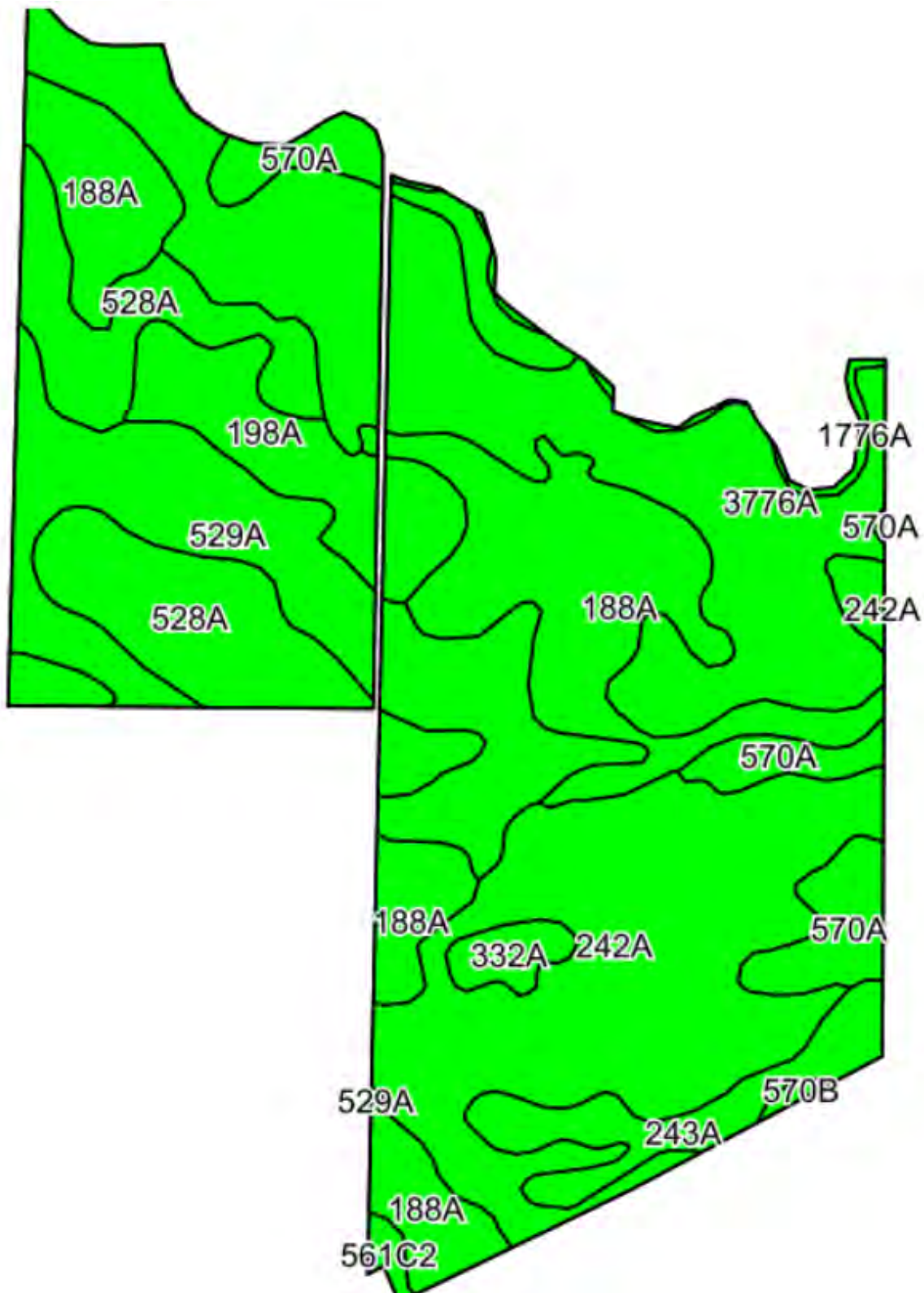

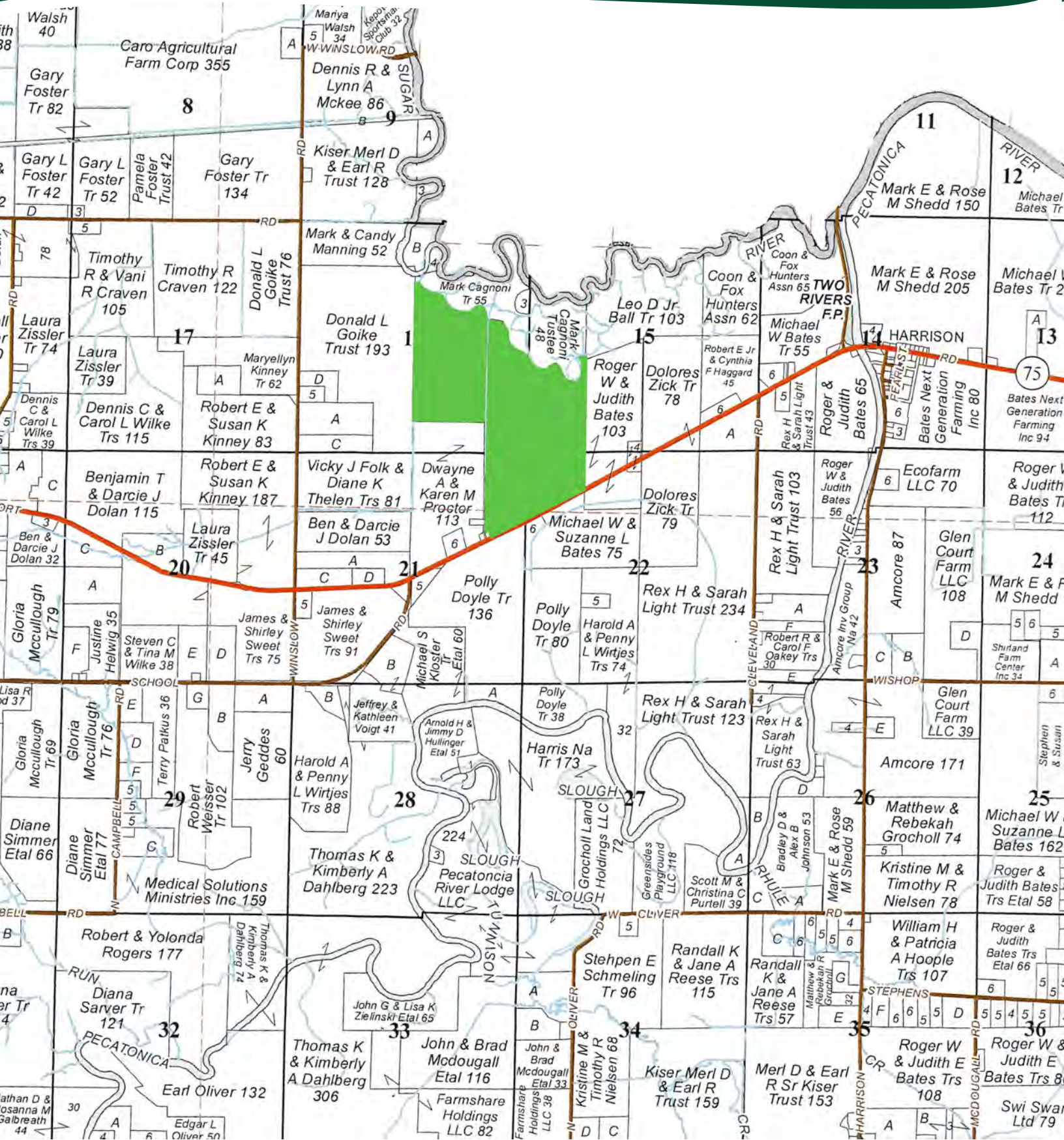

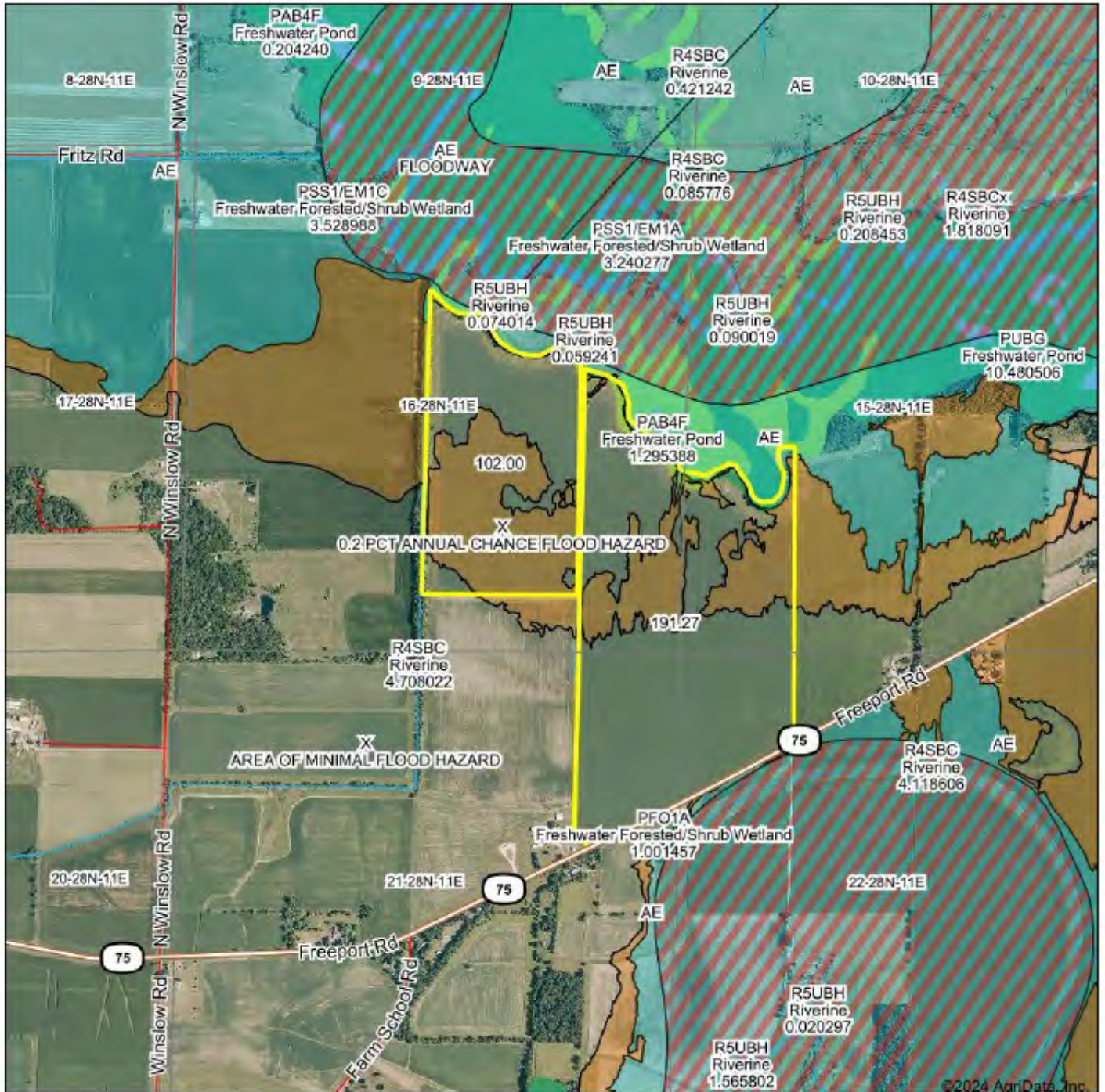
