CLOSING ORDER

Claim 41J 207368-00 appeared in the Preliminary Decree for Basin 41J with the following issue remark:

VOLUME MAY BE EXCESSIVE. BASED ON THE FLOW RATE AND PERIOD OF USE, THE SYSTEM WOULD HAVE TO RUN 23.93 HOURS PER DAY TO DELIVER THE CLAIMED VOLUME. NO INFORMATION EXISTS IN THE CLAIM FILE TO CONFIRM THIS FIGURE.

This claim is a decreed commercial groundwater right from a spring. The State of Montana, Department of Fish, Wildlife & Parks (DFWP) filed an objection to this claim. However, on February 17, 2012, the DFWP filed a Withdrawal of Objection. In the Withdrawal, the DFWP state they contacted DNRC regarding resolution of the above issue remark and were told the remark had been placed on the claim in error. Attached to the Withdrawal is a copy of an email from Water Resource Specialist Supervisor Arne Wick confirming the remark should not have been placed on the claim. Therefore, the issue remark should be removed.

This claim also appeared with the following issue remark:

AT THE TIME OF THE CLAIMED PRIORITY DATE, IT APPEARS THAT THE PLACE OF USE WAS PART OF AN INDIAN RESERVATION.

On September 22, 2011, Water Adjudication Chief John Peterson filed a memorandum indicating the above issue remark should be removed from all claims in Basin 41J with priority dates postdating April 15, 1856, the ratification date of the 1855 Treaty with the Blackfeet. These claims in Basin 41J are appurtenant to lands wherein the Claimants' predecessors were early settlers upon lands originally part of the Blackfeet

reservation in 1855, but later restored to the public domain. The April 30, 1866 priority date postdates April 15, 1856. The above issue remark was placed on the abstract in error, and should be removed. No further proceedings are required on this claim.

Therefore, it is

ORDERED that the issue remarks which appear on the abstract of the above captioned claim are STRICKEN;

A Post Decree Abstract of Water Right Claim is served with this Order to confirm the remark has been stricken in the state's centralized record system.
