

LEGAL DESCRIPTION

THENCE, South 01 Degrees 19 Minutes 51 Seconds East, along an East line of said 120.00 acre tract, the West line of said 77.964 acre tract, and said County Road No. 4315, a distance of 460.16 feet to a 1/2 inch iron rod set marked (BY-LINE) at an ell corner of said 120.00 acre tract, and the Southwest corner of said 77.964 acre tract, said point lying on the Southwest side of County Road No. 4315, from said point, a 40D nail found for witness, bears North 56 Degrees 15

THENCE, South 00 Degrees 42 Minutes 39 Seconds East, along an East line of said 120.00 acre tract, and the West line of said 34.463 acre tract, a distance of 348.98 feet to a 1/2 inch iron pipe found at a Southeast corner of said 120.00 acre tract, and the Northeast corner of a 75 acre tract of land, called Tract 4, conveyed to Debra Stinson et al, by deed recorded in File #201100001717, Real Property Records. Titus County, Texas:

THENCE, South 88 Degrees 20 Minutes 00 Seconds West, along a South line of said 120.00 acre tract, and the North line of said 75 acre tract, passing the Northwest corner of said 75 acre tract, and the Northeast corner of a 59.95 acre tract of land, called Tract 2, conveyed to Debra Stinson et al, by deed recorded in File #201100001717, Real Property Records, Titus County, Texas, and continuing the same course in all a total distance of 2,037.23 feet to a 6 inch wood fence post found at the Southwest corner of said 120.00 acre tract, and the Southeast corner of the remainder of a 79.1 acre tract of land conveyed to James Crabb et ux, by deed recorded in Volume 364, Page 473, Deed Records, Titus

THENCE, North 01 Degrees 23 Minutes 31 Seconds West, along the West line of said 120.00 acre tract, and the East line of the remainder of said 79.1 acre tract, passing at a distance of 829.02 feet, a 1/2 inch iron rod set marked (BY-LINE) at the Northeast corner of the remainder of said 79.1 acre tract, the Southeast corner of said 50 acre tract, and the Southeast corner of said 50.70 acre tract in all a total distance of 1,638.91 feet to the POINT OF BEGINNING and CONTAINING 5,225,322 square feet or 119.96 acres of land.
