This is to certify that the holder(s) of the conditional permit to divert and appropriate water as indicated above has completed construction of the works as set forth therein. And that the holder(s) of said conditional permit did, on the 11th day of July, 1983, submit proof of the application to beneficial use of 405.0 acre feet of water for the following purpose to irrigate a total of 270.0 acres
(April 26, 1984: 45.0 acre-feet of water and 30.0 acres undeveloped Cancelled)

Now, therefore, by virtue of the authority vested in me by the laws of the State of North Dakota, I hereby grant and confirm to Reinhold Opp of Napoleon, North Dakota 58561 holder(s) of said Conditional Permit No. 3232, a right dating from February 27, 1980 to appropriate and divert from at a point located in the SW 1/4 & SE 1/4 Sec. 22, Twp. 136N, Rge. 70W, a quantity of water limited to the amount that can be beneficially used herein, but not to exceed 405.0 acre feet at a total pumping rate not to exceed 2000 gallons per minute annually for irrigating a total of 270.0 acres

and if purpose is irrigation, water is to be applied to the following lands to which this Water Permit is appurtenant:

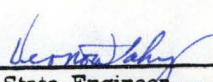
Estimated return flow to stream

The right to use water for irrigation set forth herein is limited to the above described lands and is subject to cancellation for nonuse.

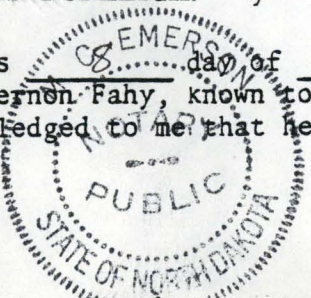
